R E S O L U T I O N

1 WHEREAS, The family and friends of Sean Michael DuBose
2 sustained an immeasurable loss with his untimely death on March 28,
3 2007, at the age of 23; and

4 WHEREAS, Born to the late Major William T. DuBose and Judith
5 Ann Cushman DuBose on February 13, 1984, in Arlington, Mr. DuBose
6 graduated in 2002 from the Marine Military Academy in Harlingen; he
7 earned a bachelor's degree in 2006 from the University of Oklahoma,
8 where he was a member of the Kappa Alpha Order; and

9 WHEREAS, An Eagle Scout, Mr. DuBose was employed with the Boy
10 Scouts of America as a district scout executive; he was a valued
11 congregant of St. John the Evangelist Catholic Church and the
12 Knights of Columbus in Baytown; in addition, he was a member of
13 Masonic Lodge No. 539 AF & AM in Moore, Oklahoma, and the Hejaz
14 Shrine Temple in Greenville, South Carolina; and

15 WHEREAS, Admired by all who knew him, Sean DuBose strove to
16 meet the highest standards of character and conduct; he had already
17 demonstrated a remarkable ability to act decisively in a crisis,
18 having rescued a woman and her baby from an overturned vehicle when
19 he was only 15; and

20 WHEREAS, He was also exceptionally accomplished in judo; a
21 former collegiate All-American, he won national titles while
22 competing from childhood through college; and

23 WHEREAS, Mr. DuBose was truly an outstanding young man, and
24 he will forever be held close in the hearts of his family and

2 RESOLVED, That the House of Representatives of the 80th Texas
3 Legislature hereby pay tribute to the life of Sean Michael DuBose
4 and extend sincere sympathy to the members of his family: to his
