WHEREAS, Judge Garcia was elected to the office of county judge in the 1994 election and began presiding over the Duval County Commissioners Court on January 1, 1995; he helped guide the county for the next 12 years, providing wise leadership and effective administration to his constituents and offering valuable input to organizations such as the South Texas County Judges and Commissioners Association and the Coastal Bend Council of
