- 1 WHEREAS, The certain knowledge of a life well-lived may
- 2 temper the sadness brought by the passing of William Grogan Lord of
- 3 Georgetown on January 13, 2007; and
- WHEREAS, Mr. Lord was born in Hearne; after graduating from
- 5 Downey High School, he worked with Firestone Tire and Rubber
- 6 Company in San Antonio before moving to Georgetown in 1940 to
- 7 supervise the firm's sales in Central Texas; and
- 8 WHEREAS, His career was interrupted by the outbreak of World
- 9 War II, when he served his country as an artillery observation
- 10 pilot, earning a battlefield commission to the rank of first
- 11 lieutenant and both the Air Medal with clusters and the Purple Heart
- 12 for his heroism; and
- WHEREAS, He returned to civilian life in 1945 and expanded
- 14 his business interests to include automobile financing, insurance,
- banking, and a savings and loan association; he also founded a small
- 16 business investment company, Texas Capital Corporation, which
- 17 later became TeleCom Corporation; and
- WHEREAS, Among his many notable ventures, Mr. Lord served as
- 19 senior chairman of the board of First Texas Bancorp, Inc., a
- 20 multibank holding company, advisory director of the Citizens State
- 21 Bank of Georgetown, a director of State Trust Company of
- 22 Georgetown, and a director of Georgetown Savings and Loan
- 23 Association; in addition, he led a number of Dallas-based
- 24 companies, serving as chairman of the board of Red Ball Motor

- 1 Freight, a director of Mercantile Texas Corporation, and a director
- of Frozen Food Express Industries, Inc.; and
- 3 WHEREAS, This respected civic leader shared his wisdom and
- 4 expertise with the Texas Research League and the Texas
- 5 Philosophical Society; he became a member of the State Securities
- 6 Board of Texas in 1971 and served for more than a decade; elected
- 7 chair in 1975, he held the record of longest-serving member in the
- 8 body's history on his retirement eight years later; and
- 9 WHEREAS, Through the years Mr. Lord was a dedicated supporter
- of Southwestern University; he served with the institution's board
- of trustees for 40 years and, with his wife, funded a complex of
- 12 townhouses for students, and in 1967, Southwestern recognized him
- 13 with an honorary degree, Doctor of Humane Letters; and
- 14 WHEREAS, Those fortunate enough to have known William Lord
- 15 will long remember him not only as one of Georgetown's most
- 16 influential businessmen and philanthropists but also as a true
- 17 Texas gentleman; although he is greatly missed, his legacy lives on
- in the immeasurable impact of his many contributions to the city of
- 19 Georgetown and this state; now, therefore, be it

- 21 Legislature hereby pay special tribute to the life of William
- 22 Grogan Lord and extend deepest sympathy to the members of his
