WHEREAS, The second oldest of six children born to Leroy and Kathy Neel, Phillip Neel graduated in 1998 from Fredericksburg High School, where he was a member of the cross-country team and a student in the "Principles of Technology" rocket program; he went on to complete two years of service in the U.S. Army, during which time he served as an Airborne unit paratrooper in Kosovo and advanced to the rank of specialist; with his sights set on becoming a commissioned officer, he received an appointment to the U.S. Military Academy at West Point and was commissioned as a second lieutenant in 2005; he was deployed to Iraq in October 2006; and

WHEREAS, First Lieutenant Neel was the recipient of numerous military decorations, including the Bronze Star, the Purple Heart, the Army Achievement Medal, the Kosovo Campaign Medal with Bronze Star, the Iraq Campaign Medal, the Global War on Terrorism Service Medal, the Expert Infantryman Badge, and the Parachute Badge; and

WHEREAS, Widely admired for his leadership, his devotion to

- 7 athlete and had performed in several national competitions with the

- 11 efforts and immense sacrifice are deserving of the respect and
