

R E S O L U T I O N

1           WHEREAS, The hard work of Keep Katy Beautiful has been  
2 recognized with a 2007 Governor's Community Achievement Award  
3 (GCAA), one of nine announced on May 22, 2007; and

4           WHEREAS, Keep Katy Beautiful is affiliated with Keep Texas  
5 Beautiful, a nonprofit organization with 340 affiliates around the  
6 state that are devoted to environmental and community improvement;  
7 the annual GCAA winners are chosen by Keep Texas Beautiful and  
8 receive a share of \$1 million provided by the Texas Department of  
9 Transportation for state right-of-way landscaping projects; and

10           WHEREAS, Founded in 1993, Keep Katy Beautiful this year  
11 sponsored a number of successful projects and events, including the  
12 Paint-a-Can Project, a plastic bottle recycling program at Katy  
13 High School football games, the Plant a Flower Day and Arbor Day  
14 partnership with Hutsell Elementary School and Wal-Mart, and the  
15 annual Don't Mess with Texas Trash-Off; and

16           WHEREAS, Along with the 2007 GCAA, the group has also been  
17 recognized this year with the President's Circle Award from Keep  
18 America Beautiful, the Gold Star Affiliate Award from Keep Texas  
19 Beautiful, and the Keep Texas Beautiful Lifetime Achievement Award  
20 for member Kay Callender; and

21           WHEREAS, Keep Katy Beautiful is ably led by Chairman Sandy  
22 Schmidt, Vice Chairman Kay Callender, Secretary Jamie Wolman, and  
23 board members Albert Thompson, Sharon Rhoads, Patti Hanson, Debbie  
24 Berger, Kathy Wiesner, Elaine Lutringer, Dixie McDonald, and

1 Jacalyn Warner; the group has enjoyed the support of Katy mayors and  
2 many city council members throughout its existence and also  
3 receives outstanding assistance from Katy parks director Jennifer  
4 Archer and the Public Works Department; and

5 WHEREAS, Through their exceptional vision and tireless  
6 efforts, the members of Keep Katy Beautiful have contributed  
7 immeasurably to enhancing the physical environment of their city,  
8 and the fruits of their efforts will give pleasure to their fellow  
9 citizens for years to come; now, therefore, be it

11 Legislature hereby congratulate Keep Katy Beautiful for winning a
