## RESOLUTION

1 WHEREAS, Teri E. Flack begins a new chapter of her life with 2 her retirement on May 31, 2007, after 26 years of outstanding 3 service to the state; and

WHEREAS, After graduating summa cum laude from Southwest 4 5 Texas State University with a degree in history and political science, Ms. Flack worked for the consumer protection division of 6 7 the Office of the Attorney General; her duties included investigating violations of the Consumer Protection Act, leading 8 investigative teams, managing the consumer protection legislative 9 program, and training investigative staff; through her work for the 10 11 attorney general's office, Ms. Flack rendered exemplary service to 12 consumers and the people of Texas and worked closely with the Texas Legislature to end abuses in the telemarketing and psychiatric 13 14 hospital industries; and

WHEREAS, Returning to her alma mater to earn a master's 15 degree in business administration, Ms. Flack then joined the staff 16 of the Texas Higher Education Coordinating Board as director of 17 governmental relations and public information; in that capacity, 18 she acted as the agency's liaison to the Texas Legislature and 19 executive branch, developing policy and negotiating among 20 21 competing parties, and drafting legislation and providing resource 22 information; and

23 WHEREAS, Ms. Flack went on to support the work of the Texas 24 Legislature in 1999 in creating the TEXAS Grant program that has

1 helped tens of thousands of needy students attend college and that
2 will pay dividends for future generations of Texans; and

3 WHEREAS, Ms. Flack's growing expertise in policy and budget 4 matters regarding higher education resulted in her 2001 selection 5 as deputy commissioner of the coordinating board, and she has since 6 acted as its chief operating officer; she has expanded her role in 7 developing and implementing higher education policy and championed 8 the goals of *Closing the Gaps by 2015*, the state's higher education 9 plan; and

10 WHEREAS, During the past three legislative sessions, members of the Texas Legislature have benefited from Ms. Flack's knowledge 11 of the intricacies of the coordinating board budget and her ability 12 to answer questions in detail on such diverse topics as financial 13 aid, research, tuition revenue bonds, graduate medical education, 14 15 loan programs, academic programs, higher education finance, 16 facilities, accountability, enrollments, and 17 college-readiness--all of which she can explain lucidly, calmly, and respectfully for hours on end; and 18

WHEREAS, For more than a quarter-century, Teri Flack has served the State of Texas with great skill and commitment, and through her distinguished service, she has made an invaluable contribution to Texas consumers, to students enrolled in Texas colleges and universities, and to higher education throughout the Lone Star State; now, therefore, be it
