A BILL TO BE ENTITLED

1	AN ACT
2	relating to the prevention of and education concerning the offense
3	of online solicitation of a minor.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter G, Chapter 37, Education Code, is
6	amended by adding Section 37.2095 to read as follows:
7	Sec. 37.2095. EDUCATIONAL MATERIALS. (a) The center, in
8	consultation with the attorney general and the commissioner, shall
9	maintain on the center's Internet website a link that enables an
10	Internet user to access free of charge information and educational
11	materials designed to prevent the commission of the offense of
12	online solicitation of a minor under Section 33.021, Penal Code, or
13	any substantially similar offense.
14	(b) The information and educational materials described by
15	Subsection (a) must be:
16	(1) appropriate for use in a classroom setting in a
17	<pre>public primary or secondary school; and</pre>
18	(2) designed to educate minors concerning ways to
19	avoid becoming a victim or perpetrator of the offense of online
20	solicitation of a minor under Section 33.021, Penal Code, or a
21	substantially similar offense.
22	(c) The Internet link maintained under Subsection (a) may
23	link the Internet user to information and educational materials
24	that are prepared by the center, the attorney general, another

- 1 state agency, or a private entity that operates in the computer or
- 2 computing industry, including an Internet service provider or a
- 3 computer software provider.
- 4 SECTION 2. Subsection (a), Section 37.083, Education Code,
- 5 is amended to read as follows:
- 6 (a) Each school district shall adopt and implement a
- 7 discipline management program to be included in the district
- 8 improvement plan under Section 11.252. The program must provide
- 9 for:
- 10 (1) prevention of and education concerning unwanted
- 11 physical or verbal aggression, sexual harassment, and other forms
- of bullying in school, on school grounds, and in school vehicles;
- 13 and
- 14 (2) prevention of the offense of online solicitation
- of a minor under Section 33.021, Penal Code, or a substantially
- 16 similar offense by educating students concerning ways to avoid
- 17 becoming victims or perpetrators of that offense.
- 18 SECTION 3. (a) The Texas School Safety Center shall post
- 19 the Internet link required by Section 37.2095, Education Code, as
- added by this Act, not later than December 1, 2007.
- 21 (b) Each school district shall modify its discipline
- 22 management program to comply with Section 37.083, Education Code,
- 23 as amended by this Act, as soon as possible after the Texas School
- 24 Safety Center posts the Internet link required by Section 37.2095,
- 25 Education Code, as added by this Act, and not later than the first
- 26 day of the 2008-2009 school year.
- 27 SECTION 4. This Act takes effect September 1, 2007.
