A BILL TO BE ENTITLED

1	AN ACT
2	relating to a competitive grant program to fund nurse-family
3	partnership programs in certain communities in this state.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 531, Government Code, is amended by
6	adding Subchapter M to read as follows:
7	SUBCHAPTER M. NURSE-FAMILY PARTNERSHIP COMPETITIVE GRANT PROGRAM
8	Sec. 531.451. DEFINITIONS. In this subchapter:
9	(1) "Competitive grant program" means the
10	nurse-family partnership competitive grant program established
11	under this subchapter.
12	(2) "Partnership program" means a nurse-family
13	partnership program.
14	Sec. 531.452. ESTABLISHMENT OF NURSE-FAMILY PARTNERSHIP
15	COMPETITIVE GRANT PROGRAM. (a) The commission shall establish a
16	nurse-family partnership competitive grant program through which
17	the commission will award grants for the implementation of
18	nurse-family partnership programs, or the expansion of existing
19	programs, and for the operation of those programs for a period of
20	not less than two years.
21	(b) The commission shall award grants under the program to
22	applicants, including applicants operating existing programs, in a
23	manner that ensures that the partnership programs collectively:
24	(1) operate in multiple communities that are

2 (2) provide program services to approximately 2,000 3 families. 4 Sec. 531.453. PARTNERSHIP PROGRAM REQUIREMENTS. partnership program funded through a grant awarded under this 5 6 subchapter must: 7 (1) strictly adhere to the program model developed by the Nurse-Family Partnership National Service Office, including 8 9 any clinical, programmatic, and data collection requirements of 10 that model; 11 (2) require that registered nurses regularly visit the homes of low-income, first-time mothers participating in the 12 13 program to provide services designed to: 14 (A) improve pregnancy outcomes; 15 improve child health and development; (B) 16 (C) improve family economic self-sufficiency and 17 stability; and 18 (D) reduce the incidence of child abuse and 19 neglect; 20 (3) require that nurses who provide services through 21 the program: 22 (A) receive training from the office of the 23 attorney general at least once each year on procedures by which a person may voluntarily acknowledge the paternity of a child and on 24 25 the availability of child support services from the office; (B) provide a mother with information about the 26

- 2 <u>(C) provide assistance to a mother and the</u>
- 3 alleged father of her child if the mother and alleged father seek to
- 4 voluntarily acknowledge paternity of the child, if appropriate; and
- 5 (D) provide information to a mother about the
- 6 availability of child support services from the office of the
- 7 attorney general; and
- 8 (4) require that the regular nurse visits described by
- 9 Subdivision (2) begin not later than a mother's 28th week of
- 10 gestation and end when her child reaches two years of age.
- Sec. 531.454. APPLICATION. (a) A public or private
- 12 entity, including a county, municipality, or other political
- 13 <u>subdivision of this state</u>, may apply for a grant under this
- 14 subchapter.
- 15 (b) To apply for a grant, an applicant must submit a written
- 16 application to the commission on a form prescribed by the
- 17 <u>commission in consultation with the Nurse-Family Partnership</u>
- 18 National Service Office.
- 19 (c) The application prescribed by the commission must:
- 20 (1) require the applicant to provide data on the
- 21 <u>number of low-income, first-time mothers residing in the community</u>
- 22 <u>in which the applicant proposes to operate or expand a partnership</u>
- 23 program and provide a description of existing services available to
- those mothers;
- 25 (2) describe the ongoing monitoring and evaluation
- 26 process to which a grant recipient is subject under Section
- 27 531.459, including the recipient's obligation to collect and

- 1 provide information requested by the commission under Section
- $\frac{531.459(c)}{3}$ and
- 3 (3) require the applicant to provide other relevant
- 4 <u>information as determined by the commission.</u>
- 5 Sec. 531.455. ADDITIONAL CONSIDERATIONS IN AWARDING
- 6 GRANTS. In addition to the factors described by Sections
- 7 531.452(b) and 531.453, in determining whether to award a grant to
- 8 an applicant under this subchapter, the commission shall consider:
- 9 (1) the demonstrated need for a partnership program in
- 10 the community in which the applicant proposes to operate or expand
- the program, which may be determined by considering:
- 12 (A) the poverty rate, the crime rate, the number
- of births to Medicaid recipients, the rate of poor birth outcomes,
- 14 and the incidence of child abuse and neglect during a prescribed
- 15 period in the community; and
- 16 (B) the need to enhance school readiness in the
- 17 community;
- 18 (2) the applicant's ability to participate in ongoing
- 19 monitoring and performance evaluations under Section 531.459,
- 20 including the applicant's ability to collect and provide
- information requested by the commission under Section 531.459(c);
- 22 <u>(3) the applicant's ability to adhere to the</u>
- 23 partnership program standards adopted under Section 531.456;
- 24 (4) the applicant's ability to develop broad-based
- 25 community support for implementing or expanding a partnership
- 26 program, as applicable; and
- 27 (5) the applicant's history of developing and

- 1 sustaining innovative, high-quality programs that meet the needs of
- 2 families and communities.
- 3 Sec. 531.456. PARTNERSHIP PROGRAM STANDARDS. The executive
- 4 commissioner, with the assistance of the Nurse-Family Partnership
- 5 National Service Office, shall adopt standards for the partnership
- 6 programs funded under this subchapter. The standards must adhere
- 7 to the Nurse-Family Partnership National Service Office program
- 8 model standards and guidelines that were developed in multiple,
- 9 randomized clinical trials and have been tested and replicated in
- 10 multiple communities.
- 11 Sec. 531.457. USE OF AWARDED GRANT FUNDS. The grant funds
- 12 awarded under this subchapter may be used only to cover costs
- 13 related to implementing or expanding and operating a partnership
- 14 program, including costs related to:
- 15 (1) administering the program;
- 16 (2) training and managing registered nurses who
- 17 participate in the program;
- 18 (3) paying the salaries and expenses of registered
- 19 nurses who participate in the program;
- 20 (4) paying for facilities and equipment for the
- 21 program; and
- 22 (5) paying for services provided by the Nurse-Family
- 23 Partnership National Service Office to ensure a grant recipient
- 24 adheres to the organization's program model.
- Sec. 531.458. STATE NURSE CONSULTANT. Using money
- 26 appropriated for the competitive grant program, the commission
- 27 shall contract with a state nurse consultant to assist grant

- 1 recipients with implementing or expanding and operating the
- 2 partnership programs in the applicable communities.
- 3 Sec. 531.459. PROGRAM MONITORING AND EVALUATION; ANNUAL
- 4 COMMITTEE REPORTS. (a) The commission, with the assistance of the
- 5 Nurse-Family Partnership National Service Office, shall:
- 6 (1) adopt performance indicators that are designed to
- 7 measure a grant recipient's performance with respect to the
- 8 partnership program standards adopted by the commission under
- 9 Section 531.456;
- 10 (2) use the performance indicators to continuously
- 11 monitor and formally evaluate on an annual basis the performance of
- 12 each grant recipient; and
- 13 (3) prepare and submit an annual report, not later
- 14 than December 1 of each year, to the Senate Health and Human
- 15 <u>Services Committee, or its successor, and the Hou</u>se Human Services
- 16 Committee, or its successor, regarding the performance of each
- 17 grant recipient during the preceding state fiscal year with respect
- 18 to providing partnership program services.
- 19 (b) The report required under Subsection (a)(3) must
- 20 include:
- 21 (1) the number of low-income, first-time mothers to
- 22 whom each grant recipient provided partnership program services
- 23 and, of that number, the number of mothers who established the
- 24 paternity of an alleged father as a result of services provided
- 25 under the program;
- 26 (2) the extent to which each grant recipient made
- 27 regular visits to mothers during the period described by Section

- 1 531.453(4); and
- 2 (3) the extent to which each grant recipient adhered
- 3 to the Nurse-Family Partnership National Service Office's program
- 4 model, including the extent to which registered nurses:
- 5 <u>(A) conducted home visitations comparable in</u>
- 6 frequency, duration, and content to those delivered in Nurse-Family
- 7 Partnership National Service Office clinical trials; and
- 8 <u>(B) assessed the health and well-being of mothers</u>
- 9 and children participating in the partnership programs in
- 10 accordance with indicators of maternal, child, and family health
- 11 defined by the commission in consultation with the Nurse-Family
- 12 Partnership National Service Office.
- 13 (c) On request, each grant recipient shall timely collect
- 14 and provide data and any other information required by the
- 15 commission to monitor and evaluate the recipient or to prepare the
- 16 report required by this section.
- 17 Sec. 531.460. COMPETITIVE GRANT PROGRAM FUNDING. (a) The
- 18 commission shall actively seek and apply for any available federal
- 19 funds, including federal Medicaid and Temporary Assistance for
- 20 Needy Families (TANF) funds, to assist in financing the competitive
- 21 grant program established under this subchapter.
- 22 (b) The commission may use appropriated funds from the state
- 23 government and may accept gifts, donations, and grants of money
- 24 from the federal government, local governments, private
- 25 corporations, or other persons to assist in financing the
- 26 competitive grant program.
- 27 SECTION 2. (a) As required by Subsection (a), Section

- 1 531.460, Government Code, as added by this Act, the Health and Human
- 2 Services Commission shall, as soon as practicable, apply for any
- 3 available federal funds to assist in financing the nurse-family
- 4 partnership competitive grant program under Subchapter M, Chapter
- 5 531, Government Code, as added by this Act.
- 6 (b) Not later than December 1, 2007, the Health and Human
- 7 Services Commission shall establish and implement the nurse-family
- 8 partnership competitive grant program required by Subchapter M,
- 9 Chapter 531, Government Code, as added by this Act.
- 10 (c) Not later than December 1, 2008, the Health and Human
- 11 Services Commission shall submit the initial annual report required
- 12 by Subdivision (3), Subsection (a), Section 531.459, Government
- 13 Code, as added by this Act.
- 14 SECTION 3. This Act takes effect September 1, 2007.
