14	Chapter] 551 <u>and 552</u> , Government Code, <u>do not apply</u> [applies] to the

16	[(b) The board may hold closed meetings to consider:

Subsection (b), Section 2054.256, 15 Insurance 16 Code, as effective April 1, 2007, is amended to read as follows: 17 The [Except as otherwise required or permitted by (b) 18 Chapter 552, Government Code, the] company may not provide to an insurance agent information obtained from another insurance agent. 19 SECTION 6. Subsections (b) and (c), Section 2054.008, 20 Insurance Code, as effective April 1, 2007, are repealed. 21 22 SECTION 7. The change in law made by the amendment of Section 2054.008, Insurance Code, by this Act applies 23 to information maintained in investigation files of the Texas Mutual 24 25 Insurance Company without regard to the date the information is collected, compiled, or developed or otherwise becomes part of the 26 27 investigation file.

1 SECTION 8. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2007.
