- 6 SECTION 1. Chapter 101, Family Code, is amended by adding 7 Section 101.0255 to read as follows:
- 8 Sec. 101.0255. RECORD. "Record" means information that is:
- 9 <u>(1) inscribed on a tangible medium or stored in an</u>
- 10 electronic or other medium; and
- 11 (2) retrievable in a perceivable form.
- 12 SECTION 2. Subsection (d), Section 102.009, Family Code, is
- 13 amended to read as follows:
- 14 (d) If the petition requests the establishment,
- 15 termination, modification, or enforcement of a support right
- 16 assigned to the Title IV-D agency under Chapter 231 or the
- 17 rescission of a voluntary acknowledgment of paternity under Chapter
- 18 160, notice shall be given to the Title IV-D agency in a manner
- 19 provided by Rule 21a, Texas Rules of Civil Procedure.
- SECTION 3. Subsection (b), Section 151.001, Family Code, is
- 21 amended to read as follows:
- (b) The duty of a parent to support his or her child exists
- 23 while the child is an unemancipated minor and continues as long as
- the child is fully enrolled in a [an accredited] secondary school in

- 1 a program leading toward a high school diploma and complies with
- 2 <u>attendance requirements described by Section 154.002(a)(2)</u> [until
- 3 the end of the school year in which the child graduates].
- 4 SECTION 4. Subsection (c), Section 155.301, Family Code, is
- 5 amended to read as follows:
- 6 (c) Except as otherwise provided by this subsection, if [If]
- 7 a transfer of continuing, exclusive jurisdiction is sought under
- 8 this section, the procedures for determining and effecting a
- 9 transfer of proceedings provided by this chapter apply. If the
- 10 parties submit to the court an agreed order for transfer, the court
- 11 shall sign the order without the need for other pleadings.
- 12 SECTION 5. Subsection (b), Section 156.401, Family Code, is

- 18 (2) an appearance in the suit to modify.

- 22 (a) The [If the sole managing conservator of a child or the
- 23 joint managing conservator who has the exclusive right to determine
- 24 the primary residence of the child has voluntarily relinquished the
- 25 primary care and possession of the child to another person for at
- 26 least six months, the] court shall, on the motion of a party or a
- 27 [the other] person having physical possession of the child, modify

- 1 an order providing for the support of the child to provide that the
- 2 [other] person having physical possession of the child for at least
- 3 <u>six months</u> shall have the right to receive and give receipt for
- 4 payments of support for the child and to hold or disburse money for
- 5 the benefit of the child if the sole managing conservator of the
- 6 child or the joint managing conservator who has the exclusive right
- 7 to determine the primary residence of the child has:
- 8 <u>(1) voluntarily relinquished the primary care and</u>
- 9 possession of the child;
- 10 (2) been incarcerated or sentenced to be incarcerated
- 11 for at least 90 days; or
- 12 (3) relinquished the primary care and possession of
- the child in a proceeding under Title 3 or Chapter 262.
- 14 <u>(a-1) If the court modifies a support order under this</u>
- 15 section, the court shall order the obligor to pay the person or
- 16 entity having physical possession of the child any unpaid child
- 17 support that is not subject to offset or reimbursement under
- 18 Section 157.008 and that accrues after the date the sole or joint
- 19 <u>managing conservator:</u>
- 20 (1) relinquishes possession and control of the child,
- 21 whether voluntarily or in a proceeding under Title 3 or Chapter 262;
- 22 <u>or</u>
- 23 <u>(2) is incarcerated.</u>
- 24 (a-2) This section does not affect the ability of the court
- 25 to render a temporary order for the payment of child support that is
- 26 in the best interest of the child.
- 27 SECTION 7. Subsection (a), Section 157.005, Family Code, is

- 1 amended to read as follows:
- 2 (a) The court retains jurisdiction to render a contempt
- 3 order for failure to comply with the child support order if the
- 4 motion for enforcement is filed not later than the second
- 5 anniversary of [sixth month after] the date:
- 6 (1) the child becomes an adult; or
- 7 (2) on which the child support obligation terminates
- 8 under the order or by operation of law.
- 9 SECTION 8. Subsection (a), Section 157.065, Family Code, is
- 10 amended to read as follows:
- 11 (a) If a party has been ordered under Chapter 105 to provide
- 12 the court and the state case registry with the party's current
- mailing address, notice of a hearing on a motion for enforcement may
- 14 be served by mailing a copy of the notice to the respondent,
- 15 together with a copy of the motion, by first class mail to the last
- 16 mailing address of the respondent on file with the court and the
- 17 registry.
- SECTION 9. Subsections (a) and (c), Section 157.105, Family
- 19 Code, are amended to read as follows:
- 20 (a) If the respondent is taken into custody and not released
- 21 on bond, the respondent shall be brought before the court that
- 22 issued the capias on or before the third [first] working day after
- 23 the arrest. The court shall determine whether the respondent's
- 24 appearance in court at a designated time and place can be assured by
- 25 a method other than by posting the bond or security previously
- 26 established.
- 27 (c) If the court is not satisfied that the respondent's

- 1 appearance in court can be assured and the respondent remains in
- 2 custody, a hearing on the alleged contempt shall be held as soon as
- 3 practicable, but not later than the seventh [fifth] day after the
- 4 date that the respondent was taken into custody, unless the
- 5 respondent and the respondent's attorney waive the accelerated
- 6 hearing.

- 16 the respondent at the respondent's home or elsewhere;
- 17 (3) obtain counseling on financial planning, budget
- 18 management, conflict resolution, parenting skills, alcohol or drug
- 19 abuse, or other matters causing the respondent to fail to obey the
- 20 order;
- 21 (4) pay required child support and any child support
- 22 arrearages;
- (5) pay court costs and attorney's fees ordered by the
- 24 court;
- 25 (6) seek employment assistance services offered by the
- 26 Texas Workforce Commission under Section 302.0035, Labor Code, if
- 27 appropriate; [and]

- 1 (7) participate in mediation or other services to
- 2 alleviate conditions that prevent the respondent from obeying the
- 3 court's order; and
- 4 (8) submit to a period of confinement in a county jail
- 5 beginning at any time during the community supervision period,
- 6 except that the aggregate of all periods of confinement during the
- 7 community supervision period may not exceed 180 days.
- 8 SECTION 11. Section 157.212, Family Code, is amended to
- 9 read as follows:
- Sec. 157.212. TERM OF COMMUNITY SUPERVISION. The initial
- 11 <u>period of community supervision [period</u>] may not exceed 10 years.
- 12 The court may continue the community supervision beyond 10 years
- 13 until the earlier of:
- 14 (1) the second anniversary of the date on which the
- community supervision first exceeded 10 years; or
- 16 (2) the date on which all child support, including
- 17 arrearages and interest, has been paid.
- SECTION 12. Subsections (a) and (b), Section 157.216,
- 19 Family Code, are amended to read as follows:
- 20 (a) The court shall hold a hearing without a jury not later
- 21 than [on or before] the third [first] working day after the date the
- 22 respondent is arrested under Section 157.215. If the court is
- 23 unavailable for a hearing on that date, the hearing shall be held
- 24 not later than the <u>third</u> [<u>first</u>] working day after the date the
- 25 court becomes available.
- 26 (b) The hearing under this section may not be held later
- than the seventh [third] working day after the date the respondent

- 1 is arrested.
- 2 SECTION 13. Subsection (c), Section 157.263, Family Code,
- 3 is amended to read as follows:
- 4 (c) If the amount of arrearages confirmed by the court
- 5 reflects a credit to the obligor for support arrearages collected
- from a federal tax refund under 42 U.S.C. Section 664, [as amended,]

- 8 refund was adjusted because of an injured spouse claim by a jointly
- 9 filing spouse, the tax return was amended, the return was audited by

- to a share of the refund under 42 U.S.C. Section 664, as amended],
- 13 the court shall render a new cumulative judgment to include as
- 14 arrearages an amount equal to the amount by which the credit was

- 5 [arrearages] retains continuing jurisdiction to enforce the order,
- 6 including by adjusting the amount of the periodic payments to be
- 7 made by the obligor or the amount to be withheld from the obligor's
- 8 disposable earnings, until all current support and medical support
- 9 and child support arrearages, including interest and any applicable
- 10 fees and costs, have been paid.
- 11 SECTION 16. Subsections (a), (c), and (e), Section 157.313,
- 12 Family Code, are amended to read as follows:
- 13 (a) Except as provided by Subsection (e), a child support
- 14 lien notice must contain:
- 15 (1) the name and address of the person to whom the
- 16 notice is being sent;
- 17 (2) the style, docket or cause number, and identity of
- 18 the tribunal of this or another state having continuing
- 19 jurisdiction of the child support action and, if the case is a Title
- 20 IV-D case, the case number;

- 25 number of the obligee;
- 26 (5) the amount of the current or prospective child

- 3 court order, administrative order, or writ that determined the

- 7 IV-D agency may provide notice to a licensing authority concerning
- 8 <u>an obligor who has failed to pay child support for six months or</u>
- 9 more that requests the authority to refuse to accept an application
- 10 for renewal of the license of the obligor.
- 11 (b) A licensing authority that receives the information
- described by Subsection (a) shall refuse to accept an application
- 13 for renewal of the license of the obligor until the authority is
- 14 notified by the Title IV-D agency that the obligor has:
- 15 (1) paid all child support arrearages;
- 16 (2) established with the Title IV-D agency a
- 17 <u>satisfactory repayment schedule or is in compliance with a court</u>

- 20 part of a court-supervised plan to improve the obligor's earnings

- 22 (4) successfully contested the denial of renewal of
- 23 license under Subsection (d).
- 24 (c) On providing a licensing authority with the notice
- described by Subsection (a), the Title IV-D agency shall send a copy
- 26 to the obligor by first class mail and inform the obligor of the
- 27 steps the obligor must take to permit the authority to accept the

1 <u>obligor's application for license renewal.</u>

- (d) An obligor receiving notice under Subsection (c) may 2 3 request a review by the Title IV-D agency to resolve any issue in dispute regarding the identity of the obligor or the existence or 4 amount of child support arrearages. The Title IV-D agency shall 5 6 promptly provide an opportunity for a review, either by telephone 7 or in person, as appropriate to the circumstances. After the review, if appropriate, the Title IV-D agency may notify the 8 9 licensing authority that it may accept the obligor's application for renewal of license. <u>If the Title IV-D agency and the obligor</u> 10 fail to resolve any issue in dispute, the obligor, not later than 11 the 30th day after the date of receiving notice of the Title IV-D 12 13 agency's determination from the review, may file a motion with the court to direct the Title IV-D agency to withdraw the notice under 14 Subsection (a) and request a hearing on the motion. The obligor's 15 16 application for license renewal may not be accepted by the licensing authority until the court rules on the motion. If, after 17 a review by the Title IV-D agency or a hearing by the court, the 18 Title IV-D agency withdraws the notice under Subsection (a), the 19 20 Title IV-D agency shall reimburse the obligor the amount of any fee charged the obligor under Section 232.014. 21
