S.B. No. 228

A BILL TO BE ENTITLED

AN ACT

1
2 relating to suits affecting the parent-child relationship,
3 including proceedings for the establishment, modification, and
4 enforcement of child support; providing a civil penalty.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Chapter 101, Family Code, is amended by adding
7 Section 101.0255 to read as follows:

8 Sec. 101.0255. RECORD. "Record" means information that
9 is:

10 (1) inscribed on a tangible medium or stored in an
11 electronic or other medium; and

12 (2) retrievable in a perceivable form.

13 SECTION 2. Section 102.009(d), Family Code, is amended to
14 read as follows:

15 (d) If the petition requests the establishment,
16 termination, modification, or enforcement of a support right
17 assigned to the Title IV-D agency under Chapter 231 or the
18 rescission of a voluntary acknowledgment of paternity under Chapter
19 160, notice shall be given to the Title IV-D agency in a manner
20 provided by Rule 21a, Texas Rules of Civil Procedure.

21 SECTION 3. Section 151.001(b), Family Code, is amended to
22 read as follows:

23 (b) The duty of a parent to support his or her child exists
24 while the child is an unemancipated minor and continues as long as

1 the child is fully enrolled in a a [~~an accredited~~] secondary school in
2 a program leading toward a high school diploma and complies with
3 attendance requirements described by Section 154.002(a)(2) [~~until~~
4 ~~the end of the school year in which the child graduates~~].

5 SECTION 4. Section 155.301(c), Family Code, is amended to
6 read as follows:

7 (c) Except as otherwise provided by this subsection, if [~~If~~]
8 a transfer of continuing, exclusive jurisdiction is sought under
9 this section, the procedures for determining and effecting a
10 transfer of proceedings provided by this chapter apply. If the
11 parties submit to the court an agreed order for transfer, the court
12 shall sign the order without the need for other pleadings.

13 SECTION 5. Section 156.401(b), Family Code, is amended to
14 read as follows:

15 (b) A support order may be modified with regard to the
16 amount of support ordered only as to obligations accruing after the
17 earlier of:

18 (1) the date of service of citation; or

19 (2) an appearance in the suit to modify.

20 SECTION 6. Section 156.409, Family Code, is amended by
21 amending Subsection (a) and adding Subsection (a-1) to read as
22 follows:

23 (a) The [~~If the sole managing conservator of a child or the~~
24 ~~joint managing conservator who has the exclusive right to determine~~
25 ~~the primary residence of the child has voluntarily relinquished the~~
26 ~~primary care and possession of the child to another person for at~~
27 ~~least six months, the~~] court shall, on the motion of a party or a

1 ~~[the other]~~ person having physical possession of the child, modify
2 an order providing for the support of the child to provide that the
3 ~~[other]~~ person having physical possession of the child, including a
4 conservator or governmental entity, shall have the right to receive
5 and give receipt for payments of support for the child and to hold
6 or disburse money for the benefit of the child if the sole managing
7 conservator of the child or the joint managing conservator who has
8 the exclusive right to determine the primary residence of the child
9 has:

10 (1) voluntarily relinquished the primary care and
11 possession of the child to another person for at least six months;

12 (2) been incarcerated or sentenced to be incarcerated
13 for at least 30 days; or

14 (3) relinquished the primary care and possession of
15 the child in a proceeding under Title 3 or Chapter 262.

16 (a-1) If the court modifies a support order under this
17 section, the court shall order the obligor to pay the person or
18 entity having physical possession of the child any unpaid child
19 support that is not subject to offset or reimbursement under
20 Section 157.008 and that accrues after the date the sole or joint
21 managing conservator:

22 (1) relinquishes possession and control of the child,
23 whether voluntarily or in a proceeding under Title 3 or Chapter 262;

24 or

25 (2) is incarcerated.

26 SECTION 7. Section 157.005(a), Family Code, is amended to
27 read as follows:

1 (a) The court retains jurisdiction to render a contempt
2 order for failure to comply with the child support order if the
3 motion for enforcement is filed not later than the second
4 anniversary of [~~sixth month after~~] the date:

5 (1) the child becomes an adult; or

6 (2) on which the child support obligation terminates
7 under the order or by operation of law.

8 SECTION 8. Section 157.065(a), Family Code, is amended to
9 read as follows:

10 (a) If a party has been ordered under Chapter 105 to provide
11 the court and the state case registry with the party's current
12 mailing address, notice of a hearing on a motion for enforcement may
13 be served by mailing a copy of the notice to the respondent,
14 together with a copy of the motion, by first class mail to the last
15 mailing address of the respondent on file with the court and the
16 registry.

17 SECTION 9. Sections 157.105(a) and (c), Family Code, are
18 amended to read as follows:

19 (a) If the respondent is taken into custody and not released
20 on bond, the respondent shall be brought before the court that
21 issued the capias on or before the third [~~first~~] working day after
22 the arrest. The court shall determine whether the respondent's
23 appearance in court at a designated time and place can be assured by
24 a method other than by posting the bond or security previously
25 established.

26 (c) If the court is not satisfied that the respondent's
27 appearance in court can be assured and the respondent remains in

1 custody, a hearing on the alleged contempt shall be held as soon as
2 practicable, but not later than the seventh [~~fifth~~] day after the
3 date that the respondent was taken into custody, unless the
4 respondent and the respondent's attorney waive the accelerated
5 hearing.

6 SECTION 10. Section 157.211, Family Code, is amended to
7 read as follows:

8 Sec. 157.211. CONDITIONS OF COMMUNITY SUPERVISION. If the
9 court places the respondent on community supervision [~~and suspends~~
10 ~~commitment~~], the terms and conditions of community supervision may
11 include the requirement that the respondent:

12 (1) report to the community supervision officer as
13 directed;

14 (2) permit the community supervision officer to visit
15 the respondent at the respondent's home or elsewhere;

16 (3) obtain counseling on financial planning, budget
17 management, conflict resolution, parenting skills, alcohol or drug
18 abuse, or other matters causing the respondent to fail to obey the
19 order;

20 (4) pay required child support and any child support
21 arrearages;

22 (5) pay court costs and attorney's fees ordered by the
23 court;

24 (6) seek employment assistance services offered by the
25 Texas Workforce Commission under Section 302.0035, Labor Code, if
26 appropriate; [~~and~~]

27 (7) participate in mediation or other services to

1 alleviate conditions that prevent the respondent from obeying the
2 court's order; and

3 (8) submit to a period of confinement in a county jail
4 beginning at any time during the community supervision period,
5 except that the aggregate of all periods of confinement during the
6 community supervision period may not exceed 180 days.

7 SECTION 11. Section 157.212, Family Code, is amended to
8 read as follows:

9 Sec. 157.212. TERM OF COMMUNITY SUPERVISION. The initial
10 period of community supervision [~~period~~] may not exceed 10 years.
11 The court may continue the community supervision beyond 10 years
12 until the earlier of:

13 (1) the second anniversary of the date on which the
14 community supervision first exceeded 10 years; or

15 (2) the date on which all child support, including
16 arrearages and interest, has been paid.

17 SECTION 12. Sections 157.216(a) and (b), Family Code, are
18 amended to read as follows:

19 (a) The court shall hold a hearing without a jury not later
20 than [~~on or before~~] the third [~~first~~] working day after the date the
21 respondent is arrested under Section 157.215. If the court is
22 unavailable for a hearing on that date, the hearing shall be held
23 not later than the third [~~first~~] working day after the date the
24 court becomes available.

25 (b) The hearing under this section may not be held later
26 than the seventh [~~third~~] working day after the date the respondent
27 is arrested.

1 SECTION 13. Section 157.263(c), Family Code, is amended to
2 read as follows:

3 (c) If the amount of arrearages confirmed by the court
4 reflects a credit to the obligor for support arrearages collected
5 from a federal tax refund under 42 U.S.C. Section 664, ~~[as amended,~~
6 and, subsequently, the amount of that credit is reduced because the
7 refund was adjusted because of an injured spouse claim by a jointly
8 filing spouse, the tax return was amended, the return was audited by
9 the Internal Revenue Service, or for another reason permitted by
10 law ~~[based on a joint return under which another person was entitled~~
11 ~~to a share of the refund under 42 U.S.C. Section 664, as amended],~~
12 the court shall render a new cumulative judgment to include as
13 arrearages an amount equal to the amount by which the credit was
14 reduced.

15 SECTION 14. Section 157.264(b), Family Code, is amended to
16 read as follows:

17 (b) The court shall ~~[may]~~ render an order requiring~~[-~~
18 ~~[(1) that income be withheld from the disposable~~
19 ~~earnings of the obligor in an amount sufficient to discharge the~~
20 ~~judgment in not more than two years, or~~
21 ~~[(2) if the obligor is not subject to income~~
22 ~~withholding,~~] that the obligor make periodic payments on the
23 judgment, including by income withholding under Chapter 158 if the
24 obligor is subject to income withholding ~~[to the obligee in an~~
25 ~~amount sufficient to discharge the judgment within a reasonable~~
26 ~~time].~~

27 SECTION 15. Section 157.269, Family Code, is amended to

1 read as follows:

2 Sec. 157.269. RETENTION OF JURISDICTION. A court that
3 renders an order providing for the payment of child support
4 [~~arreages~~] retains continuing jurisdiction to enforce the order,
5 including by adjusting the amount of the periodic payments to be
6 made by the obligor or the amount to be withheld from the obligor's
7 disposable earnings, until all current support and medical support
8 and child support arreages, including interest and any applicable
9 fees and costs, have been paid.

10 SECTION 16. Sections 157.313(a), (c), and (e), Family Code,
11 are amended to read as follows:

12 (a) Except as provided by Subsection (e), a child support
13 lien notice must contain:

14 (1) the name and address of the person to whom the
15 notice is being sent;

16 (2) the style, docket or cause number, and identity of
17 the tribunal of this or another state having continuing
18 jurisdiction of the child support action and, if the case is a Title
19 IV-D case, the case number;

20 (3) the full name, address, and, if known, the birth
21 date, driver's license number, social security number, and any
22 aliases of the obligor;

23 (4) the full name and, if known, social security
24 number of the obligee;

25 (5) the amount of the current or prospective child
26 support obligation, the frequency with which current or prospective
27 child support is ordered to be paid, and the amount of child support

1 arrearages owed by the obligor and the date of the signing of the
2 court order, administrative order, or writ that determined the
3 arrearages or the date and manner in which the arrearages were
4 determined;

5 (6) the rate of interest specified in the court order,
6 administrative order, or writ or, in the absence of a specified
7 interest rate, the rate provided for by law;

8 (7) the name and address of the person or agency
9 asserting the lien;

10 (8) the motor vehicle identification number as shown
11 on the obligor's title if the property is a motor vehicle;

12 (9) a statement that the lien attaches to all
13 nonexempt real and personal property of the obligor that is located
14 or recorded in the state, including any property specifically
15 identified in the notice and any property acquired after the date of
16 filing or delivery of the notice;

17 (10) a statement that any ordered child support not
18 timely paid in the future constitutes a final judgment for the
19 amount due and owing, including interest, and accrues up to an
20 amount that may not exceed the lien amount; and

21 (11) a statement that the obligor is being provided a
22 copy of the lien notice and that the obligor may dispute the
23 arrearage amount by filing suit under Section 157.323.

24 (c) Except as provided by Subsection (e), the ~~The~~ lien
25 notice must be verified.

26 (e) A notice of a lien for child support under this section
27 may be in the form authorized by federal law or regulation. The

1 federal form of lien notice does not require verification when used
2 by the Title IV-D agency.

3 SECTION 17. Section 157.317(a-1), Family Code, is amended
4 to read as follows:

5 (a-1) A lien attaches to all property owned or acquired on
6 or after the date the lien notice or abstract of judgment is filed
7 with the county clerk of the county in which the property is
8 located, with the court clerk as to property or claims in
9 litigation, or, as to property of the obligor in the possession or
10 control of a third party, from the date the lien notice is delivered
11 to [filed with] that party.

12 SECTION 18. Subchapter C, Chapter 158, Family Code, is
13 amended by adding Section 158.214 to read as follows:

14 Sec. 158.214. WITHHOLDING FROM SEVERANCE PAY. (a) In this
15 section, "severance pay" means income paid on termination of
16 employment in addition to the employee's usual earnings from the
17 employer at the time of termination.

18 (b) An employer receiving an order or writ of withholding
19 under this chapter shall withhold from any severance pay owed an
20 obligor an amount equal to the amount the employer would have
21 withheld under the order or writ if the severance pay had been paid
22 as the obligor's usual earnings as a current employee.

23 (c) The total amount that may be withheld under this section
24 is subject to the maximum amount allowed to be withheld under
25 Section 158.009.

26 SECTION 19. Section 159.102(23), Family Code, is amended to
27 read as follows:

1 (23) "Support order" means a judgment, decree, [~~or~~]
2 order, or directive, whether temporary, final, or subject to
3 modification, issued by a tribunal for the benefit of a child, a
4 spouse, or a former spouse that provides for monetary support,
5 health care, arrearages, or reimbursement and may include related
6 costs and fees, interest, income withholding, attorney's fees, and
7 other relief.

8 SECTION 20. Section 161.206, Family Code, is amended by
9 adding Subsection (d) to read as follows:

10 (d) An order rendered under this section must include a
11 finding that:

12 (1) a request for identification of a court of
13 continuing, exclusive jurisdiction has been made as required by
14 Section 155.101; and

15 (2) all parties entitled to notice, including the
16 Title IV-D agency, have been notified.

17 SECTION 21. Section 231.202, Family Code, is amended to
18 read as follows:

19 Sec. 231.202. AUTHORIZED COSTS AND FEES IN TITLE IV-D
20 CASES. In a Title IV-D case filed under this title, including a
21 case filed under Chapter 159, the Title IV-D agency shall pay:

22 (1) filing fees and fees for issuance and service of
23 process as provided by Chapter 110 of this code and by Sections
24 51.317, 51.318(b)(2), and 51.319(2), Government Code;

25 (2) fees for transfer as provided by Chapter 110;

26 (3) fees for the issuance and delivery of orders and
27 writs of income withholding in the amounts provided by Chapter 110;

1 (4) the fee that sheriffs and constables are
2 authorized to charge for serving process under Section 118.131,
3 Local Government Code, for each item of process to each individual
4 on whom service is required, including service by certified or
5 registered mail, to be paid to a sheriff, constable, or clerk
6 whenever service of process is required; ~~and~~

7 (5) the fee for filing an administrative writ of
8 withholding under Section 158.503(d); and

9 (6) the fee for issuance of a subpoena as provided by
10 Section 51.318(b)(1), Government Code.

11 SECTION 22. Sections 232.001(1)-(3), Family Code, are
12 amended to read as follows:

13 (1) "License" means a license, certificate,
14 registration, permit, or other authorization that:

15 (A) is issued by a licensing authority;

16 (B) is subject before expiration to renewal,
17 suspension, revocation, forfeiture, or termination by a ~~the~~
18 ~~issuing~~ licensing authority; and

19 (C) a person must obtain to:

20 (i) practice or engage in a particular
21 business, occupation, or profession;

22 (ii) operate a motor vehicle on a public
23 highway in this state; or

24 (iii) engage in any other regulated
25 activity, including hunting, fishing, or other recreational
26 activity for which a license or permit is required.

27 (2) "Licensing authority" means a department,

1 commission, board, office, or other agency of the state or a
2 political subdivision of the state that issues or renews a license
3 or that otherwise has authority to suspend or refuse to renew a
4 license.

5 (3) "Order suspending license" means an order issued
6 by the Title IV-D agency or a court directing a licensing authority
7 to suspend or refuse to renew a license.

8 SECTION 23. Section 232.002, Family Code, is amended to
9 read as follows:

10 Sec. 232.002. LICENSING AUTHORITIES SUBJECT TO
11 CHAPTER. Unless otherwise restricted or exempted, all [~~The~~

24 SECTION 24. Chapter 232, Family Code, is amended by adding
25 Section 232.0022 to read as follows:

26 Sec. 232.0022. SUSPENSION OF MOTOR VEHICLE REGISTRATION.

27 The Texas Department of Transportation is the appropriate licensing

1 authority for suspension of a motor vehicle registration under this
2 chapter. The general registration provisions of Chapter 502,
3 Transportation Code, do not apply to the suspension or denial of a
4 renewal of a motor vehicle registration under this chapter.

5 SECTION 25. Section 232.004(a), Family Code, is amended to
6 read as follows:

7 (a) A child support agency or obligee may file a petition to
8 suspend, as provided by this chapter, a license of an obligor who
9 has an arrearage equal to or greater than the total support due for
10 three months [~~90 days~~] under a support order.

11 SECTION 26. Sections 232.006(b) and (c), Family Code, are
12 amended to read as follows:

13 (b) Notice under this section may be served:

14 (1) if the party has been ordered under Chapter 105 to
15 provide the court and registry with the party's current mailing
16 address, by mailing a copy of the notice to the respondent, together
17 with a copy of the petition, by first class mail to the last mailing
18 address of the respondent on file with the court and the state case
19 registry; or

20 (2) as in civil cases generally.

21 (c) The notice must contain the following prominently
22 displayed statement in boldfaced type, capital letters, or
23 underlined:

24 "AN ACTION TO SUSPEND ONE OR MORE LICENSES ISSUED TO YOU HAS
25 BEEN FILED AS PROVIDED BY CHAPTER 232, TEXAS FAMILY CODE. YOU MAY
26 EMPLOY AN ATTORNEY TO REPRESENT YOU IN THIS ACTION. IF YOU OR YOUR
27 ATTORNEY DO NOT REQUEST A HEARING BEFORE THE 21ST DAY AFTER THE DATE

1 OF SERVICE OF THIS NOTICE, AN ORDER SUSPENDING YOUR [~~OF~~] LICENSE
2 [~~SUSPENSION~~] MAY BE RENDERED."

3 SECTION 27. Chapter 232, Family Code, is amended by adding
4 Section 232.0135 to read as follows:

5 Sec. 232.0135. DENIAL OF LICENSE RENEWAL. (a) The Title
6 IV-D agency may provide notice to a licensing authority concerning
7 an obligor who has failed to pay child support for six months or
8 more that requests the authority to refuse to accept an application
9 for renewal of the license of the obligor.

10 (b) A licensing authority that receives the information
11 described by Subsection (a) shall refuse to accept an application
12 for renewal of the license of the obligor until the authority is
13 notified by the Title IV-D agency that the obligor has:

14 (1) paid all child support arrearages;

15 (2) established with the Title IV-D agency a
16 satisfactory repayment schedule or is in compliance with a court
17 order for payment of the arrearages;

18 (3) been granted an exemption from this subsection as
19 part of a court-supervised plan to improve the obligor's earnings
20 and child support payments; or

21 (4) successfully contested the denial of renewal of
22 license under Subsection (d).

23 (c) On providing a licensing authority with the notice
24 described by Subsection (a), the Title IV-D agency shall send a copy
25 to the obligor by first class mail and inform the obligor of the
26 steps the obligor must take to permit the authority to accept the
27 obligor's application for license renewal.

1 (d) An obligor receiving notice under Subsection (c) may
2 request a review by the Title IV-D agency to resolve any issue in
3 dispute regarding the identity of the obligor or the existence or
4 amount of child support arrearages. The Title IV-D agency shall
5 promptly provide an opportunity for a review, either by telephone
6 or in person, as appropriate to the circumstances. After the
7 review, if appropriate, the Title IV-D agency may notify the
8 licensing authority that it may accept the obligor's application
9 for renewal of license. If the Title IV-D agency and the obligor
10 fail to resolve any issue in dispute, the obligor, not later than
11 the 30th day after the date of receiving notice of the Title IV-D
12 agency's determination from the review, may file a motion with the
13 court to direct the Title IV-D agency to withdraw the notice under
14 Subsection (a) and request a hearing on the motion. The obligor's
15 application for license renewal may not be accepted by the
16 licensing authority until the court rules on the motion.

17 (e) If an obligor enters into a repayment agreement with the
18 Title IV-D agency under this section, the Title IV-D agency may
19 incorporate the agreement in an order to be filed with and confirmed
20 by the court in the manner provided for agreed orders under Chapter
21 233.

22 (f) In this section, "licensing authority" does not include
23 the State Securities Board.

24 SECTION 28. Section 232.014, Family Code, is amended to
25 read as follows:

26 Sec. 232.014. FEE BY LICENSING AUTHORITY. (a) A licensing
27 authority may charge a fee to an individual who is the subject of an

1 order suspending license or of an action by the Title IV-D agency to
2 deny renewal of license in an amount sufficient to recover the
3 administrative costs incurred by the authority under this chapter.

4 (b) A fee collected by the Texas Department of
5 Transportation or the Department of Public Safety shall be

5 to a court order establishing paternity or the obligation to pay
6 child support applies only to a suit affecting the parent-child
7 relationship filed on or after the effective date of this Act. A
8 suit affecting the parent-child relationship filed before the
9 effective date of this Act is governed by the law in effect on the
10 date the suit was filed, and the former law is continued in effect
11 for that purpose.

12 (b) The change in law made by this Act relating to the
13 modification or enforcement of a child support order rendered
14 before the effective date of this Act applies only to a proceeding
15 for modification or enforcement that is commenced on or after the
16 effective date of this Act. A proceeding for modification or

18 is governed by the law in effect on the date the proceeding was

21 (c) The change in law made by this Act by the enactment of
22 Section 234.105, Family Code, applies only to a violation that
23 occurs on or after the effective date of this Act. A violation that
24 occurs before that date is governed by the law in effect on the date
25 the violation occurred, and the former law is continued in effect
26 for that purpose.
