A BILL TO BE ENTITLED

| 4 | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: |
| 5 | SECTION 1. Subchapter A, Chapter 44, Education Code, is |
| 6 | amended by adding Section 44.012 to read as follows: |
| 7 | Sec. 44.012. REPORT OF INCOME-PRODUCING CONTRACTS AND |
| 8 | PROGRAMS. (a) In this section, "income-producing contract or |
| 9 | <pre>program" means:</pre> |
| 10 | (1) a contract under which a school district is |
| 11 | entitled to or expects to receive income, including rentals, |
| 12 | royalties, or a percentage of sales revenue; or |
| 13 | (2) a program operated by a school district or another |
| 14 | entity under which the district is entitled to or expects to receive |
| 15 | income. |
| 16 | (b) As provided by this section, a school district shall: |
| 17 | (1) publish a report of income-producing contracts and |
| 18 | programs in a newspaper of general circulation in: |
| 19 | (A) a county in which the district is located; or |
| 20 | (B) the county seat of a county adjacent to a |
| 21 | county in which the district is located, if a newspaper of general |
| 22 | circulation is not published in a county in which the district is |
| 23 | <pre>located; or</pre> |
| 24 | (2) post a report of income-producing contracts and |

| 2 | (c) Except as provided by Subsection (d): |
| 3 | (1) for each income-producing contract a school |
| 4 | district enters into or under which the district receives income |
| 5 | during the reporting period covered by the publication or posting, |
| 6 | the district's report must include: |
| 7 | (A) the full name and address of each party to the |
| 8 | <pre>contract other than the district;</pre> |
| 9 | (B) a description of the type of contract |
| 10 | <pre>involved;</pre> |
| 11 | (C) the date the contract was entered into; |
| 12 | (D) the duration of the contract; |
| 13 | (E) a statement of the amount of income the |
| 14 | district expects to receive under the contract over the term of the |
| 15 | <pre>contract; and</pre> |
| 16 | (F) a statement of the amount of income the |
| 17 | district received under the contract during the reporting period; |
| 18 | <u>and</u> |
| 19 | (2) for each income-producing program under which the |
| 20 | district receives income during the reporting period covered by the |
| 21 | <pre>publication or posting, the district's report must include:</pre> |
| 22 | (A) the name of the program; |
| 23 | (B) a description of the program; |
| 24 | (C) if the program is operated by an entity other |
| 25 | than the district, the name of each entity from whom the district |
| 26 | received income under the program during the reporting period; and |
| 27 | (D) a statement of the total amount of income the |

- 2 (d) A school district is not required to report under this
- 3 section:
- 4 (1) a contract or program from which the district
- 5 <u>expects to receive income of \$5,000 or less over:</u>
- 6 (A) the term of the contract, in the case of a
- 7 <u>contract; or</u>
- 8 (B) the reporting period, in the case of a
- 9 program;
- 10 (2) a contract between the district and another school
- 11 district or other governmental entity; or
- 12 (3) a fund-raising contract with a nonprofit
- 13 organization or student group.
- 14 (e) A school district shall publish or shall post on the
- district's Internet website a report of income-producing contracts
- and programs two times each year. For a district whose fiscal year
- 17 begins July 1, the first report shall be published or posted not
- 18 later than August 15 and cover the period from the preceding January
- 19 1 through June 30, and the second report shall be published or
- 20 posted not later than February 15 and cover the period from the
- 21 preceding July 1 through December 31. For a district whose fiscal
- 22 year begins September 1, the first report shall be published or
- 23 posted not later than October 15 and cover the period from the
- 24 preceding March 1 through August 31, and the second report shall be
- 25 published or posted not later than April 15 and cover the period
- 26 from the preceding September 1 through the last day of February.
- 27 (f) Beginning on the second anniversary of the last date a

- 1 school district receives income under an income-producing contract
- 2 or program, if the district does not expect to receive additional
- 3 income under the contract or program, the district may remove
- 4 information relating to the contract or program from the district's
- 5 Internet website.
- 6 SECTION 2. A school district's first report of
- 7 income-producing contracts and programs under Section 44.012,
- 8 Education Code, as added by this Act, must be published or must be
- 9 posted on the district's Internet website not later than October
- 10 15, 2007, or February 15, 2008, depending on the date the district's
- 11 fiscal year begins.
- 12 SECTION 3. This Act takes effect immediately if it receives
- 13 a vote of two-thirds of all the members elected to each house, as
- 14 provided by Section 39, Article III, Texas Constitution. If this
- 15 Act does not receive the vote necessary for immediate effect, this
- 16 Act takes effect September 1, 2007.
