1 AN ACT 2 relating to parking of a motor vehicle operated by or for the 3 transportation of a veteran with a disability in certain parking 4 spaces; providing a criminal penalty. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subsection (e), Section 681.009, Transportation 6 7 Code, is amended to read as follows: A private property owner or private person who controls 8 (e) property used for parking and who designates one or more uncovered 9 parking spaces for the exclusive use of vehicles transporting 10 persons with disabilities shall assign at least half of those 11

spaces for the exclusive use of vehicles displaying a white on blue 12 13 shield disabled parking placard or license plates issued under Section 504.202, except that if an odd number of spaces is 14 15 designated, only the number of spaces that is the largest whole number less than half of the number of designated spaces must be 16 assigned for the exclusive use of vehicles displaying a white on 17 blue shield placard or license plates issued under Section 504.202. 18 19 Van-accessible parking spaces shall be counted as assigned spaces under this subsection. These assigned spaces must be the spaces 20 located closest to an accessible route to an entrance accessible to 21 22 a person with a disability. The remaining designated parking 23 spaces may be used by vehicles displaying a white on blue shield 24 disabled parking placard, a white on red shield disabled parking

placard, [or] license plates issued under Section 504.201, or license plates issued under Section 504.202. This subsection applies only to a property used for parking that serves a building or other facility: (1) that state law requires to be accessible to person with disabilities; and (2) for which construction or an alteration of the building or other facility is completed on or after September 1, 1999. SECTION 2. Subsection (b), Section 681.011, Transportation Code, is amended to read as follows: A person commits an offense if the person: (b) (1)stands a vehicle on which license plates issued under Section 504.201 or 504.202 are not displayed and a disabled parking placard is not displayed in a parking space or area designated specifically for individuals with disabilities by: a political subdivision; or (A) (B) a person who owns or controls private property used for parking as to which a political subdivision has provided for the application of this section under this Subsection (f); or (2) stands a vehicle displaying a white on red shield disabled parking placard or license plates issued under Section 504.201 in a space designated under Section 681.009(e) for the exclusive use of vehicles displaying a white on blue shield disabled parking placard or license plates issued under Section 504.202.
