- 2 relating to the availability of free prekindergarten programs in
- 3 public schools.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 29.153(a), (b), and (f), Education
- 6 Code, are amended to read as follows:
- 7 (a) A district shall offer prekindergarten classes if the
- 8 district identifies 15 or more children who are [eligible under
- 9 Subsection (b) and are at least four years of age. A school
- 10 district may offer prekindergarten classes if the district
- identifies 15 or more eligible children who are at least three years
- 12 of age. A district may not charge tuition for a prekindergarten
- 13 class offered under this section.
- 14 (b) A child is eligible for enrollment in a prekindergarten
- 15 class under this section if the child is:
- 16 (1) at least three years of age and is:
- 17 $\underline{\text{(A)}}$ [\(\frac{\text{(1)}}{\text{)}}\)] unable to speak and comprehend the
- 18 English language;
- 19 (B) [(2)] educationally disadvantaged;
- 20 (C) (3) homeless, as defined by 42 U.S.C.
- 21 Section 11302, regardless of the residence of the child, of either
- 22 parent of the child, or of the child's guardian or other person
- 23 having lawful control of the child;
- (D) $\left[\frac{(4)}{(4)}\right]$ the child of an active duty member of

- 1 the armed forces of the United States, including the state military
- 2 forces or a reserve component of the armed forces, who is ordered to
- 3 active duty by proper authority; or
- 4 (E) $\left[\frac{(5)}{(5)}\right]$ the child of a member of the armed
- 5 forces of the United States, including the state military forces or
- 6 a reserve component of the armed forces, who was injured or killed
- 7 while serving on active duty; or
- 8 (2) at least four years of age.
- 9 (f) A child who is eligible for enrollment in a
- 10 prekindergarten class under Subsection (b)(1)(D) or (E) [(b)(4) or
- 11 (5) remains eligible for enrollment if the child's parent leaves
- 12 the armed forces, or is no longer on active duty, after the child
- 13 begins a prekindergarten class.
- 14 SECTION 2. Section 29.1532(c), Education Code, is amended
- 15 to read as follows:
- 16 (c) A school district that offers prekindergarten classes
- 17 shall include the following information in the district's Public
- 18 Education Information Management System (PEIMS) report:
- 19 (1) demographic information, as determined by the
- 20 commissioner, on students enrolled in district prekindergarten
- 21 classes, including the number of students who are eligible for
- 22 classes under Section 29.153(b)(1) [29.153];
- 23 (2) the numbers of half-day and full-day
- 24 prekindergarten classes offered by the district; and
- 25 (3) the sources of funding for the prekindergarten
- 26 classes.
- 27 SECTION 3. Section 29.153(d), Education Code, is repealed.

- SECTION 4. This Act applies beginning with the 2007-2008
- 2 school year.
- 3 SECTION 5. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2007.
