Subsection (a), Section 61.9623, Education Code, is amended to read as follows: 8 9 (a) A grant from the professional nursing shortage 10 reduction program to a professional nursing program or other entity involved with a professional nursing program in the preparation of 11 12 students for initial licensure as registered nurses must be: 13 (1)expended exclusively on costs related to: 14 enrolling additional students; (A) 15 (B) nursing faculty enhancement in accordance with Section 61.96231; 16 (C) encouraging innovation in the recruitment 17 and retention of students, including the recruitment and retention 18 of Spanish-speaking and bilingual students; or 19 identifying, developing, or implementing 20 (D) innovative methods to make the most effective use of limited 21 22 professional nursing program faculty, instructional or clinical space, and other resources, including: 23 administrative 24 (i) sharing or

instructional personnel, facilities, and responsibilities between two or more professional nursing programs located in the same region of this state; and

4 (ii) using preceptors <u>or part-time faculty</u>
5 to provide clinical instruction in order to <u>address the need for</u>
6 <u>qualified</u> [reduce the number of new] faculty [needed] to
7 accommodate increased student enrollment in the professional
8 nursing program;

9 (2) contingent on the professional nursing program's 10 having been approved as a professional nursing program by the board 11 or the Board of Nurse Examiners, as appropriate, by September 1, 12 2001;

(3) contingent on the professional nursing program's not being on probation with the Board of Nurse Examiners or other accrediting body; and

16 (4) if granted to increase enrollments, contingent on 17 the professional nursing program's ability to enroll additional 18 students, including having the necessary classroom space and 19 clinical slots.

20 SECTION 2. This Act takes effect immediately if it receives 21 a vote of two-thirds of all the members elected to each house, as 22 provided by Section 39, Article III, Texas Constitution. If this 23 Act does not receive the vote necessary for immediate effect, this 24 Act takes effect September 1, 2007.
