## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the administration of end-of-course assessment 3 instruments in public schools at certain grade levels.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 18.006(b), Education Code, is amended to 6 read as follows:
- 7 (b) In addition to other factors determined to be

appropriate by the commissioner, the accountability system must

- 9 include consideration of:
- 10 (1) student performance on the <u>end-of-course</u>
- 11 [secondary exit-level] assessment instruments required by Section
- 12 39.023(c); and
- 13 (2) dropout rates, including dropout rates and diploma
- 14 program completion rates for the grade levels served by the diploma
- 15 program.

- SECTION 2. Section 25.005(b), Education Code, is amended to
- 17 read as follows:
- 18 (b) A reciprocity agreement must:
- 19 (1) address procedures for:
- 20 (A) transferring student records;
- 21 (B) awarding credit for completed course work;
- 22 and
- (C) permitting a student to satisfy the
- 24 requirements of Section 39.025 through successful performance on

- 1 comparable <u>end-of-course</u> or <u>other</u> exit-level assessment
- 2 instruments administered in another state; and
- 3 (2) include appropriate criteria developed by the
- 4 agency.
- 5 SECTION 3. Section 29.081(b), Education Code, is amended to
- 6 read as follows:
- 7 (b) Each district shall provide accelerated instruction to
- 8 a student enrolled in the district who has taken an end-of-course
- 9 [the secondary exit-level] assessment instrument administered
- 10 <u>under Section 39.023(c)</u> and has not performed satisfactorily on the
- 11 assessment instrument [each section] or who is at risk of dropping
- 12 out of school.
- SECTION 4. Section 29.087(f), Education Code, as amended by
- 14 Chapters 283 and 373, Acts of the 78th Legislature, Regular
- 15 Session, 2003, is reenacted and amended to read as follows:
- 16 (f) A student participating in a program authorized by this
- 17 section, other than a student ordered to participate under
- 18 Subsection (d)(1), must have taken the appropriate end-of-course
- 19 assessment instruments under [specified by] Section 39.023(c) for
- courses in which the student has enrolled [39.023(a) for grade 9]
- 21 before entering the program and must take each appropriate
- 22 end-of-course [grade level] assessment instrument administered for
- 23 <u>courses in which the student is enrolled</u> during the period in which
- the student is enrolled in the program. Except for a student ordered
- 25 to participate under Subsection (d)(1), a student participating in
- 26 the program may not take the high school equivalency examination
- 27 unless the student has taken the assessment instruments required by

- 1 this subsection.
- 2 SECTION 5. Section 30.021(e), Education Code, is amended to
- 3 read as follows:
- 4 The school shall cooperate with public and private 5 agencies and organizations serving students and other persons with 6 impairments in the planning, development, implementation of effective educational and rehabilitative service 7 8 delivery systems associated with educating students with visual 9 impairments. To maximize and make efficient use of state 10 facilities, funding, and resources, the services provided in this area may include conducting a cooperative program with other 11 agencies to serve students who have graduated from high school by 12 completing all academic requirements applicable to students in 13 14 regular education, excluding satisfactory performance under Section 39.025 [on the exit-level assessment instrument], who are 15 younger than 22 years of age on September 1 of the school year and 16 17 have identified needs related to vocational training, independent living skills, orientation and mobility, social and 18 leisure skills, compensatory skills, or remedial academic skills. 19
- SECTION 6. Section 39.023, Education Code, is amended by amending Subsections (a) and (c) and adding Subsection (c-1) to read as follows:
- 23 (a) The agency shall adopt or develop appropriate 24 criterion-referenced assessment instruments designed to assess 25 essential knowledge and skills in reading, writing, mathematics, 26 social studies, and science. All students, except students 27 assessed under Subsection (b) or (1) or exempted under Section

- 17 (c) The agency shall also adopt <a href="end-of-course">end-of-course</a> [secondary
- 18 <u>exit-level</u>] assessment instruments for each course offered at or
- 19 above the grade nine level that is a part of the foundation
- 20 curriculum under Section 28.002(a)(1). A school district shall
- 21 comply with State Board of Education rules regarding administration
- of the assessment instruments to students enrolled in the courses
- 23 for which the assessment instruments were adopted and shall adopt a
- 24 policy that requires a student's performance on an assessment
- instrument for a course to account for at least 20 percent and not
- 26 more than 40 percent of the student's final grade for the course
- 27 [designed to be administered to students in grade 11 to assess

essential knowledge and skills in mathematics, English language arts, social studies, and science. The mathematics section must include at least Algebra I and geometry with the aid of technology. The English language arts section must include at least English III and must include the assessment of essential knowledge and skills in writing. The social studies section must include early American and United States history. The science section must include at least biology and integrated chemistry and physics. The assessment instruments must be designed to assess a student's mastery of minimum skills necessary for high school graduation and readiness to enroll in an institution of higher education]. If a student is in a special education program under Subchapter A, Chapter 29, the student's admission, review, and dismissal committee shall determine whether any allowable modification is necessary in administering to the student an assessment instrument required under this subsection or whether the student should be exempted under Section 39.027(a)(2). The State Board of Education shall administer the assessment instruments. The State Board of Education shall adopt a schedule for the administration of end-of-course [secondary exit-level] assessment instruments. Each student who did not perform satisfactorily on any end-of-course [secondary exit-level] assessment instrument when initially tested shall be given multiple opportunities to retake that assessment instrument. [A student who performs at or above a level established by the Texas Higher Education Coordinating Board on the secondary exit-level assessment instruments is exempt from the requirements of Section 51.306.

No. 379 (c-1) Notwithstanding Subsection (a), a student in grade 1 2 eight who is enrolled in a secondary-level course for which an end-of-course assessment instrument has been adopted under 3 4 Subsection (c) shall be administered the end-of-course assessment instrument for that course instead of the assessment instrument for 5 6 the related subject area under Subsection (a). SECTION 7. Section 39.025, Education Code, is amended to 7 8 read as follows: 9 Sec. 39.025. SECONDARY-LEVEL [EXIT-LEVEL] PERFORMANCE REQUIRED. (a) The commissioner shall adopt rules requiring a 10 student to receive, in each subject in the foundation curriculum 11 12 under Section 28.002(a)(1), an average score of at least 70 on a 13

scale of 100 on the end-of-course assessment instruments administered to the student under Section 39.023(c) in grades 9, 10, and 11. For purposes of this subsection, a student's average score for each subject in the foundation curriculum is determined by averaging the student's highest score on each end-of-course assessment instrument administered to the student for a course considered a part of that subject, as determined by commissioner rule. A student may not receive a high school diploma until the student has performed satisfactorily on the <a href="mailto:end-of-course">end-of-course</a> [secondary exit-level] assessment instruments in the manner provided under this subsection [for English language arts, mathematics, social studies, and science administered under Section 39.023(c)]. This subsection does not require a student to

demonstrate readiness to enroll in an institution of higher

- 1 (b) Each time <u>an end-of-course</u> [a secondary exit-level]
  2 assessment instrument is administered, a student who has not been
  3 given a high school diploma because of a failure to perform
  4 satisfactorily on the assessment instrument [for that subject area]
  5 may retake the assessment instrument.
- 6 (c) A student who has been denied a high school diploma
  7 under this section [Subsections (a) and (b)] and who subsequently
  8 performs at the level necessary to comply with the requirements of
  9 this section [satisfactorily on each secondary exit-level
  10 assessment instrument] shall be issued a high school diploma.
- 11 (d) Notwithstanding Subsection (a), the commissioner by 12 rule shall adopt one or more alternative nationally recognized norm 13 referenced assessment instruments under this section to administer 14 to a student to qualify for a high school diploma if the student 15 enrolls after January 1 of the school year in which the student is 16 otherwise eligible to graduate:

- 24 The indicators must be based on information that is disaggregated

- 17 (6) the percentage of graduating students who meet the
- 18 course requirements established for the recommended high school
- 19 program by State Board of Education rule;
- 20 (7) the results of the Scholastic Assessment Test
- 21 (SAT), the American College Test (ACT), articulated postsecondary
- 22 degree programs described by Section 61.852, and certified
- workforce training programs described by Chapter 311, Labor Code;
- 24 (8) the percentage of students, aggregated by grade
- level, provided accelerated instruction under Section 28.0211(c),
- 26 the results of assessments administered under that section, the
- 27 percentage of students promoted through the grade placement

- 2 assessment instrument on which each student failed to perform
- 3 satisfactorily, and the performance of those students in the school

- 7 satisfactorily on an assessment instrument required under Section

- 25 SECTION 10. Section 51.3062(q), Education Code, is amended
- 26 to read as follows:
- 27 (q) A student who has achieved scores [a score] set by the

board on <a href="mailto:end-of-course assessment">end-of-course assessment instruments</a> [an exit-level 1 assessment instrument] required under Section 39.023 is exempt from 2 the requirements of this section. The exemption is effective for 3 4 the three-year period following the date a student takes the last 5 assessment instrument required for purposes of this section and 6 achieves the standard set by the board. This subsection does not apply during any period for which the board designates the 7 8 end-of-course assessment instruments [exit-level assessment 9 instrument] required under Section 39.023 as the primary assessment instrument under this section, except that the three-year period 10 described by this subsection remains in effect for students who 11 qualify for an exemption under this subsection [section] before 12 that period. 13

SECTION 11. Section 39.023(j), Education Code, is repealed.

15 SECTION 12. A reference in the Education Code to an

end-of-course assessment instrument administered under Section

17 39.023(c), Education Code, includes an exit-level assessment

instrument administered under that section as provided by Section

19 39.025(f), Education Code, as added by this Act.

20 SECTION 13. This Act takes effect September 1, 2007.
