4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:	
5	SECTION 1. Chapter 242, Local Government Code, is amended	
6	by adding Subchapter B to read as follows:	
7	SUBCHAPTER B. DEVELOPMENT REGULATIONS IN CERTAIN COUNTIES AND	
8	MUNICIPALITIES	
9	Sec. 242.051. APPLICABILITY. This subchapter applies only	
10	to:	
11	(1) a county with a total area of less than 6,000	
12	square miles that includes territory located within 50 miles of an	
13	international border; or	
14	(2) a municipality located in that county if:	
15	(A) the county does not exercise in the	
16	municipality's extraterritorial jurisdiction the authority	
17	described by this subchapter; and	
18	(B) the county by resolution authorizes the	
19	municipality to exercise in the municipality's extraterritorial	
20	jurisdiction the authority described by this subchapter.	
21	Sec. 242.052. REGULATORY AUTHORITY. (a) The	
22	commissioners court of a county to which this subchapter applies	
23	may, by order, regulate residential land development in the	
24	unincorporated area of the county. The governing body of a

- 1 municipality to which this subchapter applies may, by ordinance,
- 2 regulate residential land development in the municipality's
- 3 <u>extraterritorial</u> jurisdiction. By this authority, the
- 4 commissioners court or governing body may prevent the proliferation
- 5 of colonias by:
- 6 (1) adopting regulations relating to:
- 7 (A) maximum densities, including the size of
- 8 lots;
- 9 (B) the height, number of stories, size, or
- 10 number of buildings or other structures that may be located on a lot
- 11 or tract;
- 12 (C) the location of buildings and other
- 13 structures on a lot or tract; and
- 14 (D) the preparation of a plan for utility
- 15 development, environmental effect and adaptation, utility
- 16 extension, and capacity planning and providing financial analysis
- of said plan; and
- 18 (2) adopting building codes to promote safe and
- 19 uniform building, plumbing, and electrical standards.
- 20 (b) If a tract of land is appraised as agricultural or
- 21 open-space land by the appraisal district, the commissioners court
- or governing body may not regulate land development on that tract
- 23 under the authority granted by Subsection (a)(1)(B), (a)(1)(C), or
- 24 (a)(2).
- 25 (c) The authority granted under this section does not
- 26 authorize the commissioners court or governing body to adopt an
- order regulating commercial property that is uninhabitable.

- 1 (d) The authority granted under this section does not
 2 authorize the commissioners court or governing body to adopt an
 3 order that limits or otherwise impairs the rights of individuals or
 4 entities in the exploration, development, or production of oil,
 5 gas, or other minerals.
- Sec. 242.053. BUILDING PERMITS. (a) The county or municipality, as appropriate, shall issue a building permit if the person submitting the application for the permit:
- 9 <u>(1) files information relating to the location of the</u> 10 residence;
- 11 (2) files the building plans for the residence; and
- 12 <u>(3) complies with the applicable regulations relating</u>
 13 to the issuance of the permit.
- 14 <u>(b) The county or municipality may charge a reasonable</u> 15 building permit fee.
- 16 (c) The county or municipality shall deposit fees collected
 17 under this section in an account in its general fund and dedicate
 18 the fees to the building permit program. The funds in the account
 19 may be used only for the purpose of administering the building
 20 permit program.
- Sec. 242.054. MUNICIPAL ORDINANCE PREVAILS OVER COUNTY

 ORDER. If an order adopted by the county under this subchapter

 conflicts with an ordinance of a municipality, the municipal

 ordinance prevails within the municipality's jurisdiction to the

 extent of the conflict.
- 26 <u>Sec. 242.055. EXISTING AUTHORITY UNAFFECTED. The authority</u> 27 granted by this subchapter does not affect the authority of the

- 1 <u>commissioners court or governing body to adopt an order or</u>
- 2 ordinance under other law.
- 3 Sec. 242.056. INJUNCTION. The county or municipality, in a
- 4 suit brought by the appropriate attorney representing the county or
- 5 municipality in the district court, is entitled to appropriate
- 6 injunctive relief to prevent the violation or threatened violation
- 7 of the entity's order or ordinance adopted under this subchapter
- 8 from continuing or occurring.
- 9 Sec. 242.057. PENALTY; EXCEPTION. (a) A person commits an
- offense if the person violates a restriction or prohibition imposed
- 11 by an order or ordinance adopted under this subchapter. An offense
- 12 under this section is a Class C misdemeanor.
- 13 (b) It is an exception to the application of this section
- 14 that:
- 15 (1) the person is an owner-occupant of a residential
- 16 <u>dwelling that is classified by the Texas Department of Housing and</u>
- 17 Community Affairs as a low-income household;
- 18 (2) the dwelling was constructed before the effective
- 19 date of this subchapter;
- 20 (3) the violation related to a building standard or
- 21 <u>building code for that dwelling; and</u>
- 22 (4) the county or municipality, as appropriate:
- 23 (A) did not make available to the person a grant
- or loan in an amount sufficient to cure the violation; or
- 25 (B) made available to the person a loan that was
- 26 sufficient to cure the violation but that caused the housing
- 27 expenses of the person to exceed 30 percent of the person's net

- 2 SECTION 2. The heading to Chapter 242, Local Government
- 3 Code, is amended to read as follows:
- 4 CHAPTER 242. AUTHORITY OF MUNICIPALITY AND COUNTY TO REGULATE
- 5 SUBDIVISIONS AND PROPERTY DEVELOPMENT [IN AND OUTSIDE
- 6 MUNICIPALITY'S EXTRATERRITORIAL JURISDICTION
- 7 SECTION 3. Chapter 242, Local Government Code, is amended
- 8 by designating Sections 242.001, 242.0015, and 242.002 as
- 9 Subchapter A and adding a heading for Subchapter A to read as
- 10 follows:
- SUBCHAPTER A. AUTHORITY TO REGULATE SUBDIVISIONS IN AND OUTSIDE
- 12 MUNICIPALITY'S EXTRATERRITORIAL JURISDICTION
- SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2007.
