The commissioner shall establish a 5 registry of legal entities engaged in the business of insurance in 6 this state that have a documented history of: 7 (1) refusing to insure or provide coverage to an individual, refusing to continue to insure or provide coverage to 8 an individual, limiting the amount, extent, or kind of coverage 9 available for an individual, or charging an individual a rate that 10 is different from the rate charged to other individuals for the same 11 12 coverage, because of the race or color of the individual; or (2) marketing a kind of insurance or insurance product 13 14 to individuals predominately of the same race or color because of 15 their race or color. Sec. 521.153. SUBMISSION OF INFORMATION TO DEPARTMENT. (a) 16 The commissioner may require a legal entity subject to this 17 subchapter to submit information to the department regarding 18 practices of the entity that reasonably indicate a history of the 19 activities described by Section 521.152. 20 21 (b) The commissioner shall prescribe by rule the manner of submitting information under Subsection (a). 22 Sec. 521.154. PUBLIC INFORMATION. 23 (a) Information 24 submitted to the department under Section 521.153 is public 25 information. (b) The department shall prepare information of public 26 interest describing the registry established under 27 this

2 SECTION 2. The commissioner of insurance shall establish 3 the registry and adopt rules as required by Subchapter D, Chapter 4 521, Insurance Code, as added by this Act, not later than January 1, 5 2008.
