5	SECTION 1. Subchapter A, Chapter 2155, Government Code, is

7	Sec. 2155.006. PROHIBITION ON CERTAIN BIDS AND CONTRACTS.
8	(a) In this section:
9	(1) "Disaster" has the meaning assigned by Section
10	418.004.
11	(2) "Hurricane Katrina" means the hurricane of that
12	name that struck the gulf coast region of the United States in
13	August 2005.
14	(b) A state agency may not accept a bid or award a contract,
15	including a contract for which purchasing authority is delegated to
16	a state agency, that includes proposed financial participation by a
17	person who, during the five-year period preceding the date of the
18	bid or award, has been:
19	(1) convicted of violating a federal law in connection
20	with a contract awarded by the federal government for relief,
21	recovery, or reconstruction efforts as a result of Hurricane Rita,
22	as defined by Section 39.459, Utilities Code, Hurricane Katrina, or
23	any other disaster occurring after September 24, 2005; or
24	(2) assessed a penalty in a federal civil or

1	administrative enforcement action in connection with a contract
2	awarded by the federal government for relief, recovery, or
3	reconstruction efforts as a result of Hurricane Rita, as defined by
4	Section 39.459, Utilities Code, Hurricane Katrina, or any other

6	(c) A bid or award subject to the requirements of this
7	section must include the following statement:
8	"Under Section 2155.006, Government Code, the vendor
9	certifies that the individual or business entity named in this bid
10	or contract is not ineligible to receive the specified contract and
11	acknowledges that this contract may be terminated and payment
12	withheld if this certification is inaccurate."
13	(d) If a state agency determines that an individual or
14	business entity holding a state contract was ineligible to have the
15	bid accepted or contract awarded under Subsection (b), the state
16	agency may immediately terminate the contract without further
17	obligation to the vendor.
18	(e) This section does not create a cause of action to
19	contest a bid or award of a state contract.
20	SECTION 2. Section 2155.077, Government Code, is amended by
21	amending Subsection (b) and adding Subsections (a-1), (d), and (e)
22	to read as follows:
23	(a-1) The commission shall bar a vendor from participating
24	in state contracts that are subject to this subtitle, including
25	contracts for which purchasing authority is delegated to a state
26	agency, if the vendor has been:
27	(1) convicted of violating a federal law in connection

1	with a contract awarded by the federal government for relief,
2	recovery, or reconstruction efforts as a result of Hurricane Rita,
3	as defined by Section 39.459, Utilities Code, Hurricane Katrina, or
4	any other disaster occurring after September 24, 2005; or

6	administrative enforcement action in connection with a contract

11	(b) <u>Except as provided by Subsection (d), the</u> [The]

15	damage to the state's interests.
16	(d) The commission shall bar a vendor from participating in
17	state contracts under Subsection (a-1) for a period of five years
18	from the date the vendor was convicted or the penalty was assessed.

22	(2) "Hurricane Katrina" means the hurricane of that

25	SECTION 3. Subchapter B, Chapter 2261, Government Code, is

27	Sec. 2261.053. PROHIBITION ON CERTAIN BIDS AND CONTRACTS.

10	period preceding the date of the bid or award, has been:
11	(1) convicted of violating a federal law in connection
12	with a contract awarded by the federal government for relief,
13	recovery, or reconstruction efforts as a result of Hurricane Rita,
14	as defined by Section 39.459, Utilities Code, Hurricane Katrina, or
15	any other disaster occurring after September 24, 2005; or
16	(2) assessed a penalty in a federal civil or
17	administrative enforcement action in connection with a contract
18	awarded by the federal government for relief, recovery, or
19	reconstruction efforts as a result of Hurricane Rita, as defined by

9	SECTION 4. The changes in law made by this Act apply only in
10	relation to a state contract for which the request for bids or
11	proposals or other applicable expressions of interest are made

12 public on or after the effective date of this Act.
