| 9 | SUBCHAPTER A. GENERAL PROVISIONS |
| LO | Sec. 1379.001. DEFINITIONS. In this chapter: |
| L1 | (1) "Enrollee" means an individual entitled to |

| L3 | (2) "Life-threatening disease or condition" means a |
| L4 | disease or condition from which the likelihood of death is probable |
| L5 | unless the course of the disease or condition is interrupted. |

| 9 | Sec. 1379.003. APPLICABILITY TO CERTAIN GOVERNMENT |
| LO | PROGRAMS. To the extent allowed by federal law, the state Medicaid |
| L1 | program, and a managed care organization that contracts with the |
| L2 | Health and Human Services Commission to provide health care |
| L3 | services to Medicaid recipients through a managed care plan, shall |
| L4 | provide the benefits required under this chapter to a Medicaid |
| L5 | recipient. |

The commissioner, in accordance with 9 10 Subchapter A, Chapter 36, may adopt rules to implement this 11 chapter. 12 [Sections 1379.006-1379.050 reserved for expansion] SUBCHAPTER B. COVERAGE FOR ROUTINE PATIENT CARE COSTS 13 Sec. 1379.051. ROUTINE PATIENT CARE COSTS. For purposes of 14 15 this chapter, routine patient care costs means the costs of any medically necessary health care service for which benefits are 16 17 provided under a health care plan, without regard to whether the enrollee is participating in a clinical trial. Routine patient 18 19 care costs do not include: (1) the cost of an investigational new drug or device 20 21 that is not approved for any indication by the United States Food and Drug Administration, including a drug or device that is the 22 subject of the clinical trial; 23

with widely accepted and established standards of care for a 1 2 particular diagnosis; or 3 (4) a cost associated with managing a clinical trial. Sec. 1379.052. COVERAGE REQUIRED. A health benefit plan 4 5 issuer shall provide benefits for routine patient care costs to an 6 enrollee in connection with a phase I, phase II, phase III, or phase 7 IV clinical trial if the clinical trial is conducted in relation to the prevention, detection, or treatment of a life-threatening 8 9 disease or condition and is approved by: 10 (1) the National Institutes of Health; 11 (2) the United States Food and Drug Administration; 12 (3) the United States Department of Defense; the United States Department of Veterans Affairs; 13 (4)14 or 15 (5) another entity that supports research in clinical trials and that meets the grant standards of the National 16 17 Institutes of Health.

Sec. 1379.053. RESEARCH INSTITUTION. (a) A health benefit plan issuer is not required to reimburse the research institution conducting the clinical trial for the cost of routine patient care provided through the research institution unless the research institution, and each health care professional providing routine patient care through the research institution, agrees to accept reimbursement under the health benefit plan, at the rates that are established under the plan, as payment in full for the routine patient care provided in connection with the clinical trial.

(b) A health benefit plan issuer is not required to provide

- 3 for by the research institution conducting the clinical trial.
- 4 Sec. 1379.054. LIMITATIONS ON COVERAGE. (a)
- 5 Notwithstanding Section 1379.053, this chapter does not require a
- 6 health benefit plan issuer to provide benefits for routine patient
- 7 care services provided outside of the plan's health care provider
- 8 network unless out-of-network benefits are otherwise provided
- 9 under the plan.
- 10 (b) This chapter does not require a health benefit plan
- 11 <u>issuer to provide benefits for health care services provided</u>
- 12 outside this state unless the health benefit plan otherwise
- 13 provides benefits for health care services provided outside this
- 14 state.
- 15 Sec. 1379.055. DEDUCTIBLE, COINSURANCE, AND COPAYMENT
- 16 REQUIREMENTS. The benefits required under this chapter may be made
- 17 subject to a deductible, coinsurance, or copayment requirement
- 18 comparable to other deductible, coinsurance, or copayment
- 19 requirements applicable under the health benefit plan.
- SECTION 2. Section 1506.151, Insurance Code, is amended by
- 21 adding Subsection (d) to read as follows:
- (d) Coverage provided by the pool is subject to Chapter
- 23 1379.
- SECTION 3. This Act applies only to a health benefit plan
- 25 that is delivered, issued for delivery, or renewed on or after
- 26 January 1, 2008. A health benefit plan that is delivered, issued
- for delivery, or renewed before January 1, 2008, is governed by the

- 1 law as it existed immediately before the effective date of this Act,
- 2 and that law is continued in effect for that purpose.
- 3 SECTION 4. This Act takes effect September 1, 2007.
