4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle F, Title 5, Agriculture Code, is
6	amended by adding Chapter 122 to read as follows:
7	CHAPTER 122. SALE OF DESERT PLANTS
8	Sec. 122.001. DEFINITION. In this chapter, "desert plant"
9	means a plant that belongs to any of the following genera:
10	(1) Agave;
11	(2) Ariocarpus;
12	(3) Echinocactus;
13	(4) Echinocereus;
14	(5) Ferocactus;
15	(6) Fouquieria;
16	(7) Mammillaria; or
17	(8) Yucca.
18	Sec. 122.002. ADMINISTRATION. The department shall
19	administer this chapter and adopt rules necessary for its
20	enforcement.
21	Sec. 122.003. REQUIREMENTS FOR SALE OR TRANSPORT. Unless a
22	desert plant is marked as provided by Section 122.005, a person may
23	<u>not:</u>
24	(1) sell the plant;

1	(2) offer the plant for sale; or
2	(3) transport the plant out of this state.
3	Sec. 122.004. REGISTRATION REQUIRED. (a) A person who
4	grows or harvests a desert plant for sale must register with the
5	department.
6	(b) A person described by Subsection (a) must include the
7	following with the registration information provided to the
8	department:
9	(1) a statement that the desert plants provided for
10	sale will be harvested from the person's property; or
11	(2) written documentation from the owner of the
12	property from which the desert plants will be harvested granting
13	the person selling or offering to sell the plants the authority to
14	harvest the plants.
15	Sec. 122.005. MARKING OF DESERT PLANTS. (a) A person
16	subject to Section 122.004 shall mark each desert plant harvested
17	for sale under this chapter with an identification mark prescribed
18	by the department.
19	(b) The department may charge a fee for providing an
20	identification mark under this section.
21	Sec. 122.006. STOP-SALE ORDER. In enforcing this chapter,
22	the department may issue and enforce a written or printed order to
23	stop the sale of a desert plant or a shipment of desert plants that
24	is not marked as provided by Section 122.005. If an order is
25	issued, a person may not sell the plant or shipment until it has
26	been properly marked.
27	Sec. 122.007. AUTHORITY TO SEIZE PLANTS. In enforcing this

1	chapter, the department with or without process may seize a desert
2	plant or a shipment of desert plants that is:
3	(1) not marked as provided by Section 122.005; and
4	(2) intended to be transported out of this state.
5	Sec. 122.008. PENALTY. (a) A person commits an offense if
6	the person advertises, sells, or offers for sale a desert plant or a
7	shipment of desert plants that is not clearly and distinctly marked
8	as provided by Section 122.005.
9	(b) An offense under this section is punishable by:
10	(1) a fine not to exceed \$1,000;
11	(2) imprisonment for a term not to exceed 180 days; or
12	(3) both fine and imprisonment under this subsection.
13	SECTION 2. Section 12.020, Agriculture Code, is amended by
14	amending Subsections (a) and (b) and adding Subsection (c-1) to
15	read as follows:
16	(a) If a person violates a provision of this code described
17	by Subsection (c) <u>or (c-1)</u> [ <del>of this section</del> ] or a rule or order
18	adopted by the department under a provision of this code described
19	by Subsection (c) <u>or (c-1)</u> [ <del>of this section</del> ], the department may
20	assess an administrative penalty against the person as provided by
21	this section.
22	(b) The penalty for each violation may be in an amount not to
23	exceed the maximum provided by Subsection (c) <u>or (c-1)</u> [ <del>of this</del>
24	section]. Each day a violation continues or occurs may be
25	considered a separate violation for purposes of penalty
26	assessments.
27	(c-1) In addition to provisions described by Subsection

(c), Chapter 122 is subject to this section and the applicable 1 2 penalty amount is \$500. 3 SECTION 3. (a) Not later than December 1, 2007, the 4 Department of Agriculture shall adopt rules to administer Chapter 5 122, Agriculture Code, as added by this Act. (b) Chapter 122, Agriculture Code, as added by this Act, 6 applies only to a sale, an offer for sale, or the transportation of 7 a desert plant on or after January 1, 2008. 8
