## A BILL TO BE ENTITLED AN ACT 1 2 relating to the registration of voters at a polling place and 3 related procedures. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Chapter 62, Election Code, is amended by adding Section 62.0015 to read as follows: 6 Sec. 62.0015. VOTER REGISTRARS MUST BE PRESENT. Two voter 7 registrars must be present at each polling place while the polls are 8 9 open. SECTION 2. Chapter 63, Election Code, is amended by adding 10 11 Section 63.010 to read as follows: 12 Sec. 63.010. REGISTRATION AT POLLING PLACE; VOTING 13 PROCEDURES. (a) This section applies to the conduct of voting and 14 to the registration of voters notwithstanding and in addition to other applicable provisions of this code. 15 16 (b) A person who would be eligible to vote in an election under Section 11.001, but for the requirement to be a registered 17 18 voter, shall be accepted for voting in the precinct of the person's residence if, on the day the person offers to vote, the person: 19 (1) submits a voter registration application that 20 21 complies with Section 13.002 to a voter registrar at the polling place; and 22 23 (2) presents as proof of identification: 24 (A) a Texas driver's license, including a

temporary license or instruction permit, or personal 1 2 identification card issued to the person by the Department of Public Safety that states the person's current address on the day 3 the person seeks to vote; or 4 5 (B) a utility bill addressed to the person dated 6 not earlier than the 30th day before the date the person seeks to 7 vote, and: 8 (i) a Texas driver's license, including a temporary license or instruction permit, or personal 9 identification card issued to the person by the Department of 10 Public Safety, regardless of whether the address stated on the 11 12 license or card is current on the day the person seeks to vote; (ii) a United States passport issued to the 13 14 person; or 15 (iii) a United States military identification card that contains the person's photograph. 16 17 (c) Persons voting under this section shall be processed separately at the polling place from persons who are voting under 18 19 regular procedures. The secretary of state shall adopt rules to ensure the 20 (d) 21 accountability of election officers and to fairly implement this 22 section. SECTION 3. The secretary of state shall adopt rules as 23 24 required by Section 63.010, Election Code, as added by this Act, not later than February 1, 2008. 25 SECTION 4. The changes in law made by this Act apply only to 26 an election for which early voting by personal appearance begins on 27

2 SECTION 5. This Act takes effect September 1, 2007.
