- 17 SECTION 3. Subsection (c), Section 481.152, Health and

- the holder of the registration, the officer may seize and summarily

- 4 SECTION 5. Subsection (b), Section 481.153, Health and
- 5 Safety Code, is amended to read as follows:
- 6 (b) If an item of controlled substance property is seized
- 7 and forfeited under this section, a court may order the disposition
- 8 of the property under Section 481.159, or the department or a peace
- 9 officer may <u>summarily</u> destroy the property under the rules of the
- 10 department.
- 11 SECTION 6. Subsection (a), Section 481.154, Health and
- 12 Safety Code, is amended to read as follows:
- 13 (a) The director may adopt reasonable rules and procedures,
- 14 not inconsistent with the provisions of this chapter, concerning:
- 15 (1) summary forfeiture and summary destruction of
- 16 controlled substance property or plants;
- 17 (2) establishment and operation of a secure storage
- 18 area;
- 19 (3) delegation by a law enforcement agency head of the
- 20 authority to access a secure storage area; and
- 21 (4) minimum tolerance for and the circumstances of
- 22 loss or destruction during an investigation.
- 23 SECTION 7. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
