S.B. No. 793

A BILL TO BE ENTITLED

AN ACT

relating to an additional filing fee for civil cases filed in Bexar County.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subchapter H, Chapter 51, Government Code, is amended by adding Section 51.706 to read as follows:

Sec. 51.706. ADDITIONAL FILING FEE FOR CIVIL CASES IN BEXAR COUNTY. (a) This section applies only to district courts, probate courts, county courts at law, and justice courts in Bexar County.

(b) Except as otherwise provided by this section and in addition to all other fees authorized or required by other law, the clerk of a court shall collect a filing fee of not more than \$15 in each civil case filed in the court to be used for the construction, renovation, or improvement of the facilities that house the Bexar County civil and criminal courts. The fee does not apply to a suit affecting the parent-child relationship for the adoption of a child or the termination of parental rights.

(c) Court fees due under this section shall be collected in the same manner as other fees, fines, or costs are collected in the case.

(d) The clerk shall send the fees collected under this section to the county treasurer or to any other official who discharges the duties commonly assigned to the county treasurer at least as frequently as monthly. The treasurer or other official

1 shall deposit the fees in a special account in the county treasury
2 dedicated to the construction, renovation, or improvement of the
3 facilities that house the courts collecting the fee.

4 (e) This section applies only to fees for a 12-month period
5 beginning October 1, if the commissioners court:

6 (1) adopts a resolution authorizing a fee of not more
7 than \$15;

8 (2) adopts a resolution requiring the county to spend
9 one dollar for the construction, renovation, or improvement of the
10 court facilities for each dollar spent from the special account
11 dedicated to that purpose; and

12 (3) files the resolutions with the county treasurer or
13 with any other official who discharges the duties commonly assigned
14 to the county treasurer not later than September 1 immediately
15 preceding the first 12-month period during which the fees are to be
16 collected.

17 (f) A resolution adopted under Subsection (e) continues
18 from year to year until October 1, 2020, allowing the county to
19 collect fees under the terms of this section until the resolution is
20 rescinded.

21 (g) The commissioners court may rescind a resolution
22 adopted under Subsection (e) by adopting a resolution rescinding
23 the resolution and submitting the rescission resolution to the
24 county treasurer or to any other official who discharges the duties
25 commonly assigned to the county treasurer not later than September
26 1 preceding the beginning of the first day of the county fiscal
27 year. The commissioners court may adopt an additional resolution

1 in the manner provided by Subsection (e) after rescinding a
2 previous resolution under that subsection.

3 (h) A fee established under a particular resolution is
4 abolished on the earlier of:

5 (1) the date a resolution adopted under Subsection (e)
6 is rescinded as provided by Subsection (g); or

7 (2) October 1, 2020.

8 (i) The county may make the required expenditure described
9 by Subsection (e)(2) at any time, regardless of when the
10 expenditure from the special account occurs.

11 SECTION 2. Section 101.061, Government Code, is amended to

3 SECTION 4. This Act takes effect immediately if it receives
4 a vote of two-thirds of all the members elected to each house, as

7 Act takes effect September 1, 2007.
