5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subsections (a), (b), (c), (e), and (h), Section
7	264.502, Family Code, are amended to read as follows:
8	(a) The child fatality review team committee is composed of:
9	(1) a person appointed by and representing the state
10	registrar [for the bureau] of vital statistics;
11	(2) a person appointed by and representing the
12	<u>commissioner [director of protective services for families and</u>
13	<pre>children] of the department;</pre>
14	(3) a person appointed by and representing the <u>Title V</u>
15	director of the [bureau of epidemiology of the Texas] Department of
16	<u>State</u> Health <u>Services</u> ; and
17	(4) individuals selected under Subsection (b).
18	(b) The members of the committee who serve under Subsections
19	(a)(1) through (3) shall select the following additional committee
20	members:
21	(1) a criminal prosecutor involved in prosecuting
22	crimes against children;
23	<pre>(2) a sheriff;</pre>
24	(3) a justice of the peace;

No. 802 1 (4) a medical examiner; 2 (5) a police chief; 3 a pediatrician experienced in diagnosing (6) and treating child abuse and neglect; 4 5 (7) a child educator; 6 (8) a child mental health provider; 7 a public health professional; (9) a child protective services specialist; 8 (10)9 (11)a sudden infant death syndrome family service 10 provider; 11 (12)a neonatologist; (13) a child advocate; 12 a chief juvenile probation officer; [and] 13 (14)a child abuse prevention specialist; 14 (15) 15 (16) a representative of the Department of Public 16 Safety; and 17 (17) a representative of the Texas Department of 18 Transportation. Members of the committee selected under Subsection (b) 19 (c) 20 serve three-year [two-year] terms with the terms of five or six members, as appropriate, expiring [that expire on] February 1 [of] 21 22 each [even=numbered] year. An appointment to a vacancy on the committee shall be 23 (e) made in the same manner as the original appointment. A member is 24 25 eligible for reappointment. (h) A member of the committee is not 26 entitled to 27 compensation for serving on the committee but is entitled to

reimbursement for the member's travel expenses as provided in the 1 2 General Appropriations Act. Reimbursement under this subsection for a person serving on the committee under Subsection (a)(2) 3 [(a)(1) or (3)] shall be paid from funds appropriated to the 4 department [Texas Department of Health]. Reimbursement for other 5 persons serving on the committee shall be paid from funds 6 7 appropriated to the Department of State Health Services [department]. 8 Subsections (c), (d), and (f), Section 264.503, 9 SECTION 2. 10 Family Code, are amended to read as follows: (c) The department shall work cooperatively with: 11 the Department of State Health Services [recognize 12 (1)the creation and participation of review teams]; [and] 13 (2) [work cooperatively with] the committee; and 14 15 (3) [with] individual child fatality review teams. 16 (d) The Department of State Health Services shall: 17 recognize the creation and participation of review (1)18 teams; (2) promote and coordinate training to assist the 19 review teams in carrying out their duties; 20 21 (3) [(2)] assist the committee in developing model 22 protocols for: the reporting and investigating of child 23 (A) for law enforcement agencies, child protective 24 fatalities 25 services, justices of the peace and medical examiners, and other professionals involved in the investigations of child deaths; 26 (B) the collection of data regarding child 27

(C) the operation of the review teams;

3 (4) [(3)] develop and implement procedures necessary
4 for the operation of the committee; and

5 <u>(5)</u> [(4)] promote education of the public regarding 6 the incidence and causes of child deaths, the public role in 7 preventing child deaths, and specific steps the public can 8 undertake to prevent child deaths.

9 (f) The committee shall issue a report for each preventable 10 child death. The report must include findings related to the child's death, recommendations on how to prevent similar deaths, 11 and details surrounding the department's involvement with the child 12 prior to the child's death. Not later than April [December] 1 of 13 each year, the committee shall publish a compilation of the reports 14 15 published under this subsection during the year, submit a copy of 16 the compilation to the governor, lieutenant governor, speaker of the house of representatives, and department, and make the 17 18 compilation available to the public. Not later than October [June] 1 of each year, the department shall submit a written response on 19 20 the compilation from the previous year to the committee, governor, lieutenant governor, and speaker of the house of representatives 21 22 describing which of the committee's recommendations regarding the operation of the child protective services system the department 23 will implement and the methods of implementation. 24

25 SECTION 3. (a) The child fatality review team committee 26 member serving under Subdivision (3), Subsection (a), Section 27 264.502, Family Code, immediately before the effective date of this

Act shall continue to serve as a committee member on and after that date until the date a new member is appointed by the Title V director of the Department of State Health Services.

The terms of the members of the child fatality review 4 (b) 5 team committee appointed under Subsection (b), Section 264.502, 6 Family Code, and serving immediately before the effective date of 7 this Act expire February 1, 2008. Not later than February 1, 2008, the committee members appointed under Subdivisions (1), (2), and 8 9 (3), Subsection (a), Section 264.502, Family Code, as amended by this Act, shall appoint committee members under Subsection (b), 10 11 Section 264.502, Family Code, as amended by this Act.

12 (c) The initial terms of the members appointed under 13 Subsection (b) of this section shall be determined by drawing lots 14 as follows:

15 (1) five members shall serve terms expiring February 16 1,2009;

17 (2) six members shall serve terms expiring February 1,
18 2010; and

19 (3) six members shall serve terms expiring February 1,20 2011.

21 SECTION 4. This Act takes effect September 1, 2007.
