9	part of a building, including a day-care center, preschool, or
10	kindergarten classroom, that is visited regularly by the same
11	child, six years of age or younger, at least two days in any

14	(B) 60 hours each year.
15	(14) "Lead hazard" means an item, surface coating, or
16	environmental media that contains or is contaminated with lead and,
17	when ingested or inhaled, may cause exposures that contribute to
18	blood lead levels in children, including:
19	(A) an accessible painted surface or coating;
20	(B) an article for residential or consumer use;
21	(C) accessible soil and dust, including attic
22	dust; and
23	(D) food, water, or remedies.
24	(15) "Certified lead risk assessor" means a person who

- 5 investigation performed by a certified lead risk assessor of the

- 7 has a confirmed blood lead level warranting such an investigation,

- 9 Control and Prevention of the United States Public Health Service.

- 12 Sec. 88.007. DEPARTMENT RULES FOR FOLLOW-UP CARE;
- 13 COORDINATION OF CARE. (a) The department may adopt rules
- 14 establishing standards for follow-up care provided to children with
- 15 a confirmed blood lead level of concern.
- (b) Rules adopted under this section must meet any federal
- 17 requirements for coordinated follow-up care for children with
- confirmed blood lead levels of concern and may include, in a manner
- 19 consistent with current federal guidelines:
- 20 (1) an environmental lead investigation of all or
- 21 parts of a child's home environment, child-care facility, or
- 22 child-occupied facility that may be a source of a lead hazard
- 23 causing or contributing to the child's lead exposure; and
- 24 (2) guidance to parents, guardians, and consulting

- Sec. 88.008. ENVIRONMENTAL LEAD INVESTIGATIONS. (a) On

- 1 receiving a report of a child with a confirmed blood lead level

- 4 investigation of:
- 5 (1) the home environment in which the child resides,
- 6 if the department or the department's authorized agent obtains the
- 7 written consent of an adult occupant;
- 8 (2) any child-care facility with which the child has
- 9 regular contact and that may be contributing to the child's blood
- 10 lead level, if the department or the department's authorized agent
- obtains the written consent of the owner, operator, or principal of
- 12 the facility; and
- 13 (3) any child-occupied facility with which the child
- 14 has regular contact and that may be contributing to the child's
- 15 blood lead level, if the department or the department's authorized
- 16 agent obtains the written consent of:
- 17 <u>(A) the owner, operator, or principal of</u> the
- 18 facility; or
- 19 (B) an adult occupant of the facility if the
- 20 facility is subject to a lease agreement.
- 21 (b) Notwithstanding the consent requirements under
- 22 Subsection (a), consent for an investigation is not required to be
- 23 in writing for an investigation related to a report of a child with
- 24 a blood lead level of 45 micrograms per deciliter or more if a good

- 26 consent under Subsection (a) has been unsuccessful.
