A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the La Joya Special Utility District and its board of
- 3 directors as successor in interest to the La Joya Water Supply
- 4 Corporation.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The La Joya Special Utility District, created by
- 7 Article 2, Chapter 1057, Acts of the 79th Legislature, Regular
- 8 Session, 2005 (enacting Chapter 7201, Special District Local Laws
- 9 Code), was enjoined by order of the District Court of Hidalgo
- 10 County, Texas, 398th Judicial District, Cause No. C-848-05-I, dated
- 11 October 3, 2005, from acting as the successor in interest to the La
- 12 Joya Water Supply Corporation until the receivership of the
- 13 corporation ordered by the court is terminated or the court
- 14 otherwise modifies its order. This Act amends Chapter 7201,
- 15 Special District Local Laws Code, in recognition of the court's
- 16 order. The legislature anticipates that the court will find that
- 17 the affairs of the corporation have been stabilized under the
- 18 receiver so that the district may succeed the corporation in
- 19 accordance with the court's orders, this Act, and the intent of the
- 20 79th Legislature.
- 21 SECTION 2. Section 7201.001, Special District Local Laws
- 22 Code, is amended by adding Subdivision (2-a) to read as follows:
- 23 (2-a) "Director" means a member of the board.
- SECTION 3. Section 7201.002(c), Special District Local Laws

- 1 Code, is amended to read as follows:
- 2 (c) The [On the effective date of the Act enacting this
- 3 chapter, the] corporation shall be dissolved and succeeded without
- 4 interruption by the district as provided by Subchapter Al.
- 5 SECTION 4. Sections 7201.005(a) and (b), Special District
- 6 Local Laws Code, are amended to read as follows:
- 7 (a) The [boundaries of the corporation and initial
- 8 boundaries of the] district is composed of the territory described
- 9 by Section 12 of the Act enacted by the 80th Legislature, Regular
- 10 Session, 2007, amending this subsection [are coextensive with the
- 11 service areas covered by Certificates of Convenience and Necessity
- 12 Nos. 10559 and 20785, as recorded on the Texas Commission on
- 13 Environmental Quality maps associated with those certificates.
- 14 Those maps are incorporated in this section by reference].
- 15 (b) The boundaries and field notes contained in Section 12
- of the Act enacted by the 80th Legislature, Regular Session, 2007,
- amending this subsection form a closure. A mistake made in the field
- 18 notes or in copying the field notes in the legislative process
- 19 [preparation, copying, or filing of the maps described by
- 20 Subsection (a) and on file with the Texas Commission on
- 21 Environmental Quality does not affect:
- 22 (1) the organization, existence, or validity of the
- 23 district;
- 24 (2) the right of the district to issue bonds; or
- 25 (3) the legality or operation of the district.
- SECTION 5. Section 7201.021, Special District Local Laws
- 27 Code, is amended by amending Subsections (a), (b), and (d) and

- 2 (a) After the temporary directors appointed and approved
 3 under Section 7201.051 have completed the training required under
 4 Section 7201.0512, the receiver for the corporation [On the
 5 effective date of the Act enacting this chapter, the corporation]
 6 shall transfer the assets, debts, and contractual rights and
 7 obligations of the corporation to the district and provide notices
 8 and make recordings of the transfer required by the Water Code and
- 10 (b) In accordance with the orders of the receivership court

 11 and not [Not] later than the 30th day after the date of the transfer

 12 under Subsection (a), the receiver for [board of directors of] the

 13 corporation shall commence dissolution proceedings of the

 14 corporation.
- (d) The <u>receiver for [board of directors of]</u> the corporation shall notify the Texas Commission on Environmental Quality of the dissolution of the corporation and <u>its succession in interest by</u> [the creation of] the district <u>in order [to replace it]</u> to effect the transfer of Certificates of Convenience and Necessity Nos. 10559 and 20785 to the district.
- 21 <u>(f) After the Texas Commission on Environmental Quality</u>
 22 <u>takes the action required by Subsection (e), the court shall</u>
 23 <u>terminate the receivership.</u>

- 9 program as necessary to meet district needs.
- SECTION 9. Section 7201.052, Special District Local Laws

- 12 Section 141.001, Election Code.
- 13 (c) A candidate for one of the director positions
- 14 representing a municipality listed in Subsection (a)(1), (2), (3),
- 15 <u>or (4):</u>
- 16 (1) must reside in the municipality the candidate
- 17 seeks to represent; and
- 18 (2) must be eligible to hold office under Section
- 19 141.001, Election Code.
- 20 <u>(d)</u> It is the policy of the district that the directors
- 21 shall represent and reside in as broad a cross-section of the
- 22 geographic area of the district as possible.
- 23 (e) $(\frac{d}{d})$ The district shall fill a vacancy on the board in
- 24 accordance with Section 49.105, Water Code.
- 25 <u>(f)</u> [(e)] Except for the temporary directors <u>appointed</u>
- 26 [listed] under Section 7201.051, directors serve staggered terms
- of three years.

- 3 <u>(c) A director who is elected to serve a subsequent term</u>
- 4 shall fulfill the education requirements specified by district
- 5 bylaws.
- 6 SECTION 11. Section 7201.206, Special District Local Laws
- 7 Code, is amended to read as follows:
- 8 Sec. 7201.206. RATES AND FEES FOR SERVICE. (a) The
- 9 district, in connection with water or sewer retail public utility
- 10 services, shall establish lifeline, senior citizen, or minimum
- 11 consumption level rates for services. The rate impact of such
- 12 services shall be allocated on the basis of costs of services to
- 13 achieve conservation principles, while securing necessary reserves
- 14 for the payment of operating expenses, sinking funds, principal,
- 15 interest, and debt coverage factors, and any other objective
- 16 established by the district's annual budget.
- 17 (b) Chapter 395, Local Government Code, does not apply to
- 18 any fee, charge, or assessment that, before the corporation's
- 19 dissolution and conversion to a district, is adopted by the
- 20 receiver for the purpose of generating revenue to fund or recoup the
- 21 costs of capital improvements or facility expansions necessitated
- 22 by and attributable to new developments.
- (c) Notwithstanding Subsection (b), beginning on December
- 31, 2011, the district may not impose any fee, charge, or assessment
- 25 that, before the corporation's dissolution and conversion to a
- 26 district, is adopted by the receiver for the purpose of generating
- 27 revenue to fund or recoup the costs of capital improvements or

- 1 facility expansions necessitated by and attributable to new
- 2 developments unless the district readopts the fee, charge, or
- 3 assessment or adopts a new fee, charge, or assessment in accordance

- 8 SECTION 13. (a) Temporary directors of the board of the La
- 9 Joya Special Utility District who represent the city of Mission or

- 11 are elected under Section 7201.052(g), Special District Local Laws
- 12 Code, as amended by this Act, and qualify under Section 49.055,
- 13 Water Code.
- 14 (b) Temporary directors who represent the city of Palmview
- or serve in at-large position 2 serve terms that expire when
- directors are elected under Section 7201.052(h), Special District
- 17 Local Laws Code, as amended by this Act, and qualify under Section
- 18 49.055, Water Code.
- 19 (c) Temporary directors who represent the city of Penitas or
- 20 the city of Sullivan City or serve in at-large position 3 serve
- 21 terms that expire when directors are elected under Section
- 7201.052(i), Special District Local Laws Code, as added by this
- 23 Act, and qualify under Section 49.055, Water Code.
- SECTION 14. Except as otherwise provided by Chapter 7201,
- 25 Special District Local Laws Code, as amended by this Act, the La
- 26 Joya Special Utility District is subject to:
- 27 (1) any judicial or administrative order imposing an

- 1 injunction against the La Joya Water Supply Corporation that is in
- 2 effect on the date of the transfer under Section 7201.021, Special
- 3 District Local Laws Code, as amended by this Act; or
- 4 (2) any judicial or administrative order imposing
- 5 liability for monetary damages or a civil or administrative penalty
- 6 against the La Joya Water Supply Corporation that is unsatisfied on
- 7 the date of the transfer under Section 7201.021, Special District
- 8 Local Laws Code, as amended by this Act.
- 9 SECTION 15. (a) The legal notice of the intention to
- 10 introduce this Act, setting forth the general substance of this
- 11 Act, has been published as provided by law, and the notice and a
- 12 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 15 Government Code.
- 16 (b) The governor has submitted the notice and Act to the
- 17 Texas Commission on Environmental Quality.
- 18 (c) The Texas Commission on Environmental Quality has filed
- 19 its recommendations relating to this Act with the governor,
- 20 lieutenant governor, and speaker of the house of representatives
- 21 within the required time.
- 22 (d) All requirements of the constitution and laws of this
- 23 state and the rules and procedures of the legislature with respect
- to the notice, introduction, and passage of this Act are fulfilled
- and accomplished.
- 26 SECTION 16. This Act takes effect September 1, 2009.
