- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4
- SECTION 1. Section 311.008(b), Tax Code, is amended to read 5 as follows: 6
- 7 (b) A municipality or county may exercise any power
- necessary and convenient to carry out this chapter, including the 8
- 9 power to:
- (1) cause project plans to be prepared, approve and 10
- 11 implement the plans, and otherwise achieve the purposes of the
- 12 plan;
- 13 (2) acquire real property by purchase, condemnation,
- 14 or other means to implement project plans and sell that property on
- the terms and conditions and in the manner it considers advisable; 15
- enter into agreements, including agreements with 16
- bondholders, determined by the governing body of the municipality 17
- 18 or county to be necessary or convenient to implement project plans
- and achieve their purposes, which agreements may include 19
- conditions, restrictions, or covenants that run with the land or 20
- 21 that by other means regulate or restrict the use of land; and

- 15 SECTION 2. Section 311.0085, Tax Code, is amended to read as

- 17 Sec. 311.0085. DEDICATION OF REVENUE TO SCHOOL DISTRICT FOR
- 18 EDUCATIONAL FACILITIES [POWER OF CERTAIN MUNICIPALITIES]. (a)
- 19 [This section applies only to a municipality that has:
- 20 [(1) territory in three counties; and
- 21 [(2) a population of less than 120,000.
- [ $\frac{\text{(b)}}{\text{)}}$ ] In this section, "educational facility" has the
- 23 meaning assigned by Section 311.008.
- (b)  $[\frac{(c)}{(c)}]$  In addition to exercising the powers described by
- 25 Section 311.008, a municipality may enter into a new agreement, or
- amend an existing agreement, with a school district that is located
- 27 in whole or in part in a reinvestment zone created by the

- 1 municipality to dedicate revenue from the tax increment fund to the
- 2 school district for acquiring, constructing, or reconstructing an
- 3 educational facility located in or outside of the zone.
- 4 SECTION 3. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2007.
