- 4 (d-1) If one or more directors are subsequently appointed to
  5 the board, the directors other than the subsequent appointees shall
  6 determine the length of the appointees' terms, to comply with
  7 Subsection (d).

- SECTION 2. The change in law made by this Act does not affect the term of a member of the board of directors serving on the effective date of this Act. Members appointed to fill vacancies occurring on or after the effective date of this Act must be appointed in accordance with Section 366.251, Transportation Code, as amended by this Act.
- SECTION 3. The change in law made by this Act does not prohibit a person who is a member of a regional tollway authority board of directors before the effective date of this Act from being appointed as a member of the board under the new composition of the board of a regional tollway authority if the person has the qualifications required for the position under Section 366.251, Transportation Code, as amended by this Act.
- 21 SECTION 4. This Act takes effect September 1, 2007.
