- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Chapter 33, Health and Safety
- 6 Code, is amended to read as follows:
- 7 CHAPTER 33. PHENYLKETONURIA, OTHER HERITABLE DISEASES,
- 8 HYPOTHYROIDISM, AND CERTAIN OTHER DISORDERS OR TRAITS
- 9 SECTION 2. Subsections (a) and (c), Section 33.002, Health
- and Safety Code, are amended to read as follows:
- 11 (a) The department shall carry out a program to combat
- 12 morbidity, including mental retardation, and mortality in persons
- 13 who have phenylketonuria, other heritable diseases, other
- disorders for which screening is required by the department, sickle
- 15 cell trait, or hypothyroidism.
- 16 (c) The department shall establish and maintain a
- 17 laboratory to:
- 18 (1) conduct experiments, projects, and other
- 19 activities necessary to develop screening or diagnostic tests for
- 20 the early detection of phenylketonuria, other heritable diseases,
- 21 other disorders for which screening is required by the department,
- 22 sickle cell trait, and hypothyroidism;
- 23 (2) develop ways and means or discover methods to be
- used to prevent or treat phenylketonuria, other heritable diseases,

- other disorders for which screening is required by the department,
- 2 <u>sickle cell trait</u>, and hypothyroidism; and
- 3 (3) serve other purposes considered necessary by the
- 4 department to carry out the program.
- 5 SECTION 3. Subsection (a), Section 33.011, Health and
- 6 Safety Code, is amended to read as follows:
- 7 (a) The physician attending a newborn child or the person
- 8 attending the delivery of a newborn child that is not attended by a
- 9 physician shall subject the child to screening tests approved by
- 10 the department for phenylketonuria, other heritable diseases,
- 11 hypothyroidism, sickle cell trait, and other disorders for which
- 12 screening is required by the department.
- SECTION 4. Subsection (a), Section 33.014, Health and
- 14 Safety Code, is amended to read as follows:
- 15 (a) If, because of an analysis of a specimen submitted under
- 16 Section 33.011, the department reasonably suspects that a newborn
- 17 child may have phenylketonuria, another heritable disease,
- 18 hypothyroidism, sickle cell trait, or another disorder for which
- 19 the screening tests are required, the department shall notify the
- 20 person who submits the specimen that the results are abnormal and
- 21 provide the test results to that person. The department may notify
- one or more of the following that the results of the analysis are
- 23 abnormal and recommend further testing when necessary:
- 24 (1) the physician attending the newborn child or the
- 25 physician's designee;
- 26 (2) the person attending the delivery of the newborn
- 27 child that was not attended by a physician;

- 1 (3) the parents of the newborn child;
- 2 (4) the health authority of the jurisdiction in which
- 3 the newborn child was born or in which the child resides, if known;
- 4 or
- 5 (5) physicians who are cooperating pediatric
- 6 specialists for the program.
- 7 SECTION 5. Subsection (a), Section 33.031, Health and
- 8 Safety Code, is amended to read as follows:
- 9 (a) All newborn children and other individuals under 21
- 10 years of age who have been screened, have been found to be
- 11 presumptively positive through the newborn screening program for
- 12 phenylketonuria, other heritable diseases, hypothyroidism, sickle
- 13 cell trait, or another disorder for which the screening tests are
- 14 required, and may be financially eligible may be referred to the
- department's services program for children with special health care
- 16 needs.
- SECTION 6. Subsection (a), Section 33.032, Health and
- 18 Safety Code, is amended to read as follows:
- 19 (a) Within the limits of funds available for this purpose
- 20 and in cooperation with the individual's physician, the department
- 21 may provide services directly or through approved providers to
- 22 individuals of any age who meet the eligibility criteria specified
- 23 by board rules on the confirmation of a positive test for
- 24 phenylketonuria, other heritable diseases, hypothyroidism, sickle
- 25 <u>cell trait,</u> or another disorder for which the screening tests are
- 26 required.
- 27 SECTION 7. As soon as practicable after the effective date

- 1 of this Act, the Department of State Health Services shall
- 2 implement the changes in law made by this Act to the newborn
- 3 screening program under Chapter 33, Health and Safety Code.
- 4 SECTION 8. This Act takes effect September 1, 2007.
