A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to areas of an airport where weapons are prohibited;
- 3 providing a penalty.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 46.03, Penal Code, is amended to read as
- 6 follows:
- 7 Sec. 46.03. PLACES WEAPONS PROHIBITED. (a) A person
- 8 commits an offense if the person intentionally, knowingly, or
- 9 recklessly possesses or goes with a firearm, illegal knife, club,
- or prohibited weapon listed in Section 46.05(a):
- 11 (1) on the physical premises of a school or
- 12 educational institution, any grounds or building on which an
- 13 activity sponsored by a school or educational institution is being
- 14 conducted, or a passenger transportation vehicle of a school or
- 15 educational institution, whether the school or educational
- 16 institution is public or private, unless pursuant to written
- 17 regulations or written authorization of the institution;
- 18 (2) on the premises of a polling place on the day of an
- 19 election or while early voting is in progress;
- 20 (3) on the premises of any government court or offices
- 21 utilized by the court, unless pursuant to written regulations or
- 22 written authorization of the court;
- 23 (4) on the premises of a racetrack;
- 24 (5) in or into a secured or restricted area of an

- 1 airport; or
- 2 (6) within 1,000 feet of premises the location of
- 3 which is designated by the Texas Department of Criminal Justice as a
- 4 place of execution under Article 43.19, Code of Criminal Procedure,
- 5 on a day that a sentence of death is set to be imposed on the
- 6 designated premises and the person received notice that:
- 7 (A) going within 1,000 feet of the premises with
- 8 a weapon listed under this subsection was prohibited; or
- 9 (B) possessing a weapon listed under this
- 10 subsection within 1,000 feet of the premises was prohibited.
- 11 (b) It is a defense to prosecution under Subsections
- (a)(1)-(4) that the actor possessed a firearm while in the actual
- discharge of his official duties as a member of the armed forces or
- 14 national guard or a guard employed by a penal institution, or an
- 15 officer of the court.
- 16 (c) In this section:
- 17 (1) "Premises" has the meaning assigned by Section
- 18 46.035.
- 19 (1-a) "Restricted area" means that area of an airport
- 20 where aircraft movement and support activities occur, and enclosed
- 21 <u>airport land adjacent to such area, to which ingress is permitted</u>
- 22 only by specific authorization of the airport operator.
- 23 (2) "Secured area" means an area of an airport
- 24 terminal building to which access is controlled by the inspection
- of persons and property under federal law.
- 26 (d) [It is a defense to prosecution under Subsection (a)(5)
- 27 that the actor possessed a firearm or club while traveling to or

1 from the actor's place of assignment or in the actual discharge of duties as: 2 3 [(1) a member of the armed forces or national guard; [(2) a guard employed by a penal institution; or 4 [(3) a security officer commissioned by the Texas Board 5 of Private Investigators and Private Security Agencies if: 6 7 [(A) the actor is wearing a distinctive uniform; [and 8 9 [(B) the firearm or club is in plain view; or 10 [(5) a security officer who holds a personal protection 11 authorization under the Private Investigators and Private Security Agencies Act (Article 4413(29bb), Vernon's Texas Civil Statutes). 12 [(e)] It is a defense to prosecution under Subsection (a)(5) 13 that the firearm is [actor] checked [all firearms] as baggage in 14 accordance with federal or state law or regulations before entering 15 16 a secured area. (e) $[\frac{f}{f}]$ It is not a defense to prosecution under this 17 section that the actor possessed a handgun and was licensed to carry 18 a concealed handgun under Subchapter H, Chapter 411, Government 19 Code. 20 (f) $[\frac{g}{g}]$ An offense under this section is a Class A 21 22 misdemeanor [third degree felony]. (g) [(h)] It is a defense to prosecution under Subsection 23

(a)(4) that the actor possessed a firearm or club while traveling to

(1) the actor is wearing a distinctive uniform; and
(2) the firearm or club is in plain view.

(h) [(i)] It is an exception to the application of Subsection
(a)(6) that the actor possessed a firearm or club:
(1) while in a vehicle being driven on a public road;
or

SECTION 2. This Act takes effect September 1, 2007.

(2) at the actor's residence or place of employment.
