A BILL TO BE ENTITLED

- 2 relating to the application of the doctrine of sovereign immunity
- 3 in a judicial proceeding to enforce certain employment rights.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Chapter 271, Local Government
- 6 Code, is amended to read as follows:
- 7 CHAPTER 271. PURCHASING, [AND] CONTRACTING, AND RELATED AUTHORITY
- 8 OF MUNICIPALITIES, COUNTIES, AND CERTAIN OTHER LOCAL GOVERNMENTS
- 9 SECTION 2. The heading to Subchapter I, Chapter 271, Local
- 10 Government Code, is amended to read as follows:
- 11 SUBCHAPTER I. ADJUDICATION OF CONTRACT OR EMPLOYMENT-RELATED
- 12 CLAIMS [ARISING UNDER WRITTEN CONTRACTS WITH] LOCAL GOVERNMENTAL
- 13 ENTITIES
- 14 SECTION 3. Section 271.152, Local Government Code, is
- 15 amended to read as follows:
- 16 Sec. 271.152. WAIVER OF IMMUNITY TO SUIT FOR CERTAIN
- 17 CLAIMS. A local governmental entity that is authorized by statute
- or the constitution to enter into a contract and [that] enters into
- 19 a contract subject to this subchapter, or that is governed by a
- 20 state statute or local ordinance affecting the employment rights of
- 21 <u>a local government entity's employees</u>, waives sovereign immunity to
- 22 suit for the purpose of adjudicating a claim for breach of the
- 23 contract or a violation of statute or ordinance, subject to the
- 24 terms and conditions of this subchapter.

- 1 SECTION 4. Section 271.153, Local Government Code, is
- 2 amended by adding Subsection (c) to read as follows:
- 3 (c) The total amount of money awarded in an adjudication
- 4 brought against a local governmental entity for a violation of a
- 5 statute or ordinance affecting the employment rights of a local
- 6 governmental entity's employees is limited to:
- 7 (1) The amount necessary to make the affected
- 8 <u>individual</u> whole for any violation of rights found to have
- 9 occurred; and
- 10 (2) interest as allowed by law.
- 11 SECTION 5. Section 271.155, Local Government Code, is
- 12 amended to read as follows:
- Sec. 271.155. NO WAIVER OF OTHER DEFENSES. This subchapter
- 14 does not waive a defence or a limitation on damages available to a
- person [party to a contract], other than a bar against suit based on
- 16 sovereign immunity.
- 17 SECTION 6. Section 271.159, Local Government Code, is amended to
- 18 read as follows:
- 19 Sec. 271.159. NO RECOVERY OF ATTORNEY'S FEES.
- 20 (a) Attorney's fees incurred by a local governmental entity or any
- 21 other party in the adjudication of a claim under a contract subject
- 22 <u>to this subchapter</u> by or against a local governmental entity shall
- 23 not be awarded to any party in the adjudication unless the local
- 24 governmental entity has entered into a written agreement that
- 25 expressly authorizes the prevailing party in the adjudication to
- 26 recover its reasonable and necessary attorney's fees by specific
- 27 reference to this section.

- 1 (b) Attorney's fees incurred by a local governmental entity
 2 or any other party in the adjudication of a claim under a statute or
 3 ordinance affecting the employment rights of a local governmental
 4 entity's employees shall not be awarded to any party in the
 5 adjudication unless authorized by a statute outside this
 6 subchapter.
- SECTION 7. The changes in law made by this Act to Subchapter I, Chapter 271, Local Government Code, apply to any action alleging a violation of Title 5, Local Government Code, or another state statute or a local ordinance affecting employment that has not been finally adjudicated on the effective date of this Act.
- SECTION 8. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2007.
