2	relating to the administration of the work-study student mentorship
3	program by the Texas Higher Education Coordinating Board.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 56.079, Education Code, is amended to
6	read as follows:
7	Sec. 56.079. WORK-STUDY STUDENT MENTORSHIP PROGRAM.
8	(a) In this section:
9	(1) "Coordinating board" means the Texas Higher
10	Education Coordinating Board.
11	(2) "Eligible institution" means:
12	(A) an institution of higher education; or
13	(B) a private or independent institution of
14	higher education, as defined by Section 61.003(15), other than a
15	private or independent institution of higher education offering
16	only professional or graduate degrees.
17	(3) "Participating entity" means an eligible
18	institution, a school district, or a nonprofit organization that
19	has filed a memorandum of understanding with the coordinating board
20	under this section to participate in the work-study student
21	mentorship program established under this section[, "general
22	academic teaching institution" has the meaning assigned by Section
23	61.003].
24	(b) In accordance with this section and coordinating board

rules, the coordinating board shall administer [A general academic 1 teaching institution may establish] a work-study student 2 mentorship program under which students who are enrolled [in their 3 junior or senior year] at participating eligible institutions [the 4 5 institution] and who meet the eligibility requirements for 6 employment in the Texas college work-study program under Section 7 56.075 may be employed by participating entities [the institution] under the Texas college work-study program to: 8

9 <u>(1)</u> mentor students <u>at participating eligible</u> 10 <u>institutions or high school students in participating school</u> 11 <u>districts; or</u>

12 (2) counsel high school students at GO Centers or 13 similar high school-based recruiting centers designed to improve 14 student access to higher education [who are on academic probation 15 at the institution].

16 (c) <u>To participate in the work-study student mentorship</u> 17 <u>program, an eligible institution and one or more school districts</u> 18 <u>or nonprofit organizations interested in jointly participating in</u> 19 <u>the program shall file with the coordinating board a joint</u> 20 <u>memorandum of understanding detailing the roles and</u> 21 <u>responsibilities of the participating entities.</u>

22 (d) The coordinating board, in consultation with eligible 23 institutions, school districts, and nonprofit organizations that 24 express interest in participating in the work-study student 25 mentorship program, shall develop a standard contract establishing 26 the roles and responsibilities of participating entities to be used 27 as a model for a memorandum of understanding entered into by

participating entities under Subsection (c). 1 2 (e) The coordinating board: 3 (1) shall establish criteria to ensure that the participating eligible institution's contribution toward the wages 4 5 and benefits of a student employed as a mentor under the work-study student mentorship program is matched by funds provided by the 6 7 participating entity benefiting from the services of the employed 8 student in an amount that is at least equal to the amount of the 9 participating eligible institution's contribution; (2) may accept appropriate in-kind contributions from 10 participating nonprofit organizations to satisfy the matching 11 funds requirement of this subsection; and 12 (3) may waive the matching funds requirement of this 13 subsection for a participating entity that meets criteria 14 15 established by the coordinating board for a waiver. 16 (f) The coordinating board shall partner with participating 17 nonprofit organizations to establish additional GO Centers or 18 similar high school-based recruiting centers designed to improve student access to higher education in this state. 19 (g) The coordinating board shall ensure that each student 20 employed under the work-study student mentorship program: 21 22 (1) receives appropriate training and supervision; 23 and (2) is paid at least at the minimum wage required by 24 25 law. (h) The coordinating board may accept gifts, grants, and 26 27 donations from any public or private source for the purposes of this

1 section.

2 (i) An eligible [A general academic teaching] institution 3 participating in the [that has established a] work-study student 4 mentorship program under this section may require students who are 5 on academic probation at the institution to be matched with a 6 student mentor employed under the program.

7 (j) [(d)] Not later than November 1 of each year, each 8 <u>eligible</u> [general academic teaching] institution <u>participating in</u> 9 <u>the</u> [that has established a] work-study student mentorship program 10 [under this section] shall submit to the <u>coordinating board</u> [Texas 11 <u>Higher Education Coordinating Board</u>] a report regarding the 12 progress <u>resulting from</u> [of] the institution's <u>participation in the</u> 13 program. The report must include:

14 <u>(1)</u> the number of students <u>of the institution</u> employed 15 [by the institution] as mentors under the program in the preceding 16 academic year<u>;</u>

17 (2) the number of students of the institution 18 receiving mentoring under the program in the preceding academic 19 year;

20 (3) the number of high school students receiving 21 mentoring or counseling from students of the institution under the 22 program in the preceding academic year;

23 <u>(4)</u> [and] information relating to the costs of the 24 program; and

(5) if available, information in the form prescribed
by the coordinating board regarding the following indicators of
[and] the academic progress of the students of the institution

employed as mentors under the program, students of the institution 1 2 receiving mentoring under the program, and the high school students receiving mentoring or counseling from students of the institution 3 4 under the program: 5 (A) changes in grade point averages; (B) changes in graduation rates; 6 7 (C) changes in the percentage of high school students who enroll in higher education; and 8 9 (D) effects on higher education readiness and 10 preparation [in that year]. 11 (k) [(e)] Each <u>eligible</u> [general academic teaching] institution participating in the [that has established a] 12 work-study student mentorship program under this section shall set 13 aside a portion of the institution's Texas college work-study 14 15 program funds to pay for the state's contribution toward the costs 16 of the program. 17 (1) [(f)] Notwithstanding Section 56.076, a participating entity [a general academic teaching institution] that employs a 18 student mentor under the work-study student mentorship program 19 shall provide from sources other than federal college work-study 20 funds: 21 22 (1)not less than 10 percent of the employed student's 23 wages; and (2) 100 percent of other employee benefits for the 24 25 employed student. SECTION 2. The Texas Higher Education Coordinating Board 26 27 shall adopt rules relating to the administration of the work-study 5

student mentorship program under Section 56.079, Education Code, as amended by this Act, as soon as practicable after the effective date of this Act.

4 SECTION 3. This Act takes effect immediately if it receives 5 a vote of two-thirds of all the members elected to each house, as 6 provided by Section 39, Article III, Texas Constitution. If this 7 Act does not receive the vote necessary for immediate effect, this 8 Act takes effect September 1, 2007.
