## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Somerset Municipal Utility District
3	No. 1; providing authority to impose a tax and issue bonds; granting
4	the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8203 to read as follows:
8	CHAPTER 8203. SOMERSET MUNICIPAL UTILITY DISTRICT NO. 1
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8203.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the Somerset Municipal Utility
14	District No. 1.
15	Sec. 8203.002. NATURE OF DISTRICT. The district is a
16	municipal utility district in San Jacinto County created under and
17	essential to accomplish the purposes of Section 52, Article III,
18	and Section 59, Article XVI, Texas Constitution.
19	Sec. 8203.003. FINDING OF PUBLIC USE AND BENEFIT. The
20	district is created to serve a public use and benefit.
21	Sec. 8203.004. CONFIRMATION ELECTION REQUIRED. If the
22	creation of the district is not confirmed at a confirmation
23	election held under Section 8203.023 before September 1, 2009:
24	(1) the district is dissolved September 1, 2009,

Τ	except that the district shall:
2	(A) pay any debts incurred;
3	(B) transfer to San Jacinto County any assets
4	that remain after the payment of debts; and
5	(C) maintain the organization of the district
6	until all debts are paid and remaining assets are transferred; and
7	(2) this chapter expires September 1, 2012.
8	Sec. 8203.005. INITIAL DISTRICT TERRITORY. (a) The
9	district is initially composed of the territory described by
10	Section 2 of the Act creating this chapter.
11	(b) The boundaries and field notes contained in Section 2 of
12	the Act creating this chapter form a closure. A mistake made in the
13	field notes or in copying the field notes in the legislative process
14	<pre>does not affect:</pre>
15	(1) the organization, existence, or validity of the
16	district;
17	(2) the right of the district to impose taxes; or
18	(3) the legality or operation of the board.

20	SUBCHAPTER A-1. TEMPORARY PROVISIONS
21	Sec. 8203.021. TEMPORARY DIRECTORS. (a) The temporary

- 16 district at a location in the district agreeable to a majority of
- 17 the directors. If a location cannot be agreed upon, the
- 18 organizational meeting shall be at the San Jacinto County
- 19 Courthouse.
- 20 Sec. 8203.023. CONFIRMATION AND INITIAL DIRECTORS'
- 21 ELECTION. The temporary directors shall hold an election to
- 22 confirm the creation of the district and to elect five directors as
- provided by Section 49.102, Water Code.
- Sec. 8203.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 25 directors elected under Section 8203.023 shall draw lots to
- determine which two shall serve until the first regularly scheduled
- 27 election of directors and which three shall serve until the second

regularly scheduled election of directors. 1 Sec. 8203.025. EXPIRATION OF SUBCHAPTER. This subchapter 2 3 expires September 1, 2012. 4 [Sections 8203.026-8203.050 reserved for expansion] 5 SUBCHAPTER B. BOARD OF DIRECTORS 6 Sec. 8203.051. GOVERNING BODY; TERMS. (a) The district is 7 governed by a board of five directors. 8 (b) Directors serve staggered four-year terms. 9 [Sections 8203.052-8203.100 reserved for expansion] SUBCHAPTER C. POWERS AND DUTIES 10 Sec. 8203.101. MUNICIPAL UTILITY DISTRICT POWERS AND 11 DUTIES. The district has the powers and duties provided by the 12 13 general law of this state, including Chapters 49 and 54, Water Code, applicable to municipal utility districts created under Section 59, 14 15 Article XVI, Texas Constitution. 16 Sec. 8203.102. ROAD PROJECTS; LIMIT ON EMINENT DOMAIN 17 POWER. (a) The district may construct, acquire, improve, 18 maintain, or operate macadamized, graveled, or paved roads or improvements in aid of those roads. 19 20 (b) A road project must meet all applicable construction standards, zoning and subdivision requirements, and regulations of 21 22 each municipality in whose corporate limits or extraterritorial jurisdiction the district is located. If the district is not 23

located in the corporate limits or extraterritorial jurisdiction of

a municipality, a road project must meet all applicable

construction standards, zoning and subdivision requirements, and

regulations of each county in which the district is located.

- (c) The district may not undertake a road project unless 1 2 each municipality in whose corporate limits or extraterritorial 3 jurisdiction the district is located consents by resolution.
- the district is not located in the corporate limits or 4
- extraterritorial jurisdiction of a municipality, the district may 5
- 6 not undertake a road project unless each county in which the
- 7 district is located consents by resolution.
- (d) The district may not exercise the power of eminent 8 9 domain outside the district for a road project.
- Sec. 8203.103. ROAD CONTRACTS. The district may contract 10
- 11 for a road project in the manner provided by Subchapter I, Chapter
- 12 49, Water Code.
- 13 Sec. 8203.104. RECREATIONAL FACILITIES; LIMIT ON EMINENT
- DOMAIN POWER. (a) In this section, "recreational facilities" has 14
- 15 the meaning assigned by Section 49.462, Water Code.
- 16 (b) The district may develop and maintain recreational
- 17 facilities.
- 18 (c) The district may not, for the development or maintenance
- of a recreational facility, acquire by condemnation land, an 19
- 20 easement, or other property inside or outside the district.

- 22 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- Sec. 8203.151. OPERATION AND MAINTENANCE TAX. (a) 23 The

- 26 Code.
- 27 (b) Section 49.107(f), Water Code, does not apply to

- 3 Sec. 8203.152. TAX TO REPAY BONDS. The district may impose
- 4 a tax to pay the principal of and interest on bonds issued under
- 5 Section 8203.201.
- 6 Sec. 8203.153. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 7 ASSESSMENTS. The district may not impose an impact fee or
- 8 assessment on the property, including the equipment,
- 9 rights-of-way, facilities, or improvements, of:
- 10 (1) an electric utility or a power generation company
- 11 as defined by Section 31.002, Utilities Code;
- 12 (2) a gas utility as defined by Section 101.003 or
- 13 121.001, Utilities Code;
- 14 (3) a telecommunications provider as defined by
- 15 Section 51.002, Utilities Code;
- 16 (4) a cable operator as defined by 47 U.S.C. Section
- 17 <u>522; or</u>
- 18 (5) a person who provides to the public advanced
- 19 telecommunications services.
- 20 [Sections 8203.154-8203.200 reserved for expansion]
- 21 SUBCHAPTER E. BONDS
- Sec. 8203.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 23 OBLIGATIONS. (a) The district may issue bonds or other
- obligations as provided by Chapters 49 and 54, Water Code, and to
- 25 finance the construction, maintenance, or operation of projects
- 26 under Section 8203.102.
- 27 (b) The district may issue bonds or other obligations

- payable wholly or partly from ad valorem taxes, impact fees,
  revenue, grants, or other district money.
- 3 (c) The district may not issue bonds or other obligations
  4 secured wholly or partly by ad valorem taxation to finance projects
  5 authorized by Section 8203.102 unless the issuance is approved by a
  6 vote of a two-thirds majority of district voters voting at an
  7 election called for that purpose.
- 8 (d) Bonds or other obligations issued or incurred to finance
  9 projects authorized by Section 8203.102 may not exceed one-fourth
  10 of the assessed value of the real property in the district.
- 11 (e) The district may not issue bonds or other obligations

  12 secured wholly or partly by ad valorem taxation to finance projects

  13 authorized by Section 8203.104 unless the issuance is approved by a

  14 vote of a majority of district voters voting at an election called

  15 for that purpose. Section 49.464(a), Water Code, does not apply to

  16 the district.

L1	(2) prepare a metes and bounds description for each
L2	proposed district.
L3	Sec. 8203.252. ELECTION FOR DIVISION OF DISTRICT.
L4	(a) After the board has complied with Section 8203.251(e), the
L5	board shall hold an election in the district to determine whether
L6	the district should be divided as proposed.
L7	(b) The board shall give notice of the election not later
L8	than the 35th day before the date of the election. The notice must
L9	<pre>state:</pre>
20	(1) the date and location of the election; and
21	(2) the proposition to be voted on.
22	(c) If a majority of the votes cast are in favor of the
23	division:
24	(1) the district is divided; and
25	(2) not later than the 30th day after the date of the
26	election, the district shall provide written notice of the division

1	(A) the Texas Commission on Environmental
2	Quality;
3	(B) the attorney general;
4	(C) the commissioners court of each county in

8	(d) If a majority of the votes cast are not in favor of the
9	division, the district may not be divided.
LO	Sec. 8203.253. ELECTION OF DIRECTORS OF NEW DISTRICTS.
L1	(a) Not later than the 90th day after the date of an election in
L2	favor of the division of the district, the board shall:
L3	(1) appoint itself as the board of one of the new
L4	districts; and
L5	(2) appoint five directors for each of the other new
L6	districts.
L7	(b) Directors appointed under Subsection (a)(1) serve the
L8	staggered terms to which they were elected in the original
L9	district. Directors appointed under Subsection (a)(2) serve until
20	the election for directors under Subsection (c).
21	(c) On the uniform election date in May of the first
22	even-numbered year after the year in which the directors are
23	appointed, the appointed board shall hold an election to elect five
24	directors in each district for which directors were appointed under
25	Subsection (a)(2). The directors shall draw lots to determine
06	which two shall cargo until the next regularly scheduled election

- 2 Sec. 8203.254. CONTINUING POWERS AND OBLIGATIONS OF NEW
- 3 DISTRICTS. (a) Each new district may incur and pay debts and has
- 4 all powers of the original district created by this chapter.
- 5 (b) If the district is divided as provided by this
- 6 subchapter, the current obligations and any bond authorizations of
- 7 the district are not impaired. Debts shall be paid by revenue or by
- 8 taxes or assessments imposed on real property in the district as if
- 9 the district had not been divided or by contributions from each new
- 10 district as stated in the terms set by the board under Section
- 11 <u>8203.251(e).</u>
- 12 (c) Any other district obligation is divided pro rata among
- 13 the new districts on an acreage basis or on other terms that are
