4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 31, Human Resources Code,
6	is amended by adding Section 31.0021 to read as follows:
7	Sec. 31.0021. DEFINITION OF NONRECIPIENT PARENT. (a)
8	Except as provided by Subsection (b), in this chapter,
9	"nonrecipient parent" means an adult or minor parent who is not a
10	recipient of financial assistance but who is living with the
11	person's child who is a recipient of financial assistance.
12	(b) "Nonrecipient parent" does not include:
13	(1) a minor parent who is not the head of household;
14	(2) a person who is ineligible for financial
15	assistance because of the person's immigration status; or
16	(3) a parent who cares for a disabled family member
17	living in the home if the family member does not attend school
18	full-time and the need for the care is supported by medical
19	documentation.
20	SECTION 2. Section 31.0033(d), Human Resources Code, is

member living in the home, if the family member does not attend school full-time, [A person who is the caretaker of a physically or mentally disabled shild who requires the caretaker's presence] is not required to participate in a program under this section. A single person who is the caretaker of a child is not required to participate in a program under this section [exempt] until the caretaker's youngest child at the time the caretaker first became eligible for assistance reaches the age of one. Notwithstanding Sections 31.0035(b) and 32.0255(b), the department shall provide to a person who is not required to participate in a program [exempt] under this subsection and who voluntarily participates in a program under Subsection (a)(2) six months of transitional benefits in addition to the applicable limit prescribed by Section 31.0065.

  - (d) A state program operated under this section shall be administered by the division of workforce development of the Texas Workforce Commission [when the program is transferred to that commission].
  - (g) A nonrecipient parent who receives Supplemental Security Income (SSI) benefits under 42 U.S.C. Section 1381 et seq., as amended, is not subject to the requirements of this section. The Texas Workforce Commission may provide services to

- 3 SECTION 5. Section 31.014(a), Human Resources Code, is
- 4 amended to read as follows:
- 5 (a) The Health and Human Services Commission [department]
- 6 shall provide financial assistance, in accordance with

- 8 Health and Human Services Commission, to a two-parent family if the
- 9 primary wage earner parent, other than a nonrecipient parent
- 10 described by Section 31.012(g), is registered with a Temporary

- 12 Subchapter IV, Social Security Act (42 U.S.C. Section 601 et seq.)

- 17 SECTION 6. Sections 31.0126(c) and 31.014(c), Human
- 18 Resources Code, are repealed.
- 19 SECTION 7. The changes in law made by this Act apply to a
- 20 person receiving financial assistance, including a nonrecipient
- 21 parent, as defined by Section 31.0021, Human Resources Code, as
- 22 added by this Act, on or after the effective date of this Act,
- 23 regardless of the date the determination of eligibility for that

- 4 SECTION 9. This Act takes effect September 1, 2007.
