- 2 relating to the creation of the Harris County Improvement District
- 3 No. 8; providing authority to impose a tax and issue bonds.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. LEGISLATIVE FINDINGS. (a) The legislature
- 6 finds that the Harris County Improvement District No. 8 is created
- 7 under the general authority of the Texas Legislature to legislate
- 8 for the public good.
- 9 (b) The legislature further finds that:
- 10 (1) the area of the proposed Harris County Improvement
- 11 District No. 8 is in an area that will develop into one of the
- 12 state's most dynamic activity centers and will be the location of
- 13 numerous commercial, office, retail, and residential buildings;
- 14 (2) the area is presently served with an inadequate
- 15 public transportation system and has an inadequate system of
- 16 streets and public parking facilities;
- 17 (3) residents, workers, visitors, customers, and
- other persons accessing the area must primarily use motor vehicles,
- 19 which use will place an undue burden on the street system in the
- 20 district and result in severe congestion that retards mobility of
- 21 persons and property and impairs the use of the area as one of the
- 22 state's primary economic and business centers;
- 23 (4) the absence of an adequate system of parking
- 24 facilities, including park and ride facilities, discourages the use

- 1 of public transportation and further aggravates vehicular
- 2 congestion in the area;
- 3 (5) motor vehicles are generally powered by internal
- 4 combustion engines that emit pollutants into the air, which results
- 5 in dangers to the public health and welfare;
- 6 (6) the proliferation of the use of motor vehicles for
- 7 passenger transportation in the area will be caused in substantial
- 8 part by the absence of an adequate public transportation system and
- 9 an adequate system or network of public parking facilities;
- 10 (7) provision of an adequate system of public parking
- 11 facilities and public transit and transportation facilities will
- 12 accomplish the public purposes of Section 52-a, Article III, Texas
- 13 Constitution, by stimulating transportation and commerce in the
- 14 area and in the state and will serve the further public purpose of
- 15 reducing the pollutants discharged into the air, thus reducing the
- 16 threat to the public health and welfare and preserving and
- 17 conserving the natural resources of this state as mandated by
- 18 Section 59, Article XVI, Texas Constitution; and
- 19 (8) in order for the area to have an adequate public
- 20 transit system and an adequate system of public parking it will be
- 21 necessary for the district to be able to take advantage of all
- 22 public and private funds and opportunities available and be
- 23 empowered to contract with other public agencies and with private
- 24 entities to jointly provide the systems.
- 25 SECTION 2. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 8.
- 26 Subtitle C, Title 4, Special District Local Laws Code, is amended by
- 27 adding Chapter 3848 to read as follows:

2	SUBCHAPTER A. GENERAL PROVISIONS
3	Sec. 3848.001. DEFINITIONS. In this chapter:
4	(1) "Board" means the board of directors of the

6	(2) "District" means the Harris County Improvement
7	District No. 8.
8	Sec. 3848.002. HARRIS COUNTY IMPROVEMENT DISTRICT NO. 8.
9	The Harris County Improvement District No. 8 is a special district
10	created under Section 59, Article XVI, Texas Constitution.
11	Sec. 3848.003. PURPOSE; DECLARATION OF INTENT. (a) The
12	creation of the district is essential to accomplish the purposes of
13	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
14	Texas Constitution, and other public purposes stated in this
15	chapter. By creating the district and in authorizing Harris
16	County, the City of Houston, the Metropolitan Transit Authority of
17	Harris County, and other political subdivisions to contract with
18	the district, the legislature has established a program to
19	accomplish the public purposes set out in Section 52-a, Article
20	III, Texas Constitution.
21	(b) The creation of the district is necessary to promote,
22	develop, encourage, and maintain transportation, parking, housing,
23	recreation, the arts, safety, scenic beauty, and the public welfare
24	in the area of the district.
25	(c) This chapter and the creation of the district may not be
26	interpreted to relieve Harris County or the City of Houston from
27	providing the level of services provided as of September 1, 2007, to

- 1 the area in the district. The district is created to supplement and
- 2 not to supplant the county or city services provided in the area in
- 3 the district.
- 4 Sec. 3848.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 5 (a) The district is created to serve a public use and benefit.
- 6 (b) All land and other property included in the district
- 7 will benefit from the improvements and services to be provided by
- 8 the district under powers conferred by Sections 52 and 52-a,
- 9 Article III, and Section 59, Article XVI, Texas Constitution, and
- 10 other powers granted under this chapter.
- 11 <u>(c)</u> The district will:
- 12 <u>(1) promote the health, safety, and general welfare of</u>
- 13 district residents and the public;
- 14 (2) provide needed funding for the district to
- preserve, maintain, and enhance the economic health and vitality of
- the area as a residential neighborhood and a commercially viable
- 17 area; and
- 18 (3) promote the health, safety, welfare, and enjoyment
- 19 of the public by providing pedestrian ways and by landscaping and
- 20 developing certain areas in the district, which are necessary for
- 21 the restoration, preservation, and enhancement of scenic beauty.
- 22 (d) Pedestrian ways along or across a street, whether at
- 23 grade or above or below the surface, and street lighting, street
- 24 landscaping, and street art objects are parts of and necessary
- 25 components of a street and are considered to be a street or road
- 26 improvement.
- 27 (e) The district will not act as the agent or

- 1 instrumentality of any private interest even though the district
- 2 will benefit many private interests as well as the public.
- 3 Sec. 3848.005. DISTRICT TERRITORY. The district is
- 4 composed of the territory described by Section 3 of the Act
- 5 enacting this chapter, as that territory may have been modified
- 6 under:
- 7 (1) Subchapter J, Chapter 49, Water Code; or
- 8 <u>(2) other law.</u>
- 9 Sec. 3848.006. APPLICABILITY OF MUNICIPAL MANAGEMENT
- 10 DISTRICTS LAW. Except as otherwise provided by this chapter,
- 11 Chapter 375, Local Government Code, applies to the district.
- 12 Sec. 3848.007. LIBERAL CONSTRUCTION OF CHAPTER. This
- 13 chapter shall be liberally construed in conformity with the
- 14 findings and purposes stated in this chapter.
- 15 [Sections 3848.008-3848.050 reserved for expansion]
- SUBCHAPTER B. BOARD OF DIRECTORS
- Sec. 3848.051. COMPOSITION; TERMS. (a) The district is
- 18 governed by a board of nine voting directors who serve staggered
- 19 terms of four years, with four or five directors' terms expiring
- 20 June 1 of each odd-numbered year.
- 21 (b) The board by resolution may increase or decrease the
- 22 <u>number of voting directors on the board, but only if it is in the</u>
- 23 best interest of the district to do so. The board may not:
- 24 <u>(1) increase the number of directors to more than</u>
- 25 nine; or
- 26 (2) decrease the number of directors to fewer than
- 27 five.

- Sec. 3848.052. APPOINTMENT OF DIRECTORS. The mayor and 1 2 members of the governing body of the City of Houston shall appoint 3 voting directors from persons recommended by the board. A person is appointed if a majority of the members of the governing body, 4 5 including the mayor, vote to appoint that person. Sec. 3848.053. NONVOTING DIRECTORS. (a) The following 6 7 persons serve as nonvoting directors: (1) the directors of the following departments of the 8 9 City of Houston or a person designated by that director: 10 (A) parks and recreation; 11 (B) planning and development; and (C) public works; and 12 13 (2) the City of Houston's chief of police. (b) If a department described by Subsection (a) is 14 15 consolidated, renamed, or changed, the board may appoint a director 16 of the consolidated, renamed, or changed department as a nonvoting 17 director. If a department described by Subsection (a) is 18 abolished, the board may appoint a representative of another department that performs duties comparable to those performed by 19 20 the abolished department. Sec. 3848.054. QUORUM. (a) A majority of the board is a 21
- 23 (b) Nonvoting directors and vacant director positions are 24 not counted for the purposes of establishing a board quorum.
- Sec. 3848.055. COMPENSATION OF VOTING DIRECTORS. Voting
- 26 <u>directors may receive fees of office and reimbursement of expenses</u>
- as provided by Section 49.060, Water Code.

- 10 (1) has each power of and is considered for purposes of

- 12 Chapter 431, Transportation Code; and
- 13 (2) may implement any project and provide any service
- 14 authorized by this chapter.
- 15 (c) The board shall appoint the board of directors of the
- 16 nonprofit corporation. The board of directors of the nonprofit
- 17 corporation shall serve in the same manner as, for the same term as,
- 18 and on the same conditions as the board of directors of a local
- 19 government corporation created under Chapter 431, Transportation
- 20 Code.
- Sec. 3848.103. AGREEMENTS; GRANTS. (a) The district may
- 22 make an agreement with or accept a gift, grant, or loan from any
- 23 <u>person.</u>
- (b) The implementation of a project is a governmental
- 25 <u>function or service for the purposes of Chapter 791, Government</u>
- 26 Code.
- 27 <u>Sec. 3848.104. CONTRACT FOR LAW ENFORCEMENT SERVICES.</u> To

- 1 protect the public interest, the district may contract with Harris
- 2 County or the City of Houston for the county or the city to provide
- 3 law enforcement services in the district for a fee.
- 4 Sec. 3848.105. APPROVAL BY CITY OF HOUSTON. (a) Except as
- 5 provided by Subsection (b), the district must obtain the approval
- 6 of the City of Houston's governing body for:
- 7 (1) the issuance of a bond for each improvement
- 8 project;
- 9 (2) the plans and specifications of the improvement
- 10 project financed by the bond; and
- 11 (3) the plans and specifications of any district
- improvement project related to the use of land owned by the City of
- 13 Houston, an easement granted by the City of Houston, or a
- 14 right-of-way of a street, road, or highway.
- 15 (b) If the district obtains the approval of the City of
- 16 Houston's governing body of a capital improvements budget for a
- 17 period not to exceed five years, the district may finance the
- 18 capital improvements and issue bonds specified in the budget
- 19 without further approval from the City of Houston.
- Sec. 3848.106. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 21 district may join and pay dues to an organization that:
- (1) enjoys tax-exempt status under Section 501(c)(3),
- 23 (4), or (6), Internal Revenue Code of 1986; and
- 24 (2) performs a service or provides an activity
- 25 consistent with the furtherance of a district purpose.
- Sec. 3848.107. ROAD POWERS. The district may exercise the
- 27 powers given to:

1	(1) a road district created under Chapter 257,
2	Transportation Code; and
3	(2) a road utility district created under Chapter 441,
4	Transportation Code.
5	Sec. 3848.108. AIR RIGHTS; CONSTRUCTION. The district may
6	acquire air rights and may construct improvements on property on
7	which it only owns air rights.
8	Sec. 3848.109. ADDITIONAL PROPERTY RIGHTS; LEASEHOLDS. The
9	district may construct improvements on property on which it only
10	has a leasehold interest and may own undivided interests in
11	buildings and other improvements.
12	Sec. 3848.110. NO EMINENT DOMAIN POWER. The district may
13	not exercise the power of eminent domain.
14	[Sections 3848.111-3848.150 reserved for expansion]
15	SUBCHAPTER D. PUBLIC TRANSIT SYSTEM AND PARKING FACILITIES
16	Sec. 3848.151. PUBLIC TRANSIT SYSTEM. The district may
17	acquire, lease as lessor or lessee, construct, develop, own,
18	operate, and maintain a public transit system to serve the area
19	within the boundaries of the district.
20	Sec. 3848.152. PARKING FACILITIES AUTHORIZED; OPERATION BY
21	PRIVATE ENTITY; TAX EXEMPTION. (a) The district may acquire,

- 2 (b) A parking facility of the district must be either leased
- 3 to or operated on behalf of the district by a private entity or an
- 4 entity other than the district. The district's parking facilities
- 5 are a program authorized by the legislature under Section 52-a,
- 6 Article III, Texas Constitution, and accomplish a public purpose
- 7 under that section even if leased or operated by a private entity
- 8 for a term of years.
- 9 <u>(c)</u> The district's public parking facilities and any lease
- 10 to a private entity are exempt from the payment of ad valorem taxes
- 11 and state and local sales and use taxes.
- 12 Sec. 3848.153. RULES. The district may adopt rules
- 13 covering its public transit system or its public parking facilities
- 14 except that a rule relating to or affecting the use of the public
- 15 right-of-way or a requirement for off-street parking is subject to
- all applicable municipal charter, code, or ordinance requirements.
- Sec. 3848.154. FINANCING OF PUBLIC TRANSIT SYSTEM OR
- 18 PARKING FACILITIES. (a) The district may use any of its
- 19 resources, including revenue, assessments, taxes, and grant or
- 20 contract proceeds, to pay the cost of acquiring and operating a
- 21 public transit system or public parking facilities.
- 22 (b) The district may set and impose fees, charges, or tolls
- 23 for the use of the public transit system or the public parking
- 24 <u>facilities and may issue bonds or notes to finance the cost of these</u>
- 25 facilities.
- 26 [Sections 3848.155-3848.200 reserved for expansion]

1	SUBCHAPTER E. FINANCIAL PROVISIONS
2	Sec. 3848.201. DISBURSEMENTS AND TRANSFERS OF MONEY. The
3	board by resolution shall establish the number of directors'
4	signatures and the procedure required for a disbursement or
5	transfer of the district's money.
6	Sec. 3848.202. MAINTENANCE TAX. (a) If authorized at an
7	election held in accordance with Section 3848.207, the district may
8	impose an annual ad valorem tax on taxable property in the district
9	<u>to:</u>
10	(1) administer the district;
11	(2) maintain and operate the district;
12	(3) construct or acquire improvements; or
13	(4) provide a service.
14	(b) The board shall determine the tax rate.

19	Sec. 3848.203. ASSESSMENTS; LIENS FOR ASSESSMENTS.
20	(a) The board by resolution may impose and collect an assessment
21	for any purpose authorized by this chapter.
22	(b) An assessment, a reassessment, or an assessment
23	resulting from an addition to or correction of the assessment roll
24	by the district, penalties and interest on an assessment or
25	reassessment, an expense of collection, and reasonable attorney's
26	<pre>fees incurred by the district:</pre>
27	(1) are a first and prior lien against the property

- 1 assessed;
- 2 (2) are superior to any other lien or claim other than
- 3 a lien or claim for county, school district, or municipal ad valorem
- 4 taxes; and
- 5 (3) are the personal liability of and a charge against
- 6 the owners of the property even if the owners are not named in the
- 7 assessment proceedings.
- 8 <u>(c) The lien is effective from the date of the board's</u>
- 9 resolution imposing the assessment until the date the assessment is
- 10 paid. The board may enforce the lien in the same manner that the
- 11 board may enforce an ad valorem tax lien against real property.
- 12 (d) The board may make a correction to or deletion from the
- 13 assessment roll that does not increase the amount of assessment of
- 14 any parcel of land without providing notice and holding a hearing in
- 15 the manner required for additional assessments.
- Sec. 3848.204. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 17 ASSESSMENTS. The district may not impose an impact fee or
- 18 assessment on the property, including the equipment,
- 19 rights-of-way, facilities, or improvements, of:
- 20 (1) an electric utility or a power generation company
- 21 as defined by Section 31.002, Utilities Code;
- (2) a gas utility as defined by Section 101.003 or
- 23 121.00<u>1, Utilities Code;</u>
- 24 (3) a telecommunications provider as defined by
- 25 Section 51.002, Utilities Code; or
- 26 (4) a person who provides to the public cable
- 27 television or advanced telecommunications services.

- 1 Sec. 3848.205. BONDS AND OTHER OBLIGATIONS. (a) The
- 2 district may issue bonds or other obligations payable wholly or
- 3 partly from assessments, impact fees, revenue, grants, or other
- 4 money of the district, or any combination of those sources of money,
- 5 to pay for any authorized purpose of the district.
- 6 (b) In exercising the district's power to borrow, the
- 7 district may issue a bond or other obligation in the form of a bond,
- 8 note, certificate of participation or other instrument evidencing a
- 9 proportionate interest in payments to be made by the district, or
- 10 other type of obligation.
- 11 Sec. 3848.206. LIMIT ON PARKS AND RECREATION BONDS. Bonds
- issued to finance parks and recreational facilities may not exceed
- one percent of the assessed value of the real property in the
- 14 district according to the most recent certified tax appraisal roll
- 15 for Harris County.
- Sec. 3848.207. TAX AND BOND ELECTIONS. (a) The district
- 17 shall hold an election in the manner provided by Subchapter L,
- 18 Chapter 375, Local Government Code, to obtain voter approval before
- 19 the district imposes a maintenance tax or issues bonds payable from
- 20 ad valorem taxes.
- 21 (b) The board may not include more than one purpose in a
- 22 single proposition at an election.
- Sec. 3848.208. MUNICIPALITY NOT REQUIRED TO PAY DISTRICT
- OBLIGATIONS. Except as provided by Section 375.263, Local

- 6 (b) If the district has debt when it is dissolved, the
- 7 district shall remain in existence solely for the purpose of
