## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the reimbursement of an insurance carrier for the 3 overpayment of certain workers' compensation benefits. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 408.0041, Labor Code, is amended by 5 6 adding Subsection (f-1) to read as follows: 7 (f-1) The subsequent injury fund shall reimburse an insurance carrier for any overpayment of benefits made by the 8 insurance carrier under Subsection (f) based on an opinion rendered 9 10 by a designated doctor if that opinion is reversed or modified by a final arbitration award or a final order or decision of the 11 commissioner or a court. The commissioner shall adopt rules to 12 13 provide for a periodic reimbursement schedule, providing reimbursement at least annually. 14 SECTION 2. Subsection (g), Section 408.042, Labor Code, is 15 amended to read as follows: 16

(g) An insurance carrier is entitled to apply for and 17 receive reimbursement at least annually from the subsequent injury 18 fund for the amount of income and death benefits paid to a worker 19 under this section that are based on employment other than the 20 employment during which the compensable injury occurred. The 21 22 commissioner may adopt rules that govern the documentation, 23 application process, and other administrative requirements 24 necessary to implement this subsection.

SECTION 3. Subsection (b), Section 403.006, Labor Code, is amended to read as follows:

(b) The subsequent injury fund is liable for:

4 (1) the payment of compensation as provided by Section
5 408.162;

6 (2) reimbursement of insurance carrier claims of 7 overpayment of benefits made under an interlocutory order or 8 decision of the commissioner as provided by this subtitle, 9 consistent with the priorities established by rule by the 10 commissioner; [and]

(3) reimbursement of insurance carrier claims as provided by Sections 408.042 and 413.0141, consistent with the priorities established by rule by the commissioner; and

## (4) the reimbursement of an insurance carrier as provided by Section 408.0041(f-1).

16 SECTION 4. Subsection (f-1), Section 408.0041, Labor Code, 17 as added by this Act, applies only to a final arbitration award or a 18 final order or decision of the commissioner of workers' compensation or a court rendered on or after the effective date of 19 20 this Act. A final arbitration award, order, or decision rendered before the effective date of this Act is governed by the law in 21 22 effect on the date the award, order, or decision was rendered, and the former law is continued in effect for that purpose. 23
