5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subchapter F, Chapter 2166, Government Code, is

7 amended by adding Section 2166.2527 to read as follows:

8 Sec. 2166.2527. PREFERENCE FOR VENDORS THAT PROVIDE HEALTH

BENEFITS COVERAGE. (a) The commission shall give a preference to a

contractor that provides health benefits coverage that is at least

equivalent to basic coverage provided under the state employees

group benefit program provided under Chapter 1551, Insurance Code,

to each full-time employee and the employee's family.

14 (b) To qualify for the preference under this section, the

contractor must pay at least 75 percent of the health insurance

premiums for each full-time employee who participates in the

insurance program and at least 75 percent of the health insurance

18 premiums for each dependent of a full-time employee who elects to

participate in dependent coverage under the insurance program.

20 <u>(c) The commission shall give a preference to a contractor</u>

21 who meets the health insurance requirements of this section over

22 any other contractor who does not meet the health insurance

requirements of this section, if the contractor's bid does not

24 exceed 107 percent of the bid of a contractor that does not provide

- 1 the health insurance coverage required by this section to the
- 2 contractor's employees.
- 3 (d) A contract that is awarded to a contractor using the
- 4 preference under this section must include terms that:
- 5 (1) allow the commission to terminate the contract if
- 6 the contractor at any time during the life of the contract fails to
- 7 maintain the health insurance coverage required by this section;
- 8 and
- 9 (2) require the contractor to use the preference
- 10 described by this section when awarding a subcontract under the
- 11 contract.
- 12 SECTION 2. Section 2166.2527, Government Code, as added by
- 13 this Act, applies only to a building construction contract for
- 14 which the solicitation of bids or proposals, request for proposals,
- or similar required notification as to the project is published on
- or after September 1, 2007. A building construction contract for
- 17 which the solicitation of bids or proposals, request for proposals,
- 18 or similar required notification as to the project is published
- 19 before September 1, 2007, is governed by the law in effect at the
- 20 time the solicitation, request, or notification is published, and
- 21 that law is continued in effect for that purpose.
- 22 SECTION 3. This Act takes effect September 1, 2007.
