5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle I, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 9022 to read as follows:
8	CHAPTER 9022. KENDALL COUNTY WATER CONTROL AND IMPROVEMENT
9	DISTRICT NO. 2
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 9022.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "Director" means a member of the board.
15	(3) "District" means Kendall County Water Control and
16	Improvement District No. 2.
17	Sec. 9022.002. NATURE OF DISTRICT. The district is a water
18	control and improvement district in Kendall County created under
19	and essential to accomplish the purposes of Section 59, Article
20	XVI, Texas Constitution.
21	Sec. 9022.003. CONFIRMATION ELECTION REQUIRED. If the
22	creation of the district is not confirmed at a confirmation
23	election held under Section 9022.023 before September 1, 2011:
24	(1) the district is dissolved September 1, 2011,

1	<pre>except that:</pre>
2	(A) any debts incurred shall be paid;
3	(B) any assets that remain after the payment of
4	debts shall be transferred to Kendall County; and
5	(C) the organization of the district shall be
6	maintained until all debts are paid and remaining assets are
7	transferred; and
8	(2) this chapter expires September 1, 2014.
9	Sec. 9022.004. INITIAL DISTRICT TERRITORY. (a) The
10	district is initially composed of the territory described by
11	Section 2 of the Act creating this chapter.
12	(b) The boundaries and field notes contained in Section 2 of
13	the Act creating this chapter form a closure. A mistake made in the
14	field notes or in copying the field notes in the legislative process
15	<pre>does not affect:</pre>
16	(1) the organization, existence, or validity of the
17	district;
18	(2) the right of the district to impose taxes;
19	(3) the validity of the district's bonds, notes, or
20	indebtedness; or
21	(4) the legality or operation of the district or the
22	board.

10	named in Subsection (a) expire on the uniform election date in May
11	of the next even-numbered year.

13	initial directors may not hold an election under Section 9022.023
14	until each municipality in whose corporate limits or
15	extraterritorial jurisdiction the district is located has adopted a
16	resolution consenting to the creation of the district.

18	directors shall hold an election to confirm the creation of the
19	<u>district.</u>

24	Sec. 9022.051. DIRECTORS; TERMS. (a) The district is
25	governed by a board of five directors.
26	(b) Directors serve staggered four-year terms.
27	Sec. 9022.052. ELECTION OF DIRECTORS. On the uniform

- 1 election date in May of each even-numbered year, the appropriate
- 2 number of directors shall be elected.
- 3 [Sections 9022.053-9022.100 reserved for expansion]
- 4 SUBCHAPTER C. POWERS AND DUTIES
- 5 Sec. 9022.101. WATER CONTROL AND IMPROVEMENT DISTRICT
- 6 POWERS AND DUTIES. The district has the powers and duties provided
- 7 by the general law of this state, including Chapters 49 and 51,
- 8 Water Code, applicable to water control and improvement districts
- 9 created under Section 59, Article XVI, Texas Constitution.
- Sec. 9022.102. ROAD PROJECTS. (a) To the extent authorized
- 11 by Section 52, Article III, Texas Constitution, the district may
- 12 construct, acquire, improve, maintain, or operate macadamized,
- 13 graveled, or paved roads or turnpikes, or improvements in aid of
- 14 those roads or turnpikes, inside the district.
- (b) A road project must meet all applicable construction
- 16 standards, zoning and subdivision requirements, and regulatory
- 17 ordinances of the municipality in whose corporate limits or
- 18 extraterritorial jurisdiction the district is located. If the
- 19 district is located outside the extraterritorial jurisdiction of a
- 20 municipality, a road project must meet all applicable construction
- 21 standards, zoning and subdivision requirements, and regulatory
- ordinances of the county in which the district is located.
- 23 (c) The district may not undertake a road project unless
- 24 each municipality in whose corporate limits or extraterritorial
- 25 jurisdiction the district is located consents by ordinance or
- 26 resolution.
- Sec. 9022.103. DIVISION OF DISTRICT. (a) The district may

1	divide into two new districts only if the district:
2	(1) has no outstanding bonded debt; and
3	(2) is not imposing ad valorem taxes.
4	(b) The division procedure is prescribed by Sections 53.030
5	through 53.041, Water Code. Sections 51.748 through 51.753, Water
6	Code, do not apply to the district.
7	(c) Any new district created by the division of the district
8	has all the powers and duties of the district.
9	(d) Any new district created by the division of the district
10	may not, at the time the new district is created, contain any land
11	outside the area described by Section 2 of the Act creating this
12	chapter.
13	Sec. 9022.104. DISSOLUTION OF DISTRICT. (a)
14	Notwithstanding Section 43.0751, Local Government Code, or any
15	other general law, before December 31, 2017, the district may not be
16	dissolved unless the dissolution is approved by:
17	(1) the board; and
18	(2) the governing body of each municipality in whose
19	corporate limits or extraterritorial jurisdiction the district is
20	<pre>located.</pre>
21	(b) This section expires December 31, 2017.
