- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 534.001, Health and Safety Code, is 6 amended by adding Subsection (d-1) to read as follows:
- (d-1) The community center's plan for mental health or 7 mental retardation services may include, as the local agency or 8 9 local agencies consider appropriate, mental health services, mental retardation services, substance abuse services, and any 10 other associated services that may be offered as part of a statewide 11 12 or regional service proposal. Services included in the center's plan under this subsection are not subject to Section 533.035(g) or 13 other privatization requirements. 14
- SECTION 2. Subchapter A, Chapter 534, Health and Safety
 Code, is amended by adding Section 534.0012 to read as follows:
- Sec. 534.0012. SERVICES OUTSIDE OF REGION. (a) A community

 center may provide services outside of the boundaries of the local

 agency or agencies participating in the community center's

 operation if the center submits to the department a request to

 modify the center's plan under Section 534.001(e) to authorize the

 provision of those services and the department approves the

 modification. The request for the modification:
- 24 (1) must include a description of the services to be

- 1 provided outside the center's region;
- 2 (2) may restrict the areas in which the center will
- 3 provide those services; and
- 4 (3) must include evidence that each participating
- 5 local agency has expressly approved the request for the
- 6 modification.
- 7 (b) The department shall approve the request for
- 8 modification of the community center's plan under this section if
- 9 the department determines that the center can appropriately,
- 10 effectively, and efficiently provide those services as provided by
- 11 <u>the modified plan.</u>
- 12 (c) The department may not disapprove of a center's request
- 13 for modification on the sole basis that the modified plan would
- 14 authorize the center to provide services outside of its region.
- 15 SECTION 3. Section 534.002, Health and Safety Code, is
- 16 amended to read as follows:
- 17 Sec. 534.002. BOARD OF TRUSTEES FOR CENTER ESTABLISHED BY
- 18 ONE LOCAL AGENCY. The board of trustees of a community center
- 19 established by one local agency is composed of:
- 20 (1) the members of the local agency's governing body;
- 21 or
- 22 (2) not fewer than five or more than nine qualified
- voters who reside in the region <u>primarily</u> to be served by the center
- and who are appointed by the local agency's governing body.
- 25 SECTION 4. Section 534.003(b), Health and Safety Code, is
- 26 amended to read as follows:
- 27 (b) The governing bodies of the local agencies shall appoint

- 1 the board members either from among the membership of the governing
- 2 bodies or from among the qualified voters who reside in the region
- 3 primarily to be served by the center.
- 4 SECTION 5. This Act takes effect September 1, 2007.
