4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 825.301, Government Code, is amended by

amending Subsections (a) and (b) and adding Subsections (a-1),

(a-2), (a-3), and (b-1) to read as follows:

8 (a) The board of trustees shall invest and reinvest assets

of the retirement system without distinction as to their source in

accordance with Section 67, Article XVI, Texas Constitution. The

board of trustees may invest and reinvest retirement system assets

12 <u>in any investment instrument commonly known as a security,</u>

including those instruments described [For purposes of the

investment authority of the board of trustees under Section 67,

15 Article XVI, Texas Constitution, "securities" means any investment

16 instrument within the meaning of the term as defined] by Section 4,

17 The Securities Act (Article 581-4, Vernon's Texas Civil Statutes),

19 <u>investment is authorized for investment under this section even if</u>

The board 1 2 of trustees may buy and sell: 3 (1) futures contracts; 4 (2) options; 5 (3) options on futures contracts; (4) forward contracts; 6 7 (5) swap contracts, including swap contracts with 8 embedded options; 9 (6) any [Any] instrument or contract intended to manage transaction or currency exchange risk in purchasing, 10 selling, or holding <u>investments; and</u> 11 12 (7) any other instrument commonly used institutional investors to manage institutional investment 13 portfolios [securities is considered to be a security]. 14 15 (a-1) Investment decisions under this section are subject to the standard provided in the Texas Trust Code by Section 16 17 117.004(b), Property Code. (a-2) The board of trustees may delegate investment 18 authority and contract with private professional investment 19 managers for investment and management of assets held in trust by 20 21 the retirement system. In a contract made under this subsection, the board of trustees shall specify any applicable policies, 22 requirements, or restrictions, including criteria for determining 23 24 the quality of investments or the use of standard rating services, that the board of trustees adopts for investments of the system. 25

- 22 "reinvestment," and "restricted securities" have the meanings

- (b) Chapter 551 does not require the board of trustees to
- 25 <u>confer with one or more employees, consultants, or legal counsel of</u>
- 26 the retirement system or with a third party, including
- 27 representatives of an issuer of restricted securities or a private

- 1 investment fund, in an open meeting if the only purpose of the
- 2 conference is to receive information from or question the
- 3 employees, consultants, or legal counsel of the retirement system
- 4 or the third party relating to:
- 5 (1) an investment or a potential investment by the
- 6 board of trustees in a private investment fund; or
- 7 (2) the purchase, holding, or disposal of restricted
- 8 securities or a private investment fund's investment in restricted
- 9 securities if, under Section 552.143, the information discussed
- would be confidential and excepted from the requirements of Section
- 11 552.021 if the information was included in the records of a

- 13 (c) This section applies notwithstanding Section 825.115.
- 14 SECTION 3. This Act takes effect immediately if it receives
- a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2007.
