A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the establishment of a strategy for reducing child
- 3 abuse and neglect and improving child welfare.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. In this Act, "task force" means the task force
- 6 established under this Act to establish a strategy for reducing
- 7 child abuse and neglect and improving child welfare.
- 8 SECTION 2. (a) The task force consists of 15 members
- 9 appointed as follows:
- 10 (1) five members appointed by the governor;
- 11 (2) five members appointed by the lieutenant governor;
- 12 and
- 13 (3) five members appointed by the speaker of the house
- 14 of representatives.
- 15 (b) Members of the task force must be individuals who are
- 16 actively involved in the fields of the prevention of child abuse and
- 17 neglect and child welfare. The appointment of members must reflect
- 18 the geographic diversity of the state.
- 19 (c) A member of the task force may not be appointed to, or be
- 20 an employee of, a state agency.
- 21 (d) A member of the task force is not entitled to
- 22 compensation for service on the task force but is entitled to
- 23 reimbursement for travel expenses as provided by Chapter 660,
- 24 Government Code, and the General Appropriations Act.

- 1 (e) The task force shall elect a presiding officer by a
- 2 majority vote of the membership of the task force.
- 3 (f) The task force shall meet at the call of the presiding
- 4 officer.
- 5 (g) Chapter 2110, Government Code, does not apply to the
- 6 task force.
- 7 SECTION 3. (a) The task force shall establish a strategy for
- 8 reducing child abuse and neglect and for improving child welfare in
- 9 this state. In establishing that strategy, the task force shall:
- 10 (1) gather information concerning child safety, child
- 11 abuse and neglect, and child welfare throughout the state;
- 12 (2) receive reports and testimony from individuals,
- 13 state and local agencies, community-based organizations, and other
- 14 public and private organizations;
- 15 (3) create goals for state policy that would improve
- 16 child safety, prevent child abuse and neglect, and improve child
- 17 welfare; and
- 18 (4) submit a strategic plan to accomplish those goals.
- 19 (b) The strategic plan submitted under Subsection (a) of
- 20 this section may include proposals for specific statutory changes,
- 21 the creation of new programs, and methods to foster cooperation
- among state agencies and between the state and local government.
- 23 SECTION 4. (a) The task force shall consult with employees
- of the Department of Family and Protective Services, the Department
- of State Health Services, and the Texas Department of Criminal
- 26 Justice as necessary to accomplish the task force's
- 27 responsibilities under this Act.

- 1 (b) The task force may cooperate as necessary with any other
- 2 appropriate state agency.
- 3 SECTION 5. (a) The governor, lieutenant governor, and
- 4 speaker of the house of representatives shall appoint the members
- of the task force not later than October 1, 2007.
- 6 (b) Not later than August 1, 2009, the task force shall
- 7 submit the strategic plan required by Section 3 of this Act to the
- 8 governor, lieutenant governor, and speaker of the house of
- 9 representatives.
- 10 (c) The task force is abolished and this Act expires on
- 11 September 1, 2009.
- 12 SECTION 6. This Act takes effect September 1, 2007.
