10	Sec. 61.9831. SCHOLARSHIP PROGRAM; AMOUNT OF SCHOLARSHIP.
11	(a) In accordance with this subchapter and board rules, the board
12	shall establish and administer a program to award scholarships to
13	undergraduate students who:
14	(1) are enrolled in educator preparation programs
15	provided by public or private institutions of higher education in
16	this state; and
17	(2) agree to teach for a specified period in the public
18	schools in this state that are determined by the Texas Education
19	Agency to have shortages of teachers.
20	(b) The amount of a scholarship under this subchapter for an
21	academic year is equal to the lesser of:
22	(1) the total amount of tuition that the public or
23	private institution of higher education in which the scholarship
24	recipient is enrolled charges the recipient for that academic year

1	for semester credit hours for which the recipient may use the
2	scholarship to pay tuition as provided by Subsection (c); or
3	(2) \$5,000.
4	(c) A student may use a scholarship under this subchapter
5	only to pay tuition for a semester credit hour that is required for
6	completion of the educator preparation program in which the student
7	is enrolled.
8	(d) For purposes of this subchapter, not later than April 1
9	of each school year, the Texas Education Agency shall determine
10	which public schools in this state are anticipated to have
11	shortages of teachers during the following school year and shall
12	provide that information to the board and to each educator
13	preparation program in this state accredited by the State Board for
14	Educator Certification.

8	by Section 61.9833.
9	(b) Not more than 4,000 scholarships may be awarded under
10	this subchapter for an academic year.
11	(b-1) This subsection expires September 1, 2011.
12	Notwithstanding Subsection (b), not more than the following number
13	of scholarships may be awarded under this subchapter for the
14	specified academic year:
15	(1) for the 2008-2009 academic year, not more than

6	Sec. 61.9833. AGREEMENT REQUIREMENTS. (a) To qualify for a
7	scholarship under this subchapter, a person must enter into a
8	written agreement with the board as provided by this section. The
9	agreement must:
10	(1) specify the conditions the person must satisfy to
11	receive the scholarship award;
12	(2) require the person to earn a baccalaureate degree
13	through completion of an educator preparation program accredited by
14	the State Board for Educator Certification that is provided by a
15	public or private institution of higher education in this state;
16	(3) require the person to obtain, within the period
17	prescribed by board rule, appropriate certification under
18	Subchapter B, Chapter 21, to teach in a public school in this state;
19	(4) require the person to accept, for the first school
20	year that begins after the date the person obtains the appropriate
21	certification, an offer of full-time employment to teach in a
22	public school in this state selected by the person from among
23	schools anticipated by the Texas Education Agency to have shortages
24	of teachers for that first school year for which the person is
25	accepting employment;
26	(5) require the person to complete eight years of
27	full-time employment teaching as follows:

1	(A) beginning with the school year described by
2	Subdivision (4), four consecutive school years of employment
3	teaching in one or more public schools in this state selected by the
4	person from among schools anticipated by the Texas Education Agency
5	to have shortages of teachers for the person's applicable year of
6	employment by the school; and
7	(B) beginning with the school year immediately
8	following the last of the four consecutive school years described
9	by Paragraph (A), four additional consecutive school years teaching
10	in any public school in this state;
11	(6) provide that any scholarship award the person
12	receives under this subchapter constitutes an interest-free loan
13	until the person:
14	(A) subject to Section 61.9835, satisfies the
15	requirements of Subdivision (5) and any other applicable conditions
16	of the agreement; or
17	(B) is excused from the repayment obligation in
18	accordance with law; and
19	(7) require the person to sign a promissory note
20	acknowledging the conditional nature of the scholarship award
21	received and promising to repay any unforgiven amount of that award

25	(b) For purposes of Subsection (a)(5)(A), if a person is
26	employed as a teacher in a public school anticipated to have a
27	shortage of teachers in the first year of employment, each

subsequent year of continuous employment as a teacher in that 1 2 school is considered to be employment in a school anticipated to have a shortage of teachers in that year, regardless of whether the 3 4 Texas Education Agency anticipated that the school would have a 5 shortage of teachers in that year. 6 (c) The board shall determine the terms of the promissory 7 note required by Subsection (a)(7). To the extent practicable, the terms must be the same as those applicable to state or federally 8 9 guaranteed student loans made at the same time. Sec. 61.9834. EXCEPTIONS 10 ТО TEACHING AND REPAYMENT OBLIGATIONS. (a) A person is not considered to be in violation of 11 12 the teaching obligation in the agreement described by Section 61.9833 during any period in which the person: 13 14 (1) is pursuing a full-time course of study related to 15 the field of teaching offered by a public or private institution of 16 higher education in this state and approved by the State Board for 17 Educator Certification; (2) is serving on active duty as a member of the armed 18 forces of the United States, including as a member of a reserve 19 force or National Guard called to active duty; 20 21 (3) is temporarily totally disabled for a period not to exceed 36 months as established by the affidavit of a qualified 22 23 physician; 24 (4) is unable to secure employment for a period not to 25 exceed 12 months because of care required by a disabled spouse or 26 child; 27 (5) is seeking and unable to find, for a single period

1	not to exceed 12 months, full-time employment teaching in a public
2	school in this state, or if the person is within the period of the
3	agreement described by Section 61.9833(a)(5)(A), full-time
4	employment teaching in a public school in this state anticipated to
5	have a shortage of teachers for the year for which the person is
6	seeking employment; or
7	(6) satisfies the provisions of any other teaching
8	exception adopted by the board.
9	(b) A person is excused from the repayment obligation in a
10	promissory note described by Section 61.9833 if:
11	(1) the person becomes permanently totally disabled as
12	established by the affidavit of a qualified physician; or
13	(2) the board waives repayment in the case of extreme
14	hardship to the person.
15	Sec. 61.9835. FORGIVENESS OF REPAYMENT OBLIGATION. The
16	board shall forgive 25 percent of the total amount required to be
17	repaid according to the promissory note under Section 61.9833 for
18	each complete school year the person teaches in accordance with the
19	agreement under Section 61.9833 after the expiration of the period
20	described by Subsection (a)(5)(A) of that section.
21	Sec. 61.9836. GRANTS, GIFTS, AND DONATIONS. In addition to
22	money appropriated by the legislature, the board may solicit and
23	accept grants, gifts, and donations from any public or private
24	source for the purposes of this subchapter.
25	Sec. 61.9837. RULES. (a) The board shall adopt rules to
26	administer this subchapter, including rules:
27	(1) providing for the manner in which a student may

1	apply for a scholarship; and
2	(2) providing for notification of the scholarship
3	program under this subchapter to students enrolled in educator
4	preparation programs in this state.
5	(b) The board shall distribute to each educator preparation
6	program of a public or private institution of higher education in
7	this state a copy of the rules adopted under this section.
8	SECTION 2. Not later than December 31, 2007, the Texas
9	Higher Education Coordinating Board shall adopt rules for the
10	undergraduate education scholarship program under Subchapter FF,
11	Chapter 61, Education Code, as added by this Act.
12	SECTION 3. This Act takes effect immediately if it receives
13	a vote of two-thirds of all the members elected to each house, as
14	provided by Section 39, Article III, Texas Constitution. If this
15	Act does not receive the vote necessary for immediate effect, this
16	Act takes effect September 1, 2007.
