- 2 relating to the licensing and practice of psychological associates.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 501.002(4), Occupations Code, is amended
- 5 to read as follows:
- 6 (4) "Psychological associate" means a person licensed
- 7 [who holds a license] to engage in the practice of psychology as a
- 8 psychological associate [issued] under Section 501.252 [501.259].
- 9 SECTION 2. The heading to Section 501.252, Occupations
- 10 Code, is amended to read as follows:
- 11 Sec. 501.252. <u>APPLICATION</u> FOR PSYCHOLOGIST <u>OR</u>
- 12 PSYCHOLOGICAL ASSOCIATE LICENSE [APPLICATION].
- SECTION 3. Section 501.252, Occupations Code, is amended by
- 14 adding Subsection (b-1) and amending Subsection (c) to read as
- 15 follows:
- 16 (b-1) A person may not be licensed as a psychological
- 17 associate unless the person:
- 18 <u>(1) is provisionally licensed as a psychological</u>
- 19 associate under this chapter; and
- 20 <u>(2) has had at least three years of supervised</u>
- 21 experience in the field of psychological services, one year of
- 22 which may be as part of the master's program and at least two years
- 23 of which began after the date the person's master's degree was
- conferred by an institution of higher education.

- 1 (c) For purposes of <u>Subsections</u> [<u>Subsection</u>] (b)(2) <u>and</u>
- 2 (b-1)(2), experience is supervised only if the experience is
- 3 supervised by a psychologist in the manner provided by the board's
- 4 supervision guidelines.
- 5 SECTION 4. Section 501.255(a), Occupations Code, is amended
- 6 to read as follows:
- 7 (a) An applicant may take an examination for a provisional
- 8 license if the applicant:
- 9 (1) <u>is applying for a provisional license as a</u>
- 10 psychologist and has received:
- 11 (A) a doctoral degree in psychology from a
- 12 regionally accredited educational institution conferred on or
- 13 after January 1, 1979; or
- 14 (B) a doctoral degree in psychology, or the
- 15 substantial equivalent of a doctoral degree in psychology in both
- subject matter and extent of training, from a regionally accredited
- 17 educational institution conferred before January 1, 1979;
- 18 (2) is applying for a provisional license as a
- 19 psychological associate and has received a master's degree from a
- 20 regionally accredited educational institution with at least 45
- 21 hours of coursework in psychology;
- 22 <u>(3)</u> has attained the age of majority;
- 23 $\underline{(4)}$ [$\overline{(3)}$] has good moral character;
- (5) $\left[\frac{4}{4}\right]$ is physically and mentally competent to
- 25 provide psychological services with reasonable skill and safety, as
- 26 determined by the board;
- (6) $\left[\frac{(5)}{(5)}\right]$ is not afflicted with a mental or physical

- 1 disease or condition that would impair the applicant's competency
- 2 to provide psychological services;
- 3 (7) [(6)] has not been convicted of a crime involving
- 4 moral turpitude or a felony;
- 5 (8) $\left[\frac{(7)}{(7)}\right]$ does not use drugs or alcohol to an extent
- 6 that affects the applicant's professional competency;
- 7 (9) [(8)] has not engaged in fraud or deceit in making
- 8 the application; and
- 9 (10) $\left[\frac{(9)}{}\right]$ except as provided by Section 501.263, has
- 10 not:
- 11 (A) aided or abetted the practice of psychology
- 12 by a person not licensed under this chapter in representing that the
- 13 person is licensed under this chapter;
- 14 (B) represented that the applicant is licensed
- under this chapter to practice psychology when the applicant is not
- 16 licensed; or
- 17 (C) practiced psychology in this state without a
- 18 license under this chapter or without being exempt under this
- 19 chapter.
- SECTION 5. Section 501.259, Occupations Code, is amended to
- 21 read as follows:
- Sec. 501.259. PRACTICE BY [LICENSING OF] PSYCHOLOGICAL
- 23 ASSOCIATE. (a) A psychological associate is not required to be
- 24 supervised by a psychologist [The board shall set standards for the
- 25 issuance of licenses to psychological personnel who hold a master's
- 26 degree from an accredited university or college in a program that is
- 27 primarily psychological in nature].

- 1 (b) The board shall designate a person who holds a
- 2 psychological associate license [authorized by this section] by the
- 3 [a] title [that includes the adjective] "psychological associate."
- 4 [followed by a noun such as "associate," "assistant," "examiner,"
- 5 or "technician."
- 6 SECTION 6. The heading to Section 501.303, Occupations
- 7 Code, is amended to read as follows:
- 8 Sec. 501.303. RENEWAL OF EXPIRED LICENSE [BY OUT-OF-STATE
- 9 PRACTITIONER].
- SECTION 7. Section 501.303, Occupations Code, is amended by
- amending Subsection (b) and adding Subsections (c) and (d) to read
- 12 as follows:
- 13 (b) A [The] person renewing a license under Subsection (a)
- 14 must pay to the board a fee that is equal to the amount of the
- 15 examination fee for the license.
- (c) Except as provided by Subsection (d), the board may
- 17 renew without reexamination an expired psychological associate
- 18 license of a person who:
- 19 (1) was licensed as a psychological associate; and
- 20 (2) is currently licensed in good standing and has
- 21 been practicing for the two years preceding the date the person
- 22 <u>applied for renewal as:</u>
- 23 (A) a licensed specialist in school psychology;
- 24 (B) a licensed marriage and family therapist
- 25 under Chapter 502;
- 26 (C) a licensed professional counselor under
- 27 Chapter 503; or

- 1 (D) a social worker licensed under Chapter 505.
- 2 (d) An applicant for renewal under Subsection (c) who is
- 3 currently licensed as a marriage and family therapist, licensed
- 4 professional counselor, or social worker must pass a jurisprudence
- 5 examination before renewing the person's psychological associate
- 6 license under Subsection (c).
- 7 SECTION 8. Section 32.024, Human Resources Code, is amended
- 8 by adding Subsection (gg) to read as follows:
- 9 <u>(gg)</u> The department shall provide reimbursement under the
- 10 medical assistance program for psychological services provided by a
- 11 psychological associate licensed under Chapter 501, Occupations
- 12 Code.
- SECTION 9. Section 1451.001(18), Insurance Code, is amended
- 14 to read as follows:
- 15 (18) "Psychological associate" means an individual
- 16 licensed as a psychological associate by the Texas State Board of
- 17 Examiners of Psychologists [who practices solely under the
- 18 supervision of a licensed psychologist].
- SECTION 10. Not later than December 1, 2007, the Texas State
- 20 Board of Examiners of Psychologists shall adopt rules necessary to
- 21 implement the changes made by this Act.
- 22 SECTION 11. (a) The Texas State Board of Examiners of
- 23 Psychologists shall issue a psychological associate license to a
- 24 qualified applicant under this section who:
- 25 (1) applies for a license under this section not later
- than September 1, 2008;
- 27 (2) pays the application fee;

- 1 (3) has provided psychological services, as that term
- 2 is defined in Section 501.003, Occupations Code, as an employee of a
- 3 governmental agency or regionally accredited institution of higher
- 4 education during the five years preceding the date the applicant
- 5 files an application for a license under this section;
- 6 (4) has received a graduate degree in psychology from
- 7 a regionally accredited educational institution;
- 8 (5) has passed the examinations required by the Texas
- 9 State Board of Examiners of Psychologists for a psychological
- 10 associate license; and
- 11 (6) meets the requirements in Sections
- 12 501.255(a)(3)-(10), Occupations Code.
- 13 (b) This section expires September 1, 2009.
- 14 SECTION 12. The changes in law made by this Act governing
- 15 the requirements for a psychological associate license under
- 16 Chapter 501, Occupations Code, apply only to an application for a
- 17 license filed on or after the effective date of this Act. An
- 18 application for a license filed before the effective date of this
- 19 Act is governed by the law in effect on the date the application was
- 20 filed, and the former law is continued in effect for that purpose.
- 21 SECTION 13. If before implementing any provision of this
- 22 Act a state agency determines that a waiver or authorization from a
- 23 federal agency is necessary for implementation of that provision,
- 24 the agency affected by the provision shall request the waiver or
- 25 authorization and may delay implementing that provision until the
- 26 waiver or authorization is granted.
- 27 SECTION 14. This Act takes effect September 1, 2007.
