S.B. No. 1600

A BILL TO BE ENTITLED

AN ACT

1
2 relating to the equalization of property wealth in certain school
3 districts.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subchapter A, Chapter 41, Education Code, is
6 amended by adding Section 41.0041 to read as follows:

7 Sec. 41.0041. EFFECT OF ADDITIONAL STATE AID FOR TAX
8 REDUCTION. (a) Notwithstanding any other provision of this
9 chapter, if a school district's wealth per student exceeds the
10 equalized wealth level for the first time in the 2006-2007 or a
11 later school year, the commissioner may consider the district to
12 have reduced its wealth per student to the equalized wealth level
13 for any school year as provided by this section.

14 (b) When the commissioner initially identifies a school
15 district under Section 41.004 as having a wealth per student for a
16 school year that exceeds the equalized wealth level, the
17 commissioner shall estimate:

18 (1) the amount of state revenue to which the district
19 is entitled under Section 42.2516 for that school year; and

20 (2) the cost to the district to purchase attendance
21 credits under Subchapter D in an amount sufficient to reduce the
22 district's wealth per student to the equalized wealth level for
23 that school year.

24 (c) If the commissioner determines that the amount

1 described by Subsection (b)(1) exceeds the amount described by
2 Subsection (b)(2) by more than 10 percent, the commissioner shall
3 notify the district of the commissioner's determination. In lieu of
4 exercising an option described by Section 41.003, the district's
5 board of trustees may authorize the commissioner to withhold from
6 the state revenue to which the district is entitled under Section
7 42.2516 an amount equal to the amount described by Subsection
8 (b)(2).

9 (d) In calculating the amount of state revenue to be
10 withheld from a school district under this section, the
11 commissioner shall calculate the cost for the district to reduce
12 the district's wealth per student to the equalized wealth level
13 using the final attendance and tax rate data for the school year and
14 shall award the district any available credit or discount under
15 Subchapter D as if the district had exercised the option under
16 Section 41.003(3) in a timely manner. If the final amount
17 calculated for the cost for the district to reduce the district's
18 wealth per student to the equalized wealth level for a school year
19 exceeds the amount of state revenue to which the district is
20 entitled under Section 42.2516 for that year:

21 (1) the commissioner shall withhold the entire amount
22 of state revenue to which the district is entitled under Section
23 42.2516 for that year;

24 (2) the commissioner may not withhold any other state
25 aid under this code to which the district is entitled for that year;
26 and

27 (3) the district is not required to take any further

1 action to reduce its wealth per student for that year.

2 (e) An action by the board of trustees of a school district
3 authorizing the commissioner to withhold state revenue from the
4 district under this section is valid without voter authorization.

5 SECTION 2. This Act takes effect immediately if it receives
6 a vote of two-thirds of all the members elected to each house, as
7 provided by Section 39, Article III, Texas Constitution. If this
8 Act does not receive the vote necessary for immediate effect, this
9 Act takes effect September 1, 2007.
