6	Wildlife Code, is amended to read as follows:
7	(a) The department may issue a license, stamp, tag, permit,
8	or another similar item authorized by this code <u>or federal law</u>
9	through the use of automated equipment and a point-of-sale system.
10	SECTION 2. Section 50.001, Parks and Wildlife Code, is
11	amended by adding Subsection (d) to read as follows:
12	(d) Notwithstanding Sections 43.204, 43.405, and 43.805,
13	the commission shall allocate net revenue to individual stamp funds
14	from the sale of stamps that are included in a combination license
15	package according to a methodology the commission establishes. The
16	methodology must incorporate:
17	(1) the proportionate discounted price of each stamp;
18	(2) the estimated utilization of each stamp; or
19	(3) a combination of the methods described by
20	Subdivisions (1) and (2).
21	SECTION 3. Subsection (c), Section 77.120, Parks and
22	Wildlife Code, is amended to read as follows:
23	(c) In addition to fee increases the department is
24	authorized to make under this code, the department shall increase

by 15 percent, but not by an amount that exceeds \$25, the fee for the 1 2 following licenses and shall deposit the amount of the increase to the credit of the shrimp license buyback account: 3 4 (1) a bait-shrimp dealer's license issued under 5 Section 77.043; 6 (2) a wholesale fish dealer's license issued under 7 Section 47.009; (3) a wholesale truck dealer's fish license issued 8 9 under Section 47.010; (4) a retail fish dealer's license issued under 10 Section 47.011; 11 (5) a retail dealer's truck license issued under 12 Section 47.013; 13 14 (6) [a shrimp house operator license issued under 15 Section 77.042; 16 [(7)] a commercial bait-shrimp boat license issued 17 under Section 77.033; 18 (7) [(8)] a commercial bay shrimp boat license issued under Section 77.031; and 19 (8) [(9)] a commercial gulf shrimp boat license issued 20 21 under Section 77.035[; and 22 [(10) an individual bait-shrimp trawl license issued under Section 77.048]. 23 24 SECTION 4. This Act takes effect September 1, 2007.
