PHYSICAL EXAMINATION REQUIRED PARTICIPATION IN EXTRACURRICULAR ATHLETIC ACTIVITY. (a) In this 1-16 section: "Advanced practice nurse" means a registered nurse (1)1-17 approved by the Board of Nurse Examiners to practice as an advanced practice nurse as provided by Section 301.152, Occupations Code.

(2) "Physician" means a physician licensed under 1-18 1-19 1-20 Title 3, Occupations Code. 1-21 Subtitle B, (3) "Physician assistant" 1-22 means a person who licensed under Chapter 204, Occupations Code.

(b) A student may not participate in an extracurricular athletic activity, including an athletic practice, scrimmage, 1-23 1-24 1-25 game, or match, sponsored or sanctioned by the University 1-26 1-27 Interscholastic League unless the student has submitted to the school district the student attends a completed form indicating that the student has received a physical examination conducted by a 1-28 1-29 1-30 physician, physician assistant, or advanced practice nurse. (c) The University Interscholastic League shall adopt rules to administer this section.

SECTION 2. This Act applies beginning with the 2007-2008

school year.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2007.
