- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 382.0205, Health and Safety Code, is 7 amended to read as follows:
- 8 Sec. 382.0205. SPECIAL PROBLEMS RELATED TO AIR CONTAMINANT
- 9 EMISSIONS. Consistent with applicable federal law, the commission
- 10 by rule may control air contaminants as necessary to protect
- 11 against adverse effects related to:
- 12 (1) acid deposition;
- 13 (2) stratospheric changes, including depletion of
- 14 ozone; [and]

- 15 (3) climatic changes, including global warming; and
- 16 (4) air pollution.
- SECTION 2. Subchapter B, Chapter 382, Health and Safety
- Code, is amended by adding Sections 382.0206 and 382.0207 to read as
- 19 follows:
- Sec. 382.0206. AIR POLLUTANT WATCH LIST. (a) The
- 21 commission shall establish and maintain an air pollutant watch
- 22 list. The air pollutant watch list must identify:
- 23 (1) each air contaminant that the commission
- 24 determines, on the basis of federal or state ambient air quality

- 1 standards or effects screening levels for the contaminant, should
- 2 be included on the air pollutant watch list; and
- 3 (2) each geographic area of the state for which
- 4 ambient air quality monitoring data indicates that the individual
- or cumulative emissions of one or more air contaminants identified
- 6 by the commission under Subdivision (1) may cause short-term or
- 7 <u>long-term adverse human health effects or odors in that area.</u>
- 8 (b) The commission shall publish notice of and allow public
- 9 <u>comment on:</u>
- 10 (1) an addition of an air contaminant to or removal of
- 11 an air contaminant from the air pollutant watch list; or
- 12 (2) an addition of an area to or removal of an area
- 13 from the air pollutant watch list.
- 14 (c) Each year, the commission shall hold a public meeting in
- 15 <u>each area listed on the air pollutant watch list to provide</u>
- 16 <u>residents of the area with information regarding:</u>
- 17 (1) the reasons for the area's inclusion on the air
- 18 pollutant watch list; and
- 19 (2) commission actions to reduce the emissions of air
- 20 contaminants contributing to the area's inclusion on the air
- 21 pollutant watch list.
- 22 (d) Not later than December 1 of each year, the commission
- 23 shall prepare an electronic report regarding the air pollutant
- 24 watch list and provide the report to the governor, the lieutenant
- 25 governor, and the speaker of the house of representatives. The
- 26 report must include:
- 27 (1) the a<u>reas and air contaminants currently listed on</u>

- 1 the air pollutant watch list;
- 2 (2) the areas and air contaminants added to or removed
- 3 from the air pollutant watch list during the preceding fiscal year;
- 4 (3) the actions taken by the commission during the
- 5 preceding fiscal year to reduce the ambient air concentration
- 6 levels of air contaminants included on the air pollutant watch
- 7 list; and
- 8 <u>(4) any additional monitoring that is needed in a</u>
- 9 particular area of the state to determine whether the area should be
- 10 <u>included on the air pollutant watch list.</u>
- 11 (e) The air pollutant watch list and the addition of or
- 12 removal of a pollutant or area to or from the list are not matters
- 13 <u>subject to the procedural requirements of Subchapter B, Chapter</u>
- 14 2001, Government Code.
- 15 Sec. 382.0207. PUBLICATION OF AMBIENT AIR QUALITY STANDARDS
- ON INTERNET WEBSITE. The commission shall promptly publish on its
- 17 Internet website any ambient air quality data collected by the
- 18 commission from mobile or stationary ambient air quality monitors.
- 19 SECTION 3. Not later than December 1, 2008, the Texas
- 20 Commission on Environmental Quality shall prepare and provide to
- 21 the governor, the lieutenant governor, and the speaker of the house
- 22 of representatives the initial report required under Section
- 382.0206(d), Health and Safety Code, as added by this Act.
- SECTION 4. This Act takes effect September 1, 2007.
