18	creation of the district is not confirmed at a confirmation and
19	initial directors' election held before September 1, 2009:
20	(1) the district is dissolved on September 1, 2009,
21	except that the district shall:
22	(A) pay any debts incurred;
23	(B) transfer to Kaufman County any assets of the
24	district that remain after the payment of debts; and

1	(C) maintain the organization of the district
2	until all debts are paid and remaining assets are transferred; and
3	(2) this chapter expires September 1, 2012.
4	Sec. 7213.004. APPLICABILITY OF OTHER SPECIAL UTILITY
5	DISTRICT LAW. Except as otherwise provided by this chapter,
6	Chapters 49 and 65, Water Code, apply to the district.
7	Sec. 7213.005. INITIAL DISTRICT TERRITORY. (a) The
8	district is initially composed of the territory described by
9	Section 2 of the Act creating this chapter.
10	(b) The boundaries and field notes contained in Section 2 of
11	the Act creating this chapter form a closure. A mistake made in the
12	field notes or in copying the field notes in the legislative process
13	does not affect:
14	(1) the organization, existence, or validity of the
15	<u>district;</u>
16	(2) the right of the district to issue any type of
17	bond, including a refunding bond, for a purpose for which the
18	district is created or to pay the principal of and interest on a
19	bond; or
20	(3) the legality or operation of the district or the
21	board of directors of the district.

20	Sec. 7213.022. CONFIRMATION AND INITIAL DIRECTORS'
21	ELECTION. (a) The temporary directors shall hold an election to
22	confirm the creation of the district and to elect seven initial
23	directors in accordance with Chapters 49 and 65, Water Code, on or
24	before September 1, 2009.
25	(b) The temporary board of directors shall determine the
26	method for determining the initial term of each person on the
27	initial board of directors. The terms must be clearly stated on the

1	ballot for the confirmation and directors' election.
2	(c) Section 41.001(a), Election Code, does not apply to a
3	confirmation election held as provided by this section.
4	(d) Initial directors serve until the first regularly
5	scheduled election of directors under Subchapter C, Chapter 65,
6	Water Code.
7	Sec. 7213.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If
8	the district's creation is confirmed under Section 7213.022, the
9	Gastonia-Scurry Water Supply Corporation shall transfer the
10	assets, debts, and contractual rights and obligations of the
11	corporation to the district.
12	(b) Not later than the 30th day after the date of the
13	transfer under Subsection (a), the board of directors of the
14	Gastonia-Scurry Water Supply Corporation shall commence
15	dissolution proceedings of the corporation.
16	(c) On dissolution of the Gastonia-Scurry Water Supply
17	Corporation, Certificate of Convenience and Necessity No. 10837 is
18	considered to be held by the district.
19	(d) The board of directors of the Gastonia-Scurry Water
20	Supply Corporation shall notify the Texas Commission on
21	Environmental Quality of the dissolution of the corporation and of
22	the transfer of Certificate of Convenience and Necessity No. 10837
23	to the district.
24	(e) On receipt of notice under Subsection (d), the Texas
25	Commission on Environmental Quality shall note in its records that
26	Certificate of Convenience and Necessity No. 10837 is held by the
27	district and shall reissue the certificate in the name of the

1	district without further application, notice, or hearing. A person
2	does not have a right to protest or request an administrative review
3	of the transfer prescribed by this section.
4	Sec. 7213.024. EXPIRATION OF SUBCHAPTER. This subchapter
5	expires September 1, 2012.

8	Sec. 7213.051. DIRECTORS. The district is governed by a
9	board of not fewer than 5 and not more than 11 directors.

12	Sec. 7213.101. GENERAL POWERS. Except as otherwise
13	provided by this chapter, the district has all of the rights,

15	law of this state, including Chapters 49 and 65, Water Code,
16	applicable to special utility districts created under Section 59,
17	Article XVI, Texas Constitution.
18	Sec. 7213.102. WATER SERVICE IMPACT FEE. (a) The district
19	may charge a water service impact fee that is not greater than the
20	equity buy-in fee charged by the Gastonia-Scurry Water Supply
21	Corporation on December 31, 2006, under that corporation's tariff.
22	(b) Chapter 395, Local Government Code, does not apply to
23	the initial water service impact fee set under this section.
24	(c) The district may increase the water service impact fee
25	only as provided by Chapter 395, Local Government Code, or as
26	approved by the Texas Commission on Environmental Quality.

- 26 SECTION 3. (a) The legal notice of the intention to 27 introduce this Act, setting forth the general substance of this

Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.

6 (b) The governor has submitted the notice and Act to the
7 Texas Commission on Environmental Quality.

8 (c) The Texas Commission on Environmental Quality has filed 9 its recommendations relating to this Act with the governor, 10 lieutenant governor, and speaker of the house of representatives 11 within the required time.

12 (d) The general law relating to consent by political 13 subdivisions to the creation of a conservation and reclamation 14 district and the inclusion of land in the district has been complied 15 with. All requirements of the constitution and laws of this state 16 and the rules and procedures of the legislature with respect to the 17 notice, introduction, and passage of this Act are fulfilled and 18 accomplished.

19 SECTION 4. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2007.
