S.B. No. 1954

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Waller County Municipal Utility District No. 2; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8236 to read as follows:

CHAPTER 8236. WALLER COUNTY MUNICIPAL UTILITY DISTRICT NO. 2

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8236.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "Director" means a board member.

(3) "District" means the Waller County Municipal Utility District No. 2.

Sec. 8236.002. NATURE OF DISTRICT. (a) The district is a municipal utility district created under and essential to accomplish the purposes of Section 59, Article XVI, Texas Constitution.

(b) The district, to the extent authorized by Section 8236.103 and Section 52, Article III, Texas Constitution, has road powers.

Sec. 8236.003. CONFIRMATION ELECTION REQUIRED. The board shall hold an election to confirm the creation of the district as provided by Section 49.102, Water Code.

1 Sec. 8236.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. All
2 land and other property in the district will benefit from the
3 improvements and services to be provided by the district.

4 Sec. 8236.005. INITIAL DISTRICT TERRITORY. (a) The
5 district is initially composed of the territory described by
6 Section 2 of the Act creating this chapter.

7 (b) The boundaries and field notes contained in Section 2 of
8 the Act creating this chapter form a closure. A mistake in the
9 field notes or in copying the field notes in the legislative process
10 does not affect the district's:

- 11 (1) organization, existence, or validity;
- 12 (2) right to issue any type of bond for a purpose for
13 which the district is created or to pay the principal of and
14 interest on the bond;
- 15 (3) right to impose an assessment or tax; or
- 16 (4) legality or operation.

18 SUBCHAPTER B. BOARD OF DIRECTORS

19 Sec. 8236.051. GOVERNING BODY; TERMS. (a) The district is
20 governed by a board of five elected directors.

21 (b) Directors serve staggered four-year terms.

22 Sec. 8236.052. INITIAL DIRECTORS. (a) The initial board
23 consists of:

2 (b) Unless the initial board agrees otherwise, the initial
3 directors shall draw lots to determine which two shall serve until
4 the first regularly scheduled election of directors and which three
5 shall serve until the second regularly scheduled election of
6 directors.

7 (c) This section expires September 1, 2014.

9 SUBCHAPTER C. POWERS AND DUTIES

10 Sec. 8236.101. GENERAL POWERS AND DUTIES. The district has
11 the powers and duties necessary to accomplish the purposes for
12 which the district is created.

13 Sec. 8236.102. MUNICIPAL UTILITY DISTRICT POWERS AND
14 DUTIES. The district has the powers and duties provided by the
15 general law of this state, including Chapters 49 and 54, Water Code,
16 applicable to municipal utility districts created under Section 59,
17 Article XVI, Texas Constitution.

18 Sec. 8236.103. ROAD PROJECTS. (a) Under Section 52,
19 Article III, Texas Constitution, the district may finance,
20 construct, or acquire a road project as provided by this section.

21 (b) The district shall employ or contract with a licensed
22 engineer to certify whether a proposed road project meets the
23 criteria for a thoroughfare, arterial, or collector road of:

24 (1) a county in whose jurisdiction the proposed road
25 project is located; or

26 (2) a municipality in whose corporate limits or
27 extraterritorial jurisdiction the proposed road project is

1 located.

2 (c) The district may finance, construct, or acquire a road
3 that has been certified by the licensed engineer as a thoroughfare,
4 arterial, or collector road, or any improvements in aid of the
5 certified road.

6 (d) A road project must meet all applicable standards,
7 regulations, ordinances, or orders of:

8 (1) each municipality in whose corporate limits or
9 extraterritorial jurisdiction the road project is located; and

10 (2) if the road project is not located in the corporate
11 limits of a municipality, each county in which the road project is
12 located.

13 (e) The district may, with the consent of the municipality
14 or county, convey a completed road project to:

15 (1) a municipality in whose corporate limits or
16 extraterritorial jurisdiction the road project is located; or

17 (2) a county in which the road project is located.

18 Sec. 8236.104. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
19 OR RESOLUTION. The district shall comply with all applicable
20 requirements of any ordinance or resolution, adopted by the
21 governing body of a municipality under Section 54.016, Water Code,
22 that consents to the creation of the district or to the inclusion of
23 land in the district.

25 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

26 Sec. 8236.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
27 district may issue, without an election, bonds and other

1 obligations secured by revenue or contract payments from a source
2 other than ad valorem taxation.

3 (b) The district must hold an election in the manner
4 provided by Chapters 49 and 54, Water Code, to obtain voter approval
5 before the district may impose an ad valorem tax or issue bonds
6 payable from ad valorem taxes.

7 (c) The district may not issue bonds payable from ad valorem
8 taxes to finance a road project unless the issuance is approved by a
9 vote of a two-thirds majority of district voters voting at an
10 election held for that purpose.

11 Sec. 8236.152. OPERATION AND MAINTENANCE TAX. (a) If
12 authorized at an election held under Section 8236.151, the district
13 may impose an operation and maintenance tax on taxable property in
14 the district as provided by Section 49.107, Water Code.

15 (b) The board shall determine the tax rate. The rate may not
16 exceed the rate approved at the election.

18 SUBCHAPTER E. BONDS

19 Sec. 8236.201. AUTHORITY TO ISSUE BONDS AND OTHER
20 OBLIGATIONS. The district may issue bonds or other obligations
21 payable wholly or partly from ad valorem taxes, impact fees,
22 revenue, grants, or other district money, or any combination of
23 those sources, to pay for any authorized district purpose.

24 Sec. 8236.202. BONDS FOR ROAD PROJECTS. At the time of
25 issuance, the total principal amount of a bond, note, or other
26 obligation issued or incurred to finance a road project may not
27 exceed one-fourth of the assessed value of real property in the

1 district according to the most recent certified tax appraisal roll
2 for Waller County.

3 Sec. 8236.203. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
4 the time bonds or other obligations payable wholly or partly from ad
5 valorem taxes are issued:

6 (1) the board shall impose a continuing direct annual
7 ad valorem tax, without limit as to rate or amount, for each year
8 that all or part of the bonds are outstanding; and

9 (2) the district annually shall impose an ad valorem
10 tax on all taxable property in the district in an amount sufficient
11 to:

12 (A) pay the interest on the bonds or other
13 obligations as the interest becomes due;

14 (B) create a sinking fund for the payment of the
15 principal of the bonds or other obligations when due or the
16 redemption price at any earlier required redemption date; and

17 (C) pay the expenses of imposing the taxes.

18 SECTION 2. The Waller County Municipal Utility District No.
19 2 initially includes all the territory contained in the following
20 area:

21 Being a 419.987-acre (18,294,644 square foot) tract of land
22 situated in the H. &T.C.R.R. Survey, Section 73, A-154, the T.S.
23 Reese Survey, A-330 and the Nathan Brookshire Survey, A-16, Waller
24 County, Texas, being out of a 150.62-acre tract of land recorded in
25 Volume 262, Page 403 of the Waller County Deed Records, being out of
26 a 93.675-acre tract of land recorded in Volume 240, Page 93 of the
27 Waller County Deed Records, being out of a 24.1408-acre tract of

1 land recorded in Volume 250, Page 9 of the Waller County Deed
2 Records, being out of a 302.299-acre tract of land recorded in
3 Volume 233, Page 774 of the Waller County Deed Records, being out of
4 a 191.19-acre tract of land recorded in Volume 237, Page 329 of the
5 Waller County Deed Records and being more particularly described by
6 metes and bounds as follows:

7 BEGINNING at a 4-inch x 4-inch concrete monument found for the
8 point-of-intersection of the westerly right-of-way line of Woods
9 Road (80 feet wide) with the southerly right-of-way line of
10 Interstate Highway No. 10 (width varies) for the northeasterly
11 corner of said 191.19-acre tract and for the northeasterly corner
12 of this tract;

13 THENCE South $02^{\circ} 06' 49''$ East, a distance of 1,690.14 feet with the
14 westerly right-of-way line of said Woods Road to a 5/8-inch iron rod
15 with cap stamped "Weisser Eng. Houston, Tx." set for a
16 point-of-curvature;

17 THENCE In a southerly direction with the westerly right-of-way line
18 of said Woods Road and with a tangent curve to the right having a
19 radius of 1,105.92 feet, a central angle of $17^{\circ} 00' 00''$, a length of
20 328.13 feet and a chord bearing South $06^{\circ} 23' 11''$ West, a distance of
21 326.93 feet to a 1/2-inch iron pipe found for a point-of-tangency;

22 THENCE South $14^{\circ} 53' 11''$ West, a distance of 249.26 feet with the
23 westerly right-of-way line of said Woods Road to a 1/2-inch iron
24 pipe found for a point-of-curvature;

25 THENCE In a southerly direction with the westerly right-of-way line
26 of said Woods Road and with a tangent curve to the left having a
27 radius of 1,185.92 feet, a central angle of $17^{\circ} 30' 00''$, a length of

1 362.22 feet and a chord bearing South 06° 08' 11" West, a distance of
2 360.81 feet to a 1/2-inch iron pipe found for a point-of-tangency;
3 THENCE South 02° 36' 49" East, a distance of 2,007.29 feet with the
4 westerly right-of-way line of said Woods Road to a 5/8-inch iron rod
5 with cap stamped "Weisser Eng. Houston, Tx." set for the
6 southeasterly corner of said 150.62-acre tract and for the
7 southeasterly corner of this tract, from which a 1-1/2-inch iron
8 pipe found bears South 87° 46' 29" West, a distance of 0.69 feet;
9 THENCE South 87° 46' 29" West, a distance of 3,184.82 feet with the
10 northerly line of a 150.0909-acre tract of land described as "First
11 Tract" as recorded in Volume 152, Page 268 of the Waller County Deed
12 Records to a 1-1/2-inch iron pipe found for the most southerly
13 southwesterly corner of this tract;
14 THENCE North 02° 33' 17" West, a distance of 1,996.16 feet with the
15 easterly line of the Archie K. Brookshire 30-acre tract of land as
16 recorded in Volume 60, Page 580 of the Waller County Deed Records to
17 a 1-1/2-inch iron pipe found for an interior corner of this tract;
18 THENCE South 86° 30' 38" West, a distance of 1,396.67 feet with the
19 northerly line of said 30-acre tract and with the northerly line of
20 the Howard L. Brookshire 30-acre tract of land as recorded in Volume
21 147, Page 248 of the Waller County Deed Records to a 1-1/2-inch iron
22 pipe found for an interior corner of this tract;
23 THENCE South 03° 34' 47" East, a distance of 703.09 feet with the
24 westerly line of said Howard L. Brookshire 30-acre tract to a
25 1-1/2-inch iron pipe found for an angle point of this tract;
26 THENCE South 02° 27' 11" East, a distance of 364.21 feet with the
27 westerly line of said Howard L. Brookshire 30-acre tract to a

1 5/8-inch iron rod with cap stamped "Weisser Eng. Houston, Tx." set
2 for a southeasterly corner of this tract;
3 THENCE South 87° 24' 31" West, a distance of 1,319.86 feet with the
4 northerly line of a 51.4349-acre tract of land conveyed to Ferrin B.
5 Moreland, et ux, as recorded in Volume 425, Page 448 of the Waller
6 County Deed Records to a point in the centerline of Brookshire Creek
7 for the southwesterly corner of this tract;
8 THENCE North 09° 09' 28" East, a distance of 205.56 feet with the
9 centerline of said Brookshire Creek to an angle point of this tract;
10 THENCE North 86° 15' 35" East, a distance of 824.76 feet with a
11 southerly line of the City of Brookshire Extra Territorial
12 Jurisdiction (ETJ) to an angle point of this tract;
13 THENCE North 03° 14' 31" West, a distance of 963.99 feet with an
14 easterly line of said ETJ to an angle point of this tract;
15 THENCE North 86° 33' 18" East, a distance of 1,511.04 feet with a
16 southerly line of said ETJ to an angle point of this tract;
17 THENCE North 03° 23' 50" West, a distance of 2,146.58 feet with an
18 easterly line of said ETJ to an angle point of this tract;
19 THENCE North 86° 59' 22" East, a distance of 691.51 feet with a
20 southerly line of said ETJ to an angle point of this tract;
21 THENCE North 02° 19' 12" West, a distance of 1,237.10 feet with an
22 easterly line of said ETJ to an angle point of this tract;
23 THENCE South 82° 59' 18" East, a distance of 1,969.10 feet with the
24 southerly right-of-way line of said Interstate Highway No. 10 (320
25 feet wide) to a 5/8-inch iron rod with cap stamped "Weisser Eng.
26 Houston, Tx." set for a point-of-curvature, from which a 4-inch
27 concrete monument found bears South 83° 31' 43" East, a distance of

1 0.85 feet;

2 THENCE In an easterly direction with the southerly right-of-way
3 line of said Interstate Highway No. 10 and with a tangent curve to
4 the right having a radius of 532.96 feet, central angle of 31° 16'
5 33", a length of 290.92 feet and a chord bearing South 67° 21' 02"
6 East, a distance of 287.33 feet to a 5/8-inch iron rod with cap
7 stamped "Weisser Eng. Houston, Tx." set for a point-of-tangency,
8 from which a 4-inch concrete monument found bears South 79° 35' 01"
9 East, a distance of 0.73 feet;

10 THENCE South 51° 42' 45" East, a distance of 463.64 feet with the
11 southerly right-of-way line of said Interstate Highway No. 10 to a
12 5/8-inch iron rod with cap stamped "Weisser Eng. Houston, Tx." set
13 for a point-of-curvature, from which a 4-inch concrete monument
14 found bears South 77° 49' 56" East, a distance of 1.16 feet;

15 THENCE In an easterly direction with the southerly right-of-way
16 line of said Interstate Highway No. 10 and with a tangent curve to
17 the left having a radius of 612.96 feet, central angle of 40° 00'
18 00", a length of 427.93 feet and a chord bearing South 71° 42' 45"
19 East, a distance of 419.29 feet to a 5/8-inch iron rod with cap
20 stamped "Weisser Eng. Houston, Tx." set for a point-of-tangency,
21 from which a 4-inch concrete monument found bears South 66° 01' 45"
22 East, a distance of 0.52 feet;

23 THENCE North 88° 17' 15" East, a distance of 105.30 feet with the
24 southerly right-of-way line of said Interstate Highway No. 10 to
25 the POINT OF BEGINNING and containing 419.987 acres (18,294,644
26 square feet) of land.

27 SECTION 3. (a) The legal notice of the intention to

1 introduce this Act, setting forth the general substance of this
2 Act, has been published as provided by law, and the notice and a
3 copy of this Act have been furnished to all persons, agencies,
4 officials, or entities to which they are required to be furnished
5 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
6 Government Code.

7 (b) The governor, one of the required recipients, has
8 submitted the notice and Act to the Texas Commission on
9 Environmental Quality.

10 (c) The Texas Commission on Environmental Quality has filed
11 its recommendations relating to this Act with the governor, the
12 lieutenant governor, and the speaker of the house of
13 representatives within the required time.

14 (d) All requirements of the constitution and laws of this
15 state and the rules and procedures of the legislature with respect
16 to the notice, introduction, and passage of this Act are fulfilled
17 and accomplished.

18 SECTION 4. This Act takes effect immediately if it receives
19 a vote of two-thirds of all the members elected to each house, as
20 provided by Section 39, Article III, Texas Constitution. If this
21 Act does not receive the vote necessary for immediate effect, this
22 Act takes effect September 1, 2007.
